



- 1. Rocky and Boy "shall be properly licensed and vacinated. The licensing authority shall include the potentially dangerous desigation in the registration records of the dogs.(Food & Agr. Code § 31641)
- 2. Rocky and Boy are to be kept either indoors on Respondent's property or, when outside in a securely fenced yard from which the dogs cannot escape and into which children cannot trespass. (Food & Agr. Code, § 31642).
- 3. Respondent must always maintain Rocky and Boy away from the front yard or any yard adjacent to a street or sidewalk,
- 4. Rocky and Boy may be off Respondent's premises only if they are restrained by a substantial leash, of appropriate length, and if they are under the control of a responsible adult. (Food and Agr. Code § 31642)
- 4. If a move or transfer of ownership of the Dogs occurs, Respondent must notify Petitioner within two working days. (Food & Agr. Code § 31643.

Furthermore, Respondent is ordered to pay Petitioner fees and costs of \$4,938.00, reflecting \$3,160.00 based on 158 days of kenneling Rocky and Boy at a rate of \$10 per day plus other expenses of \$1,778.00, within thirty (30) days of notice of the court's order. The costs associated with kenneling Rocky and Boy, in the amount of \$3,160.00, must be paid before the release of Rocky and Boy into the custody of the owner.
