NATURE OF CASE

This is a recommendation to settle for \$3,000,000,

inclusive of attorneys' fees and costs, a federal civil rights lawsuit filed by Emmet Brock (Plaintiff) after he was arrested and assaulted by a Los Angeles County Sheriff's Department (LASD) Deputy.

Given the risks and uncertainties of litigation, a reasonable settlement at this time will avoid further litigation costs. The full and final settlement of the case in the amount of \$3,000,000 is recommended.
