Los Angeles County Holiday Events at The Music Center: Annual Tree Lighting Ceremony and Annual Holiday Celebration - Parking Waiver

For decades, the County of Los Angeles (County) has hosted the beloved Annual Los Angeles County Tree Lighting Ceremony and the Annual Los Angeles County Holiday Celebration at The Music Center in Downtown Los Angeles each December.

This year's Tree Lighting Ceremony will be held on Monday, December 1, 2025, at 5:00 p.m. on Jerry Moss Plaza at The Music Center and will provide residents from across Los Angeles County with a festive welcome to the holiday season. The ceremony will include live holiday performances by local musicians, a festive marketplace featuring local vendors, and an art activity for all ages facilitated by a local arts organization. The event will be hosted by a newscaster and featured by local media.

The Holiday Celebration will be held on December 24, 2025, at 3:00 p.m. in the Dorothy Chandler Pavilion. The event, in its 66th year, will reach thousands of live audience members and tens of thousands of at-home viewers. The Holiday celebration performers represent vocal arts, music, dance, and puppetry from across the County.

In preparation for the performances, the performers and crew members are required to attend several rehearsals at The Music Center. As in the past, parking waivers are requested for both events, including the mandatory Holiday Celebration rehearsals.

I, THEREFORE, MOVE that the Board of Supervisors:

1. Waive the following parking fees for the dates listed below in Lot 14 (The Music Center Garage), excluding the cost of liability insurance, to accommodate artists, crew and VIPs performing and participating in the Annual Tree Lighting Ceremony on Monday, December 1, 2025, from 12:00 p.m. to 8:00 p.m.:
 - a. Waive the \$10 per vehicle parking fee for 10 vehicles for a total of \$100, on November 30, 2025; and
 - b. Waive the \$20 per vehicle parking fee for 50 vehicles for a total of \$1,000, on December 1, 2025.

2. Waive the following parking fees for the dates listed below in Lot 14 (The Music Center Garage), and Lot 16, if necessary, excluding the cost of liability insurance, for the 66th Annual Los Angeles County Holiday Celebration in the Dorothy Chandler Pavilion:
 - a. Waive the \$10 per vehicle parking fee for up to 300 vehicles for a total of \$3,000, on December 6, 2025;
 - b. Waive the \$10 per vehicle parking fee for up to 250 vehicles per day for a total of \$2,500, on December 7, 2025;
 - c. Waive the \$20 per vehicle parking fee for up to 100 vehicles per day for a total of \$2,000, on December 16-17, 2025;
 - d. Waive the \$20 per vehicle parking fee for up to 140 vehicles per day for a total of \$2,800, on December 19, 2025;
 - e. Waive the \$10 per vehicle parking fee for up to 320 vehicles per day for a total of \$3,200, on December 20-21, 2025;
 - f. Waive the \$20 per vehicle parking fee for up to 600 vehicles per day for a total of \$12,000, on December 22-23, 2025;
 - g. Waive the parking fees, excluding the cost of liability insurance, \$20 per vehicle for the entire Lot 14 (The Music Center Garage) and the entire Lot 16 if necessary, and 30 ADA valet at the main valet (AP14) for all members of the public visiting The Music Center for a total of \$55,000, on December 24, 2025; and
 - h. Waive the \$10 per vehicle parking fee for 50 vehicles per day for a total of \$500, on December 27, 2025.
