### **III. FALSE STATEMENTS & OMISSIONS IN THEIR LETTERS AND REPORTS**

County documents falsely stated:

1. “No concerns reported”

Truth: My daughter was beaten on February 16, 2025. They concealed it for nine months.

2. “Youth is doing well”

Truth: She was placed in a shelter, working two jobs, with no support or voucher.

3. “Jamiesha does not want contact with mother”

Truth: She told me “DCFS got it out for you.”

We reunified without DCFS help.

4. "Department remains committed to family"

Truth: They denied housing, ignored abuse, hid information, and refused services.

5. "Placement concerns resolved"

Truth: Rape, assault, psychiatric holds, and danger were ignored and not reported.

6. "Family does not participate"

Truth: They intentionally withheld information and blocked access to case records.

### **IV. JAMIESHA'S STATEMENTS**

My daughter stated directly that the CSW told her:

> "DCFS got it out for your mom."

This shows retaliation, bias, and personal targeting, not child protection.

### **V. CSW RETALIATION ON A CLOSED REFERRAL**

A DCFS worker showed up at Jayceon's school claiming to investigate a closed referral.

She threatened to obtain a court order, even though the LAPD Rampart COp had already cleared my son.

This is abuse of authority, harassment, and retaliation after my claims were filed.
