Reference: Support for Motion Opposing Proposed Changes to the Public Charge Rule

I am writing on behalf of the **Sunita Jain Anti-Trafficking Initiative (SJI)**, a practitioner-led, survivor-informed, policy-driven think tank housed at Loyola Law School. SJI works to advance anti-trafficking policy, improve systems responses, and prevent exploitation before it occurs.

We strongly support the Board's motion to oppose the federal government's proposed changes to the Public Charge Rule. These changes would create fear and confusion among immigrant families and discourage many from accessing essential services such as health care, housing support, food assistance, and legal assistance.

For immigrant survivors of human trafficking, the risks are even greater. Traffickers often use immigration status and threats of deportation as tools of control. When survivors are afraid to seek public benefits or interact with government agencies, it becomes significantly harder for them to reach safety, report abuse, or begin recovery. Maintaining clear, stable protections around public charge is critical to reducing exploitation and ensuring survivors can access the support they need without fear.

We appreciate the Board's leadership in standing against policies that endanger vulnerable communities. Thank you for your continued commitment to protecting the health, safety, and stability of immigrant residents across Los Angeles County.
