IMPLEMENT THE FISCAL YEAR 2025-2026 SUPPLEMENTAL BUDGET  
AND OTHER CLASSIFICATION/COMPENSATION ACTIONS  
(ALL SUPERVISORIAL DISTRICTS) (3 VOTES)**

**SUBJECT**

This letter and accompanying ordinance will update the departmental staffing provisions related to the approval of the Fiscal Year (FY) 2025-2026 Supplemental Budget, as well as provide technical adjustments and corrections to reflect earlier Board-approved budget and classification actions. In addition, this letter and accompanying ordinance will update the departmental staffing provisions by adding one (1) new employee classification; deleting one (1) represented classification and eight (8) non-represented classifications; and changing the titles of two (2) represented classifications and four (4) non-represented classifications.

**IT IS RECOMMENDED THAT THE BOARD:**

1. Approve the accompanying ordinance amending Title 6 - Salaries, of the County Code to update the departmental staffing provisions to reflect positions allocated, deleted, and transferred in the FY 2025-2026 Supplemental Budget and to implement routine technical adjustments and corrections to reflect earlier Board-approved budget and classification actions;
2. Add one (1) new employee classification;
3. Delete one (1) represented classification and eight (8) non-represented classifications; and
4. Change the titles of two (2) represented classifications and four (4) non-represented classifications.

## **PURPOSE/JUSTIFICATION OF RECOMMENDED ACTION**

The following summarizes the purpose/justification of the recommended actions:

### **FY 2025-2026 Supplemental Budget**

The subject budget phase was approved by the Los Angeles County (County) Board of Supervisors (Board) on September 30, 2025. This letter implements the approved changes to departmental staffing.

The Board's approval of the attached ordinance will fulfill the Charter requirement to provide for the number of County employees. It will also provide the authority for County departments to fill new positions allocated in the FY 2025-2026 Supplemental Budget, delete positions which are obsolete, and make other adjustments as necessary. These recommendations are a routine part of the annual budget process.

### **New Employee Classification**

We are recommending the establishment of the Justice Program Partner (Item No. 3058) (Attachment) entry-level classification within the Justice Program Analyst Series, which was approved by the Board in November 2023 to support a range of analytical, technical, and client-based functions related to justice programs. Positions in this series interact with clients, courts, and other stakeholders to support the planning and coordination of service-based programs. Positions allocable to the Justice Program Partner class are assigned duties and responsibilities that include interviewing clients to build rapport, assessing needs, and accurately responding to service-related inquiries; documenting client interactions through detailed correspondence; advocating on behalf of clients seeking assistance and support; and serving as a liaison with local partners to develop coordinated care plans that ensure seamless communication and service delivery.

### **Deleted Classifications**

In conjunction with our continuing goal of reducing classifications, we are recommending the deletion of one (1) represented classification and eight (8) non-represented classifications from the Classification Plan (Attachment). The positions are vacant, the represented classification has been approved for deletion by Employee Relations Commission (ERCOM) and the affected departments have been informed and concur with this action. This recommendation is consistent with the County's strategy to reduce the number of obsolete classifications.

### **Title Changes**

We are recommending a title change classification of Assistant Chief, Fiscal Division, Public Works (Item No. 1038) to Assistant Chief, Financial Operations, Public Works (Attachment). The new title will more accurately represent the role and responsibilities of this position within the Department of Public Works as it currently has responsibility over the Fiscal and Budget/Fund Management Divisions.

We are recommending title changes to the following four (4) classifications within the Lake Lifeguard group: Senior Lake Lifeguard, Parks & Rec (Item No. 2949) to Lake Lifeguard Specialist; Supervising Lake Lifeguard, Parks & Rec (Item No. 2950) to Captain, Lake Lifeguard Services; Lake Aquatics

Manager (Item No. 2959) to Section Chief, Lake Lifeguard Services; and Chief Lake Lifeguard (Item No. 2960) to Chief, Lake Lifeguard Services (Attachment). The new titles will more accurately reflect the role and level of responsibility with the Department of Parks and Recreation. The title changes have been approved by ERCOM.

We are recommending a title change from Community Services Liaison (Item No. 2706) to Community Services Liaison, Fire (Attachment). This classification is currently allocated exclusively to the Fire Department. The proposed title change will more accurately reflect the specific role and responsibilities associated with the position. Additionally, it will better align the class definition and standards and promote a more unified organizational structure within the department.

### **Implementation of Strategic Plan Goals**

These recommended actions support the County's Strategic Plan North Star 3 – Realize Tomorrow's Government Today, Focus Area Goal B – Diverse and Inclusive Workforce, Strategy 2 – Fairness and Equity.

### **FISCAL IMPACT/FINANCING**

The cost of and financing for the recommended new positions have been included in the FY 2025-2026 Supplemental Budget.

### **FACTS AND PROVISIONS/LEGAL REQUIREMENTS**

Pursuant to Article III, Section 11(3) of the Charter of the County of Los Angeles, the Board of Supervisors is "to provide, by ordinance, for the number of assistants, deputies, clerks, attaches, and other persons employed in the service of the County." The County Charter also authorizes the establishment and maintenance of "a classification plan and the classification of all positions." This responsibility is further delineated in Civil Service Rule 5.

Appropriate notifications have been made to the impacted employee organizations regarding the recommended classification actions. The accompanying ordinance implementing amendments to Title 6 - Salaries, of the County Code has been approved as to form by County Counsel.

### **IMPACT ON CURRENT SERVICES (OR PROJECTS)**

Approval of these recommendations will enable departments to effect personnel actions associated with the FY 2025-2026 Supplemental Budget and other classification actions.
