ORDER

On consideration of appellee's motion for summary affirmance, an amended brief and appendix, and the record on appeal, and the motion of appellee to withdraw his appearance, it is

ORDERED that the motion for summary affirmance is granted. *See v. United States*, 73 A.3d 130, 131 (D.C. 2013). Viewing the evidence in most favorable to the judgment, *Davis v. United States*, 834 A.2d 861, 8 (2003), as we must, we conclude that sufficient evidence exists to sustain all convictions for three counts of willfully violating the no-contact provision protection order (CPO). *See Williams v. United States*, 51 A.3d 1273, 12 (2012) (identifying the elements of criminal contempt for violation of a court order). The CPO ordered appellant not to contact the complainant "in any . . . manner." The government presented (1) evidence that appellant served with the CPO in open court, (2) the complainant's credited testimony as to the contents of emails sent to the complainant, and (4) the attachments to those emails. The trial court could permissibly infer from this evidence that appellant in fact emailed the complainant on May 25, June 3, and July 27, 2023. *See Rivas v. United States*, 783 A.2d 125, 134 (D.C. 2001) (en banc) (noting that the fact that the government failed to prove willfulness because he was not notified of the CPO prohibited him from sending the complainant legal documents is unpersuasive). Even assuming appellant believed he was permitted to send the complainant documents, the trial court correctly found that it was the content of the emails that violated the CPO, regardless of what was attached to them. *Cf. In re Ferrell*, 51 A.3d 1150, 1153 (D.C. 2012) (per curiam) (affirming contempt conviction of defendant's repeated questions about the complainant's whereabouts outside the scope of the CPO exception for communications regarding their child). **ORDER**

On consideration of appellee's motion for summary affirmance, appellee's amended brief and appendix, and the record on appeal, and the motion of cc for appellee to withdraw his appearance, it is

ORDERED that the motion for summary affirmance is granted. See *Williams v. United States*, 73 A.3d 130, 131 (D.C. 2013). Viewing the evidence in the most favorable to the judgment, *Davis v. United States*, 834 A.2d 861, 866 (D.C. 2003), as we must, we conclude that sufficient evidence exists to sustain appellant's convictions for three counts of willfully violating the no-contact provision of a protection order (CPO). See *Williams v. United States*, 51 A.3d 1273, 1278 (D.C. 2012) (identifying the elements of criminal contempt for violation of a court order). The CPO ordered appellant not to contact the complainant "in any . . . manner." The government presented (1) evidence that appellant was served with the CPO in open court, (2) the complainant's credited testimony, (3) the contents of emails sent to the complainant, and (4) the attachments to those emails. The trial court could permissibly infer from this evidence that appellant intentionally emailed the complainant on May 25, June 3, and July 27, 2023. See *Rivas v. United States*, 783 A.2d 125, 134 (D.C. 2001) (en banc) (noting that the fact-finder is entitled to draw reasonable inferences from the evidence). Appellant's argument that the government failed to prove willfulness because he was not notified that the CPO prohibited him from sending the complainant legal documents is unpersuasive. Even assuming appellant believed he was permitted to send the complainant legal documents, the trial court correctly found that it was the content of the emails that violated the CPO, regardless of what was attached to them. Cf. *In re Ferguson*, 60 A.3d 1150, 1153 (D.C. 2012) (per curiam) (affirming contempt conviction of defendant's repeated questions about the complainant's whereabouts exceed the scope of the CPO exception for communications regarding their child). 
