Reward Offer in the Investigation of Murder Victim Marc Sweet

On August 21, 2025, at approximately 8:56 p.m., deputies from the Los Angeles County Sheriff's Department (LASD), Pico Rivera Station, responded to a call for service regarding gunshots at a Shell gas station located at 9411 Washington Boulevard in the city of Pico Rivera. Deputies arrived at the location and found the victim, Marc Sweet, lying on the ground near gas pumps, suffering from gunshot wounds. The Los Angeles County Fire Department responded to the scene and triaged victim Sweet for his injuries. Mr. Sweet was subsequently transported to Saint Francis Medical Center where he was pronounced deceased at 9:35 p.m.

From reviewing surveillance video footage, detectives observed Mr. Sweet driving his vehicle near the intersection of Washington Boulevard and Passons Boulevard when he appeared to have had a verbal altercation with a male pedestrian walking north on Passons Boulevard. The pedestrian, identified as the suspect, walked north on Passons Boulevard and into the parking lot of the Shell gas station. The victim then drove his vehicle into the same parking lot, exited his vehicle, and approached the suspect. As the victim approached the suspect, the suspect brandished a handgun and shot the victim several times. After the shooting, the suspect walked north on Passons Boulevard and out of view of the cameras.

The victim, Marc Sweet, was identified as a resident of Los Angeles County and a youth baseball coach. At the time of his murder, he was involved in what appeared to be a road rage incident with a pedestrian. Several witnesses spoke with detectives and provided their accounts of what was observed.

The suspect has not been identified and LASD Homicide Detectives are seeking assistance to learn his identity and are requesting a \$20,000 reward for information leading to the identification, arrest, and conviction of the suspect. Anyone with information about this crime is urged to contact LASD Homicide Bureau or Crime Stoppers.

I, THEREFORE, MOVE that the Board of Supervisors establish the offer of a reward in the amount of \$20,000 in exchange for information leading to the apprehension and conviction of the person(s) responsible for the heinous murder of Marc Sweet, which occurred on August 21, 2025, at approximately 8:56 p.m. at 9411 Washington Boulevard in the city of Pico Rivera.
