REPORT BACK ON MOTION BY SUPERVISOR HOLLY J. MITCHELL AND SUPERVISOR LINDSEY P. HORVATH SEIZING REVENUE OPPORTUNITIES THROUGH STRATEGIC USE OF COUNTY ASSETS IN ADVANCE OF THE 2028 OLYMPIC AND PARALYMPIC GAMES (ITEM NO. 13, AGENDA OF MARCH 17, 2026)

On March 17, 2026, the Board of Supervisors adopted a motion, Seizing Revenue Opportunities through Strategic Use of County Assets in Advance of the 2028 Olympic and Paralympic Games, which directed the Chief Executive Office (CEO) to provide two separate reports back to your Board, with the first report due within 21 days, containing the following information:

1. A comprehensive inventory and accounting of County-owned assets that could be used and marketed in connection with the 2028 Olympic and Paralympic Games, including, but not limited to:
 - a. Hospitality houses for participating countries;
 - b. Brand activation and sponsorship spaces;
 - c. Potential international broadcast locations; and
 - d. Practice or training facilities for national teams.

Attached is the comprehensive inventory. The County has many facilities that could serve as revenue-generating opportunities during the 2028 Olympic and Paralympic games. However, our facilities vary in size, scale, accessibility, amenities, availability, and applicable restrictions. We continue to refine the attached inventory

to identify a "high priority" subset of County assets that will allow us to target facilities that are the most marketable. We will work with each Board office as our asset inventory becomes more refined.
