**A RESOLUTION OF THE BOARD OF DIRECTORS OF
PALM RANCH IRRIGATION DISTRICT
REQUESTING THE BOARD OF SUPERVISORS OF
THE COUNTY OF LOS ANGELES TO
PERMIT THE REGISTRAR-RECORDER/COUNTY CLERK TO
RENDER ELECTION SERVICES FOR AN ELECTION OF
SAID DIVISIONS 2 AND 4 TO BE HELD ON NOVEMBER 3, 2026**

WHEREAS, the California Elections Code permits special districts electing governing board members to call an election;

WHEREAS, an election in the Palm Ranch Irrigation District is to be held on Tuesday, November 3, 2026, for the purpose of electing two members of the Board of Directors of said Division; and


WHEREAS, the Board of Directors believes that it is desirable that said election be conducted with the General District Elections to be held on the same date and that within said Irrigation District Divisions the precincts, polling places and election officers of the election be the same, and that the Registrar-Recorder/County Clerk of the County of Los Angeles canvass the returns of the election and that said Palm Ranch Irrigation District Director election, be held in all respects as if there were only one election.

NOW, THEREFORE, THE BOARD OF DIRECTORS OF PALM RANCH IRRIGATION DISTRICT HEREBY RESOLVES, DETERMINES, AND ORDERS AS FOLLOWS:

1. That an election is hereby called by the Board of Directors of the Palm Ranch Irrigation District to be held on November 3, 2026, for the purpose of electing two members of the Board of Directors.
2. That pursuant to the requirements of section 10403 of the Elections Code, the Board of Supervisors of the County of Los Angeles is hereby requested to consent and agree to conduct the Palm Ranch Irrigation District election with the Tuesday, November 3, 2026, Consolidated Elections for the purpose of electing members to the Board of Directors of said district.
3. Said Registrar-Recorder/County Clerk is hereby authorized to canvass the returns of the Palm Ranch Irrigation District election.
4. Said Board of Supervisors is hereby requested to issue instructions to the Registrar-Recorder/County Clerk to take any and all steps necessary for the holding of said election.
5. Palm Ranch Irrigation District shall pay in full its pro rata share of the expenses for the conduct of the election.


6. Palm Ranch Irrigation District shall not require each candidate to pay in advance his or her pro rata share of the printing, handling, and mailing costs of his/her candidate statement as a condition to having it included in the voter's sample ballot pamphlet.
7. The word limit for candidate's statements shall be 200 or less words.
8. That the executive Director is hereby directed to file a certified copy of this resolution with the Board of Superiors and the Registrar-Recorder/County Clerk of the County of Los Angeles.
