RESOLUTION ORDERING BOARD OF EDUCATION MEMBER ELECTION

RESOLUTION NO. 23-25/26

RESOLVED that pursuant to Education Code (EC) §§5000-5030, the Los Angeles County Superintendent of Schools (County Superintendent) is hereby ORDERED to call an election for the purpose, and in accordance with the designations contained in the following specifications of the Election Order made under the authority of EC §5302, §5304, and §5322.

SPECIFICATIONS OF THE ELECTION ORDER


The election shall be held on Tuesday, November 3, 2026. The polling hours shall be from 7:00 a.m. to 8:00 p.m. on multiple days at the Voting Centers leading up to Election Day.

The purpose of the election is to submit to the voters of the district the question of whether two members shall be elected to the Board of Education of the East Whittier City School District.


The Los Angeles County Registrar-Recorder/County Clerk (Registrar-Recorder) will perform all the duties incident to the preparation for and holding of the above-mentioned election. The East Whittier City School District will pay the costs of the election. If any agency holds an election on November 3, 2026, the East Whittier City School District shall pay its pro rata share pertaining to the conduct of this election and shall be under the provisions of the appropriate sections of the Education and Election Codes.

IT IS FURTHER ORDERED that the Clerk of the district is hereby directed to furnish two copies of this order to the County Superintendent not less than 130 days prior to the date set for the election.

The foregoing Resolution and Order was adopted and affirmed by the Board of Education of East Whittier City School District of Los Angeles County, being the Board authorized by law to make the designations contained therein, by formal vote as follows:

Candidate's Statement for Board of Education

WHEREAS, pursuant to Education Code (EC) §5000, Biennial Governing Board Member election will be held on November 3, 2026; and

WHEREAS, in accordance with EC §5340, such governing board elections are required to be consolidated; and

WHEREAS, Elections Code Section 13307 permits a local agency to require payment in advance of each candidate's pro rata share of the printing, handling, and mailing costs of their candidate statement as a condition of having it included in the voter's sample ballot; and

WHEREAS, a district has the option of increasing the word limit for these statements from 200 to 400.

NOW, THEREFORE, BE IT RESOLVED, that the East Whittier City School District hereby proclaims that candidates must make payment of the maximum estimated cost at the time of filing; and that 200 words is the maximum any Candidate's Statement may contain.
