13. B. 1. Request Approval of Resolution No. 25-26/44, to Order Biennial Governing Board Elections on November 3, 2026

Rationale

The administration requests approval of Resolution No. 25-26/44, to order Biennial Governing Board election to be held on Tuesday, November 3, 2026, in accordance with Education Code 5340.

Pursuant to Education Code (EC) §5000, elections will be held on November 3, 2026, to elect members to the governing boards in some school and community college districts in Los Angeles County. A blanket "Order of Election" covering all governing board elections held on this date will be issued by the Los Angeles County Office of Education and transmitted to the Los Angeles County Registrar-Recorder/County Clerk (Registrar-Recorder). Governing boards of districts scheduled to hold elections on this date are required to take action to initiate the regular biennial governing board election by adopting the attached resolution. In accordance with EC §5340, such governing board elections are required to be consolidated.

Order of Election for the Lynwood Unified School District of Los Angeles County, California.

RESOLUTION ORDERING GOVERNING BOARD MEMBER ELECTION

RESOLVED that pursuant to Education Code (EC) §§5000-5030, the Los Angeles County Superintendent of Schools (County Superintendent) is hereby ORDERED to call an election for the purpose, and in accordance with the designations contained in the following specifications of the Election Order made under the authority of EC §5302, §5304, and §5322.

SPECIFICATIONS OF THE ELECTION ORDER

The election shall be held on Tuesday, November 3, 2026. The polling hours shall be from 7:00 a.m. to 8:00 p.m. on multiple days at the Voting Centers leading up to Election Day.

The purpose of the election is to submit to the voters of the district the question of whether 2 members shall be elected to the Governing Board of the Lynwood Unified School District.

The Los Angeles County Registrar-Recorder/County Clerk (Registrar-Recorder) will perform all the duties incident to the preparation for and holding of the above-mentioned election. The Lynwood Unified School District will pay the costs of the election. If any agency holds an election on November 3, 2026, the Lynwood Unified School District shall pay its pro rata share pertaining to the conduct of this election and shall be under the provisions of the appropriate sections of the Education and Election Codes.

IT IS FURTHER ORDERED that the Clerk of the district is hereby directed to furnish two copies of this order to the County Superintendent not less than 130 days prior to the date set for the election.

The forgoing Resolution and Order was adopted and affirmed by the Governing Board of the Lynwood Unified School District of Los Angeles County, being the Board authorized by law to make the designations contained therein, by formal vote as follows:
