On Wednesday, June 17, 2026, a fire at a Boyle Heights commercial building located at 1400 S. Los Palos St. broke out at 2:35 PM, now known as the Los Palos Incident. The fire impacted a cold storage facility operated by Lineage Logistics, which involved complex refrigeration systems, rooftop solar panel infrastructure, and other industrial equipment that created a complex and hazardous firefighting operation. Impacts on the refrigeration systems resulted in ammonia being off-gassed, prompting the City of Los Angeles Fire Department to order people nearby to shelter in place for several hours, due to a risk of exposure to hazardous materials. Additionally, smoke advisories were issued for unincorporated East Los Angeles, the City of Commerce, the City of Vernon, the City of Monterey Park, the City of Montebello, and parts of downtown Los Angeles. Subsequently, the South Coast Air Quality Management District (SCAQMD) issued an Air Quality Advisory across all of Los Angeles County.

After initial efforts to quell the fire were unsuccessful, additional action was needed to open pathways to bring in additional State resources and support. On Saturday, June 20, 2026, the Chair of the Board of Supervisors proclaimed a local

emergency for the Los Palos Incident, in alignment with a declaration of a local emergency by the City of Los Angeles. This proclamation would help accelerate the ongoing local response, assist with the rapid procurement of vital supplies, and ensure all available resources would be deployed to protect residents, workers, and first responders. It also enables the utilization of mutual aid, including technical assistance, as well as potentially obtaining reimbursement and assistance from the State and federal government. Pursuant to Government Code section 8630(b) and Los Angeles County Code section 2.68.110, the Proclamation of Local Emergency shall not remain in effect for a period more than seven days unless it has been ratified by the Board of Supervisors (Board). That evening, Governor Gavin Newsom also proclaimed a State of Emergency for Los Angeles County in response to the warehouse fire. These proclamations enable the State to further support local response efforts, protect public health, and coordinate resources.

In addition, the County of Los Angeles also launched a shelter at City Terrace Park in unincorporated East Los Angeles for residents impacted by the fire. This respite shelter provided residents living near the facility with a respite available 24/7 from adverse impacts from the fire. The Department of Health Services and Department of Mental Health deployed teams to address ongoing health concerns, and the Department of Public Social Services offered assistance with safety net programs. The Department of Animal Care and Control additionally provided resources and supports

for pets. The First Supervisorial District also offered food and resources, free transportation to the facility for impacted residents, and air purifiers for residents in the impacted areas. This was in alignment with County Department of Public Health guidance to limit exposure to outdoor air in areas impacted by the smoke, and to utilize air purifiers when available.

Although progress in containing the fire has been made, on Sunday, June 21, 2026, the City of Los Angeles Fire Department estimated that smoke would continue to come from the facility for several more days, though progress in combating the fire has progressed.

This fire is the second associated with this Lineage Logistics facility in Boyle Heights, as this warehouse previously caught fire in August of 2024. In addition, this operator had previously been accused of failing to comply with safety regulations to prevent the accidental release of ammonia, and in 2023, the company paid a fine to the Environmental Protection Agency related to a facility in Iowa. Although oversight of this facility spans State, County, and City jurisdictions, it is imperative that the County work with all impacted agencies to safeguard the health and well-being of impacted residents and businesses and take all necessary actions to hold the responsible parties accountable.

**BASED UPON THE FOREGOING, AND PURSUANT TO GOVERNMENT
CODE SECTION 54954.2(b)(2), WE, THEREFORE, MOVE** that the Board determine

that:

1) There is a need to take immediate action to ratify the Proclamation of Local Emergency and related directives; and

2) That the need to take this action came to the attention of the Board subsequent to the posting of the agenda for today's meeting.

WE, THEREFORE, FURTHER MOVE that the Board of Supervisors:

1. Ratify the Proclamation of Local Emergency for the Los Palos Incident (Boyle Heights Commercial Building Fire) in the County of Los Angeles. The Proclamation of Local Emergency shall remain in effect until its termination is proclaimed by the Board.
2. Forward a copy of the Proclamation of Local Emergency to the Director of California Governor's Office of Emergency Services (Director), and request the Director find it to be acceptable in accordance with State law, make available recovery assistance under the California Disaster Assistance Act, and expedite access to State and federal resources and any other appropriate federal disaster relief programs.
3. Direct County Departments to implement all assessment, assistance and monitoring efforts as applicable.

WE, FURTHER, MOVE that the Board of Supervisors direct County Counsel, the Chief Executive Office – Office of Emergency Management, the Los Angeles County

Fire Department, and the Department of Public Health, to:

1. Partner with the City of Los Angeles, including the Mayor, Council District 14, and the City Attorney, as well as relevant State jurisdictions, to initiate an inspection and investigation of the facility in question, and determine any actions needed against the operator to provide recompense to impacted residents and businesses;
2. Collaborate with City and State partners to ensure all future inspections and certifications of the facility upon rebuild meet needed health and safety codes to prevent such incidents from repeating in the future;
3. Report back in writing in 180 days and every 60 days thereafter on the results of the above actions, until the facility is deemed adequately safe to operate and community needs are addressed.

WE, FURTHER, MOVE that the Board of Supervisors direct the Department of Public Health and the Chief Executive Office – Office of Emergency Management to work with State and federal regulatory entities to monitor air quality and environmental health impacts in surrounding communities and disseminate communications and resources to safeguard residents' health and safety.

WE, FURTHER, MOVE that the Board of Supervisors direct the Department of Economic Opportunity (DEO), in consultation with the Department of Consumer and Business Affairs, and the Office of Immigrant Affairs, to:

1. Identify potentially impacted businesses, and promote and refer to available services and resources, in addition to hosting job fairs for workers impacted by the Los Palos Incident, and
2. Work with County Counsel to establish a claims process for businesses and impacted workers, and
3. Work with the Department of Public Social Services (DPSS) and applicable partners, such as the Red Cross, to explore the establishment of a training option for participants of existing DEO programs, and DPSS participants enrolled in CalFresh, Medi-Cal and CalWorks requiring workfare hours, that would prepare trainees to become disaster service workers, deployable to assist with temporary shelters and resource distribution.
4. Report back on the progress of directives 1 and 2 in writing in 30 days, and report back in writing on directive 3 in 90 days.

WE, FURTHER, MOVE that the Board of Supervisors direct the Chief Executive Office – Office of Emergency Management to collaborate with the Department of Public Health, the Department of Health Services, the Department of Public Works, the Internal Services Department, and all relevant departments to conduct an inventory of available equipment to safeguard residents from public health and environmental health risks, including personal protective equipment, N95 masks, respirators, and air purifiers, and report back to the Board within 30 days with a full inventory of what can be made

available to impacted residents in similar crises.

WE, FURTHER, MOVE that the Board of Supervisors provide the Director of Public Works the delegated authority to adjust disposal facility conditional use permits as-needed to facilitate waste disposal from the warehouse.

PROCLAMATION OF EXISTENCE OF A LOCAL EMERGENCY FOR LOS PALOS INCIDENT (BOYLE HEIGHTS COMMERCIAL BUILDING FIRE) BY THE CHAIR OF THE COUNTY OF LOS ANGELES BOARD OF SUPERVISORS

WHEREAS, Chapter 2.68 of the Los Angeles County Code provides that the Chair of the County of Los Angeles Board of Supervisors (Chair) may proclaim the existence of a local emergency when the Board of Supervisors (Board) is not in session pursuant to Government Code sections 8630 and 8558(c); and

WHEREAS, a "local emergency," is defined in Government Code section 8558(c)(1), in pertinent part, as follows: "[l]ocal emergency' means the duly proclaimed existence of conditions of disaster or of extreme peril to the safety of persons and property within the territorial limits of a county . . . caused by conditions such as air pollution, fire, flood, storm, epidemic, riot, drought, cyberterrorism, sudden and severe energy shortage, deenergization event . . . plant or animal infestation or disease . . . or an earthquake, or other conditions . . . which are or are likely to be beyond the control of the services, personnel, equipment, and facilities of that political subdivision and require the combined forces of other political subdivisions to combat . . ."; and

WHEREAS, on June 17, 2026, the Los Palos Incident, a fire at a Boyle Heights commercial refrigeration building located at 1400 S. Los Palos St. broke out at 2:35 PM impacting a cold storage facility operated by Lineage Logistics. Fire began impacting the facility that involved complex refrigeration systems, rooftop solar panel infrastructure and other industrial equipment that created a complex and hazardous firefighting operation including impacting refrigeration systems that began off-gassing ammonia, and prompted the City of Los Angeles Fire Department to order people nearby to shelter in place for several hours, due to a risk of exposure to hazardous materials. Additionally, smoke advisories have been issued for unincorporated East Los Angeles, the City of Commerce, the City of Vernon, City of Monterey Park, City of Montebello and parts of downtown Los Angeles. Subsequently, a South Coast Air Quality Management District (SCAQMD) Air Quality Advisory was issued across Los Angeles County.

WHEREAS, local agencies have responded to this emergency to mitigate the incident, investigate its causes and assess the damage and ongoing impacts to human health, air quality, water quality, wildlife, business, and transportation; thereby demonstrating the need for combined forces and resources beyond the immediate County; and

WHEREAS, response efforts to the fire and post fire hazards are ongoing and likely to continue for a significant time, the fire continues to generate a substantial smoke plume that covers large areas of Los Angeles County and the incident is impacting public access to businesses, residences, and recreational facilities along the impacted area due to smoke and firefighting and response activities; and

WHEREAS, these conditions require the use of emergency protective measures and warrant and necessitate that the County proclaim the existence of a local emergency.

NOW, THEREFORE, the Chair finds that as a result of the conditions of disaster or of extreme peril to the safety of persons and property exist in the County, within the meaning of Government Code section 8558(c)(1), and such conditions are or will likely be beyond the control of the services, personnel, equipment, and facilities of the County, and require the combined forces of other political subdivisions to combat; and


IT IS HEREBY ORDERED AND PROCLAIMED by the Chair that a local emergency exists for the Los Palos Incident in the County, and the local emergency shall not remain in effect for a period in excess of seven days unless it has been ratified by the Board; and

IT IS FURTHER ORDERED AND PROCLAIMED that, during the existence of said local emergency, the powers, functions, and duties of the emergency organization of the County shall be those prescribed by State law, by ordinances, and resolutions of the County.

IT IS FURTHER ORDERED AND PROCLAIMED that, a copy of the Proclamation of Local Emergency be forwarded to the Director of California Governor's Office of Emergency Services (Director), and request the Director to find it acceptable in accordance with State law, make available recovery assistance under the

California Disaster Assistance Act, and expedite access to State and federal resources and any other appropriate federal disaster relief programs.
