Public Comment		Favor	Colin M campbell	Subject: Infrastructure Modernization: Integrating Fusion and AI for Municipal Resilience Items 6 and general "Honorable LA County Supervisors, I am Colin Campbell, CEO of ADAPPS Inc out of south pasadena, district 5. I am here to request consent for a critical infrastructure upgrade at the 72 E. Glenarm, Pasadena site to build a smarter, safer LA County. Our proposal integrates a fusion reactor to power a dual-purpose strategy: an underground desalination plant for water security and a dam behind JPL at Millard Canyon to protect our county. This hub will host 'Stargate AI,' providing our police, fire, and EMS with advanced, real-time risk assessment and life-saving coordination. There is an incentivization plan for those who join this effort to enhance LA County infrastructure, supporting the union's ongoing negotiations with Pasadena while providing safe, high-tech jobs. I have proposed this to Atladena, Alhambra, Pasadena, South Pasadena, Monterey Park, Altadena and I ask the LA Board of Supervisors if they would be willing to join this initiative. I recommend focusing on reducing our highest tax on fossil fuels by moving to fusion. One gallon of ocean water has the equivalent fuel of 300-600 gallons of gasoline. This move would also rebuild critical infrastructure, ensure clean water supplies, build life support, and provide high-tech local jobs. We have the veteran-led capacity to execute this today. I urge the Council to endorse this project for a more resilient future and join the alpha team led by Susie Wiles, Chief of Staff for the Whitehouse. Thank you for your service."
