

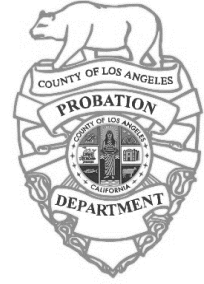

SUBJECT: **ENSURING SAFE LIVING CONDITIONS FOR PREGNANT,
JUSTICE-INVOLVED YOUTH (ITEM 50, BOARD AGENDA OF
NOVEMBER 4, 2025)**

On November 4, 2025, by motion of Supervisor Horvath, the Board of Supervisors (Board) directed the Chief Probation Officer, in collaboration with the Department of Mental Health, and Department of Health Services, to report back in writing at every regular Board meeting, as long as there are pregnant youth in custody, on the specific steps taken to secure alternative housing for pregnant youth in Probation's care, in collaboration with relevant County stakeholders as appropriate, including the Department of Children and Family Services, Public Defender, Alternate Public Defender, and District Attorney.

PREGNANT YOUTH STATUS

As of August 14, 2026, one pregnant youth is currently housed at Campus Vernon Kilpatrick.

Youth was admitted into custody on August 6, 2026, and not released from custody at her initial court hearing, however, she will undergo an expedited screening process for placement pending a suitable placement order. She is scheduled to return to court in the next couple of weeks.

As directed by the Board, whenever there is a pregnant youth within a probation facility, we will provide a weekly status update on efforts to secure their placement to alternative housing.
