Re-establish and Increase the Reward Offer in the Murder of Marvin Randolph

On Saturday, April 5, 2025, at approximately 2:17 p.m., Marvin Randolph was standing outside a residence on the 11000 block of South Manhattan in the unincorporated area of West Athens with several friends who had gathered for a birthday party. A silver four-door Kia Sorento SUV approached and parked in the middle of the street on Lohengrin Street, just west of the residence. Four individuals exited the vehicle armed with various firearms, proceeded toward Mr. Randolph, and fired numerous shots, striking him multiple times. Mr. Randolph was pronounced deceased at the scene.

Four other individuals who were with Mr. Randolph were also struck by gunfire and transported to various hospitals, including Harbor UCLA Medical Center, where they were treated for their injuries. It appeared Mr. Randolph was the intended target of the shooting.

After the shooting, the four suspects ran westbound back to the Kia Sorento and drove from the scene, ultimately abandoning the vehicle on 106th Street and Gramercy Place, several blocks from where the shooting occurred. The suspects then ran eastbound on foot and were captured on closed-circuit television (CCTV) discarding weapons in an abandoned trailer on 106th Street, just east of Manhattan

Place. The suspects were last seen running east on 106th Street towards Western Avenue before leaving the area.

Detectives discovered that the Kia Sorento had been reported stolen the day prior in the same general area as the shooting. CCTV also showed another male retrieving the apparent firearms shortly after the suspects fled the scene. Los Angeles County Sheriff's Department (LASD) Homicide Detectives believe there were four suspects involved in the heinous death of Marvin.

On February 10, 2026, the Los Angeles County Board of Supervisors (Board) established a \$10,000 reward in exchange for information leading to the apprehension and/or conviction of the person(s) responsible. To date, investigators have received no viable clues regarding this tragedy. This reward expired on May 10, 2026, and needs to be re-established by the Board. Any individuals with information about this crime are urged to contact the LASD Homicide Bureau or Crime Stoppers.

I THEREFORE MOVE THAT THE BOARD OF SUPERVISORS:

Re-establish and increase the offer of a reward from \$10,000 to \$15,000 in exchange for information leading to the apprehension and conviction of the individual(s) responsible for the heinous death of Marvin Randolph, who was murdered on April 5, 2025, at approximately 2:17 p.m. in the unincorporated area of West Athens.
