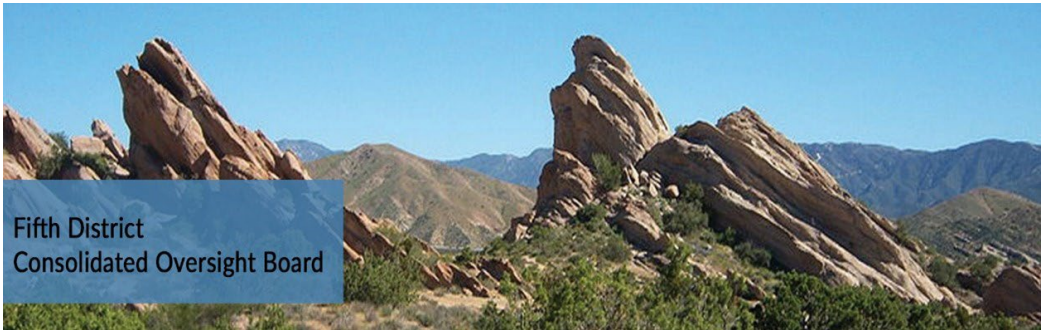


FIFTH DISTRICT CONSOLIDATED OVERSIGHT BOARD
