1.0 INTRODUCTION

In compliance with Section 15132 of the California Environmental Quality Act (CEQA) *Guidelines*, this document serves as the Final EIR for the proposed Santa Clarita Valley Area Plan Update (One Valley One Vision) (County Project No. R2007-01226-(5)), which consists of the following discretionary project approvals:

- (a) *Plan Amendment No. 2009-00006-(5)*
- (b) *Zone Change No. 2009-00009-(5)*

The proposed Area Plan's Draft EIR was made available for public review and comment on September 4, 2009. The County initially provided a 60-day comment period for the Draft EIR, which was scheduled to conclude on November 2, 2009. However, the comment period subsequently was extended to 120 days in response to requests for additional time, and ultimately terminated on February 1, 2010. The proposed Area Plan's Revised Draft EIR was then released on November 23, 2010, and made available for public review and comment for a 60-day comment period that terminated on January 24, 2011. (Although the Revised Draft EIR was recirculated in its entirety, substantive changes were only made to the air quality, traffic and circulation, global climate change, and water supply sections.) To ensure public access to the Draft EIR, copies of the document were made available for review at four local libraries, as well as the Department of Regional Planning offices. In addition, the Draft EIR was made available on the Department of Regional Planning's website. Section 15132 of the *State CEQA Guidelines* requires that the Final EIR consist of the following elements:

- (a) *The Revised Draft EIR or a revision of the draft.*¹
- (b) *Comments and recommendations received on the Revised Draft EIR either verbatim or in summary.*²
- (c) *A list of persons, organizations, and public agencies commenting on the Revised Draft EIR.*
- (d) *The responses of the Lead Agency to significant environmental points raised in the review and consultation process.*
- (e) *Any other information added by the Lead Agency.*
