At its meeting held September 23, 2003, the Board took the following action:

Supervisor Knabe made the following statement:

"On the night of June 19, 2002 around 11:00 o'clock, Alfonso Pimentel, was shot dead while sitting in his car in the parking lot of a Farmers Boy market located in the City of Paramount. The suspect has been identified by Sheriff's Department Homicide investigators as Manuel Jesus Bueno, a known gang member.

"The whereabouts of the suspect is unknown at this time. Unconfirmed reports indicate the suspect fled to Mexico, is staying with friends in Las Vegas, and frequents his mother's house in Compton. Efforts to obtain his whereabouts have proven unfruitful.

"It is important for the County of Los Angeles to display its resolve in protecting innocent citizens from appalling crimes. In order to bring this suspect to justice, and demonstrate our intolerance to such deplorable crimes, I believe the reward for this case should be extended for three more months, hoping someone will come forward in order that we can bring this suspect to justice."

Therefore, on motion of Supervisor Knabe, seconded by Supervisor Yaroslavsky, unanimously carried, the Board approved the extension of the \$5,000 reward for any information leading to the arrest and conviction of Manuel Jose Bueno, who is suspected of murdering Alfonso Pimentel while he was sitting in his car in the parking lot of a Farmers Boy Market located in the City of Paramount, on Wednesday, June 19, 2002 at approximately 11:00 p.m.

NOTICE OF \$5,000 REWARD OFFERED BY THE LOS ANGELES COUNTY BOARD OF SUPERVISORS

Notice is hereby given that the Board of Supervisors of the County of Los Angeles has extended the \$5,000 reward for any information leading to the arrest and conviction of Manuel Jose Bueno, who is suspected of murdering Alfonso Pimentel while he was sitting on his car in the parking lot of a Farmers Boy Market located in the City of Paramount, on Wednesday, June 19, 2002 at approximately 11:00 p.m.

Any person having any information related to this crime is requested to call Detective Dan Mc Elderry or Detective Steven Katz at the Los Angeles County Sheriff's Homicide Bureau at (323) 890-5500 and refer to Report No. 002-15134-1364-011.

The terms of the reward provide that:

- The information given that leads to the determination of the identity, the apprehension and conviction of any person or persons must be given no later than December 21, 2003. All reward claims must be in writing and shall be received no later than February 19, 2004.
- The total County payment of any and all rewards shall in no event exceed \$5,000 and no claim shall be paid prior to conviction unless the Board of Supervisors makes a finding of impossibility of conviction due to the death or incapacity of the person or persons responsible for the crime or crimes.
- The County reward may be apportioned between various persons and/or paid for the conviction of various persons as the circumstances fairly dictate.

Any claims for the reward funds should be filed no later than February 19, 2004 with the Executive Officer of the Board of Supervisors, 500 West Temple Street, Room 383 Kenneth Hahn Hall of Administration, Los Angeles, California 90012, Attention: Alfonso Pimentel Reward Fund.
