ORDINANCE NO. 2013-0056

An ordinance amending Title 3 – Advisory Commissions and Committees of the Los Angeles County Code authorizing the Los Angeles County Historical Landmarks and Records Commission to consult with the Director of the Department of Regional Planning of the County of Los Angeles as required by Part 26 of Chapter 22.52 of Title 22 of this code in connection with the Los Angeles County Mills Act Program.

The Board of Supervisors of the County of Los Angeles ordains as follows:

SECTION 1. Section 3.30.80 is hereby amended to read as follows:

3.30.080 Powers and dDuties.

A. The eCommission shall consider and recommend to the bBoard local historical landmarks defined to be worthy of registration by the sState of California Department of Parks and Recreation, either as "California Historical Landmarks" or as "Points of Historical Interest," and may consider and comment for the bBoard on applications relating to the National Register of Historic Places.

Criteria for designation, including significance and access, and provision for maintenance, shall be as specified in sState law, including the California Public Resources Code, or in regulations and interpretations of the State Historical Resources Commission. Criteria for consideration and comment on applications relating to the National Register of Historic Places shall be as specified in federal law and regulations relating to the National Register of Historic Places.

B. The Commission shall consult with the Director of the Department of Regional Planning of the County of Los Angeles where required by Part 26 of Chapter 22.52 of Title 22 of this code in connection with the Los Angeles County Mills Act Program.
