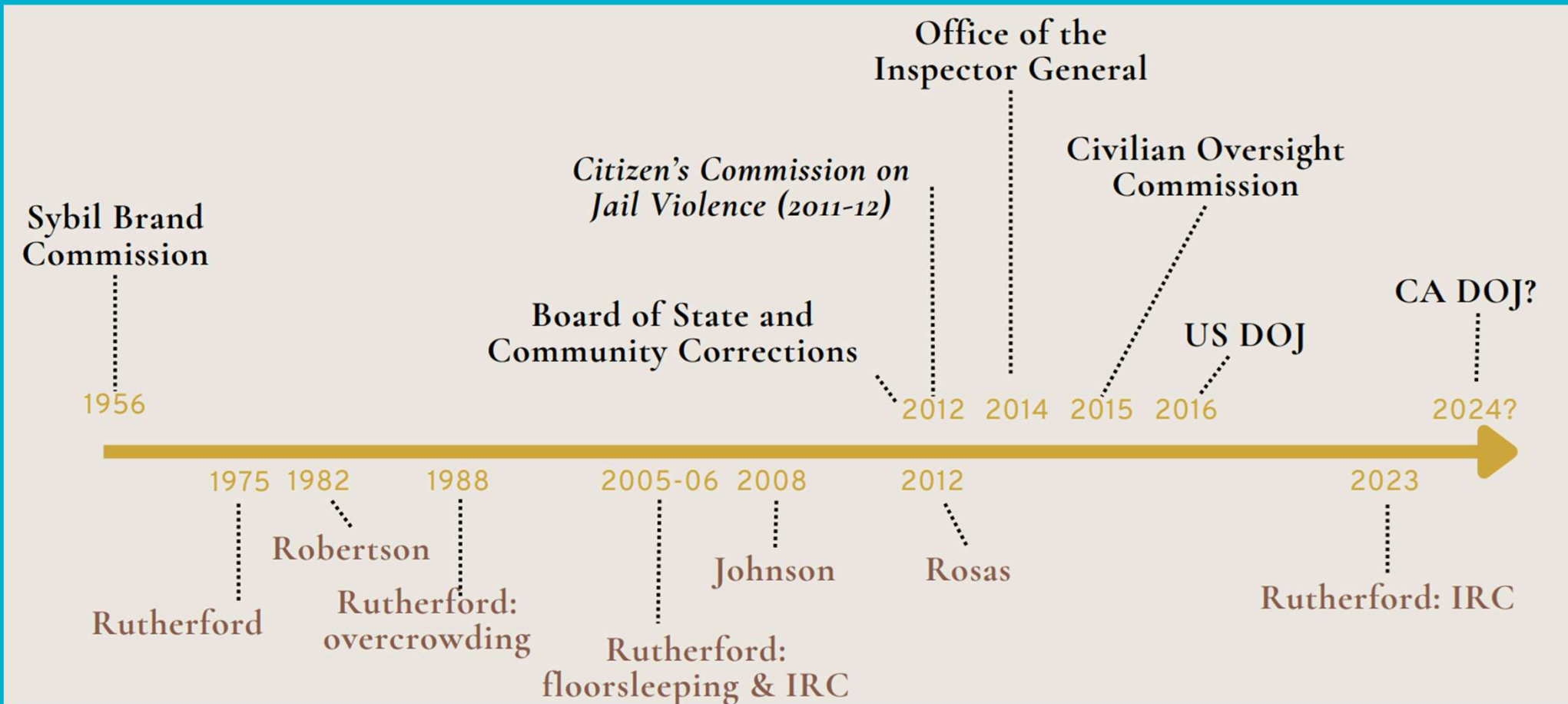

- Use of force
- Retaliation
- Access to grievances

Monitoring & Reporting

A lot of information, limited audience, limited enforcement power

- Reports to the court
 - DOJ, *Johnson, Rosas, Rutherford*
 - Limited to orders in these cases
 - Public reporting
 - SBC, OIG, BSCC, Gov mandated (in-custody death)
 - Public meetings
 - SBC, COC, BSCC
 - Board of Supervisors

Enforcement

Lack of accountability

- Court orders
 - Money judgments
 - DA prosecution
 - US DOJ prosecution
 - LASD disciplinary process
 - Sheriff removal
