3. **Please provide your public comment on LASD's Public Safety Budget prioritization for Fiscal Year 2022-2023.**

The Ad Hoc Committee on Policing & Human Relations of the Los Angeles County Commission on Human Relations (LACCHR) reviewed the LASD's Public Safety Budget Prioritization for Fiscal Year 2021-2022. The Ad Hoc Committee analyzed the budget priorities therein through the lens of the LACCHR's report, *Redefining Policing With Our Community*, a three-year effort to glean best practices in police-community relations through hearings and interviews with community members and law enforcement experts from every corner of Los Angeles County. In planning for Fiscal Year 2022-2023 budget priorities, the Ad Hoc Committee recommends that LASD should consider the report's recommendations which were aimed at advancing equity in policing practices, policies, and procedures. The Ad Hoc Committee recommends inclusion of budget priorities that are in alignment with report recommendations, and exclusion of budget priorities that are in misalignment with report recommendations. The following budget priorities were either in alignment or misalignment with report recommendations. All other budget priorities listed in the LASD's Public Safety Budget Prioritization for Fiscal Year 2021-2022 were not included in this analysis because they were not materially relevant to the report.

1) Reverse Appropriation Transferred to Provisional Financing Uses (PFU) – Misalignment

This budget priority is in misalignment with Recommendation 23 – Create and implement policies, protocols, and performance evaluation metrics that incentivize the transformation of law enforcement from a “guardian of public order” mentality to an “officer of peace” orientation. The Ad Hoc Committee agrees with the CEO's assessment that while LASD continues to make progress towards a balanced budget, the department must implement ongoing mitigation efforts to ensure a balanced budget in this year and future fiscal years before this funding is released. This process incentivizes LASD's transformation from “guardians of public order” to “officers of peace” because it underlies a commitment to transparency and accountability, which includes proper fiscal management. Further, the Ad Hoc Committee recommends that the intended use of this funding once released be identified publicly to ensure it is in alignment with the County's public safety priorities,

which may include improvements in data tracking systems and technology to support the department's transition to 21st century policing.

3) Body Worn Cameras – Alignment

This budget priority is in alignment with Recommendation 31 – Adopt and implement protocols to ensure timely release of footage to the public domain from body worn cameras and other surveillance technologies potentially used in prosecution.

4) Homeless Outreach Service Team Restoration/Expansion – Alignment

This budget priority is in alignment with Recommendation 26 – Increase capacity and number of co-response teams for responding to calls involving persons experiencing homelessness, substance use disorders, and mental health challenges. The Ad Hoc Committee applauds LASD's commitment to prioritizing co-responder models in addressing social challenges such as homelessness. While this budget priority aligns with the LACCHR's report, the Ad Hoc Committee recommends that the investments of funding to these co-response teams be increased significantly to support adequate personnel levels and resources for both law enforcement and non-law enforcement responders to ensure that the County's public safety priorities with regards to alternatives to incarceration and diversion initiatives are met. Moreover, the Ad Hoc Committee recommends that the Homeless Outreach Services Team should focus on achieving non-criminal justice-related outcomes such as linkages to housing and systems of care. To further curtail criminalization of the homeless community the lead agencies should include the Department of Public Health, Department of Health Services, and Department of Mental Health, with LASD serving in a supportive capacity. While the absence of encampments in high-visibility areas is often touted as an accomplishment, this does not correlate to people receiving the services they need to be housed and/or maintain their housing to truly address the challenge of homelessness in LA County.

5) Youth Activity League (YAL) Programs – Unsure

This budget priority is in alignment with Recommendation 13 – Increase police engagement in activities unrelated to enforcement that promote ongoing dialogue to humanize all public safety stakeholders; activities can include community events, urban gardens, recreational programming, and facilitated discussions which allow for the most vulnerable populations to safely speak directly to those with policing power. Since our hearings, many more people in impacted communities have shifted their opinions away from increasing police engagement with community members in activities unrelated to enforcement. The Ad Hoc Committee recognizes that YAL programs exist in historically underserved communities in LA County, and that disruptions in these programs will negatively impact those communities, namely the lives of young people who rely on these programs for afterschool and extracurricular activities. The Ad Hoc Committee recommends continued funding support for YAL programs as the County develops a plan of action to invest in supplanting these programs with community-based alternatives to youth programs. The County can leverage Youth Justice Reimagined, the Care First Community Investment Initiative, and the Youth Development Department to meet the needs of young people in underserved communities where YAL programs are the sole service providers. Further, the Ad Hoc Committee recommends that the County work with LASD to implement appropriate data tracking systems and evaluation metrics to identify the social impact and quality of programming offered through YAL programs. This information should be made available to the public and leveraged to further investments in community-based alternatives. Whereas positive youth engagement with law enforcement supports recruitment efforts and trust building, it is far more beneficial to engage young people in peer-led, community-based programs that are trauma-informed and grounded in youth development work.

7) Mental Evaluation Team (MET) Restoration – Alignment

This budget priority is in alignment with Recommendation 26 – Increase capacity and number of co-response teams for responding to calls involving persons experiencing homelessness, substance use disorders, and mental health challenges. The Ad Hoc Committee applauds LASD’s commitment to prioritizing co-responder models in addressing social challenges such as mental health. While this budget priority aligns with the LACCHR’s report, the Ad Hoc Committee recommends that the investments of funding to these co-response teams be increased significantly to support adequate personnel levels and resources for both law enforcement and non-law enforcement responders to ensure that the County’s public safety priorities with regards to alternatives to incarceration and diversion initiatives are met. Moreover, the Ad Hoc Committee recommends that Mental Evaluation Teams should focus on achieving non-criminal justice-related outcomes such as linkages to supportive services and systems of care. To further curtail criminalization of people with mental health challenges the lead agencies should include the Department of Public Health, Department of Health Services, and Department of Mental Health, with LASD serving in a supportive capacity.

8) Integrated Co-Response & Crisis Intervention Bureau – Alignment

This budget priority is in alignment with Recommendation 26 – Increase capacity and number of co-response teams for responding to calls involving persons experiencing homelessness, substance use disorders, and mental health challenges. The Ad Hoc Committee applauds LASD’s commitment to prioritizing co-responder models in addressing social challenges such as mental health, substance use and homelessness. While this budget priority aligns with the LACCHR’s report, the Ad Hoc Committee recommends that the investments of funding to these co-response teams be increased significantly to support adequate personnel levels and resources for both law enforcement and non-law enforcement responders to ensure that the County’s public safety priorities with regards to alternatives to incarceration and diversion initiatives are met. Moreover, the Ad Hoc Committee recommends that all teams deployed by the Integrated Co-Response & Crisis Intervention Bureau should focus on achieving non-criminal justice-related outcomes such as linkages to housing and systems of care. To further curtail criminalization of people in crisis the lead agencies should include the Department of Public Health, Department of Health Services, and Department of Mental Health, with LASD serving in a supportive capacity.

9) Veterans Mental Evaluation Team (VMET) Expansion – Alignment

This budget priority is in alignment with Recommendation 26 – Increase capacity and number of co-response teams for responding to calls involving persons experiencing homelessness, substance use disorders, and mental health challenges. The Ad Hoc Committee applauds LASD’s commitment to prioritizing co-responder models in addressing social challenges such as mental health. While this budget priority aligns with the LACCHR’s report, the Ad Hoc Committee recommends that the investments of funding to these co-response teams be increased significantly to support adequate personnel levels and resources for both law enforcement and non-law enforcement responders to ensure that the County’s public safety priorities with regards to alternatives to incarceration and diversion initiatives are met. Moreover, the Ad Hoc Committee recommends that Veterans Mental Evaluation Teams should focus on achieving non-criminal justice-related outcomes such as linkages to supportive services and systems of care. To further curtail criminalization of veterans with mental health challenges the lead agencies should include the Department of Military and Veterans Affairs, Department of Public Health, Department of Health Services, and Department of Mental Health, with LASD serving in a supportive capacity.

12) Public Records Act Additional Staffing – Alignment

This budget priority is in alignment with Recommendation 23 – Create and implement policies, protocols, and performance evaluation metrics that incentivize the transformation of law enforcement from a “guardian of public order” mentality to an “officer of peace” orientation. A commitment to transparency and accountability is paramount for this transformation to be effective. Adequate staffing to ensure timely and appropriate responses to Public Records Act requests is critical in building public trust in the department and elevating community oversight.
