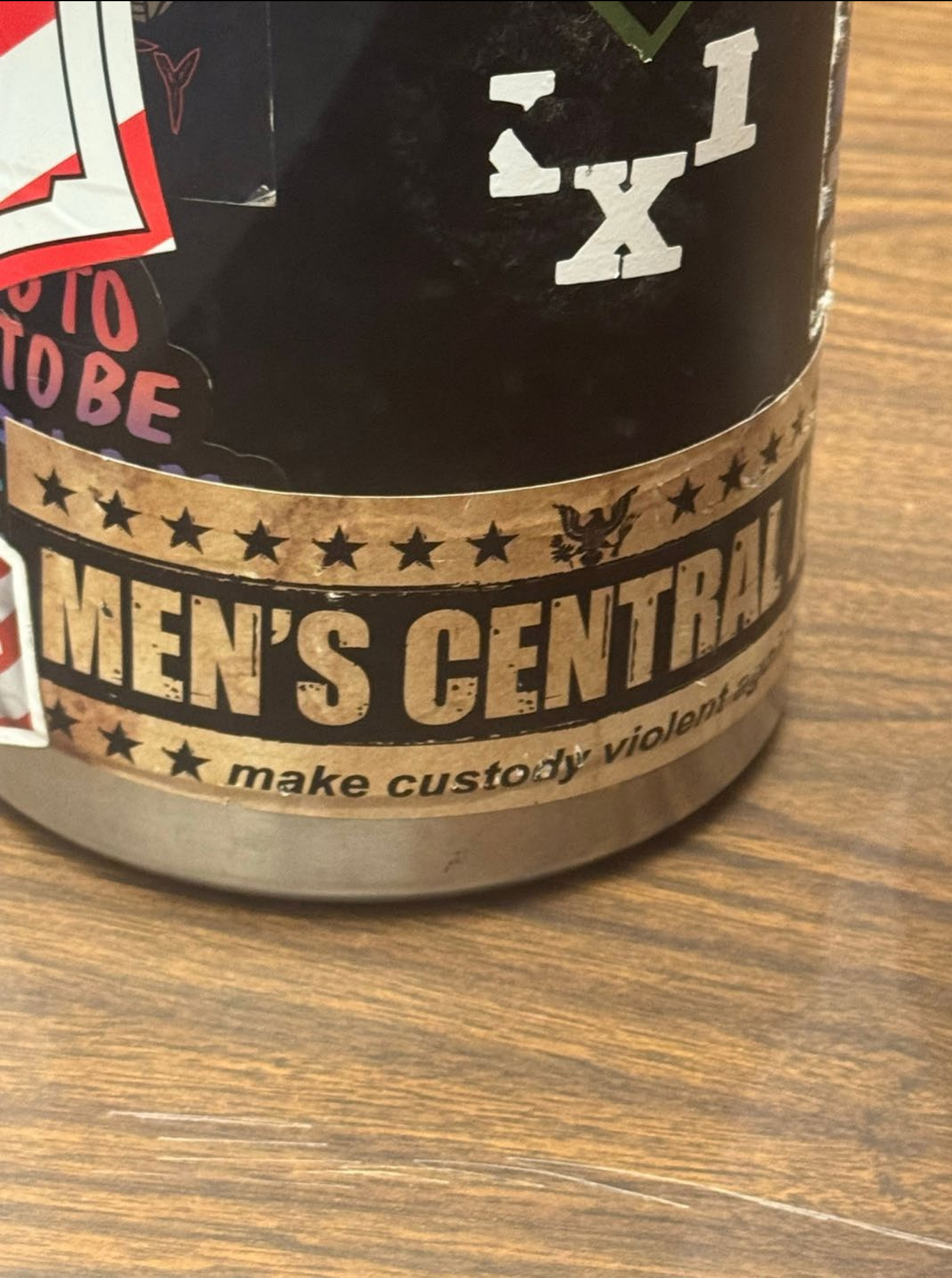

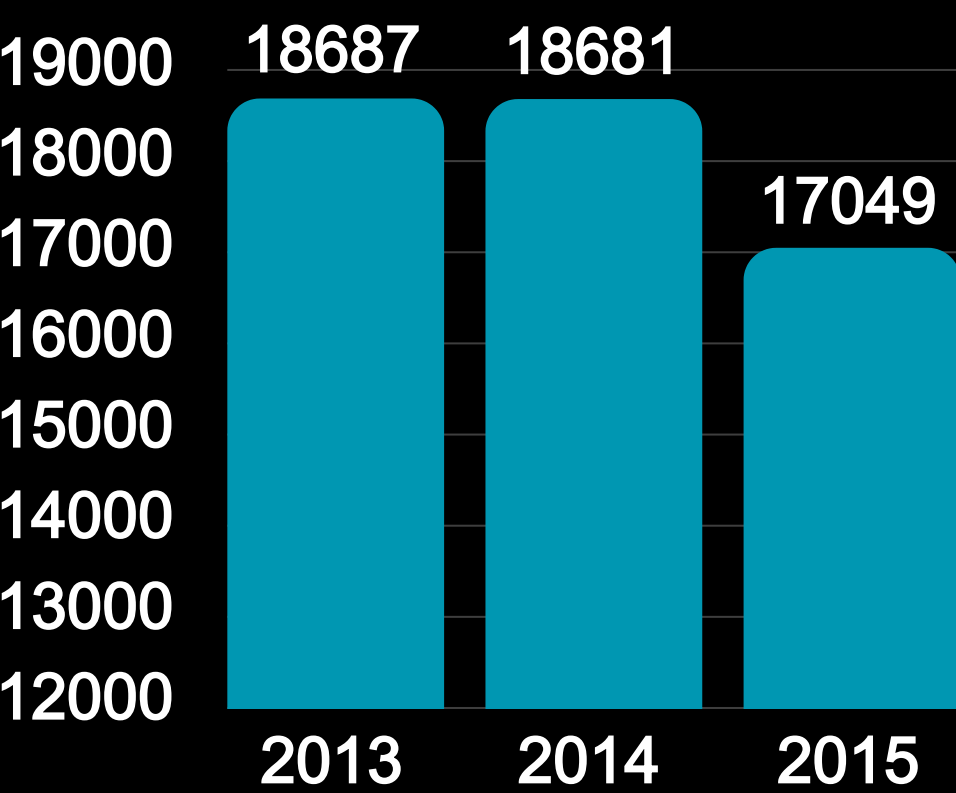
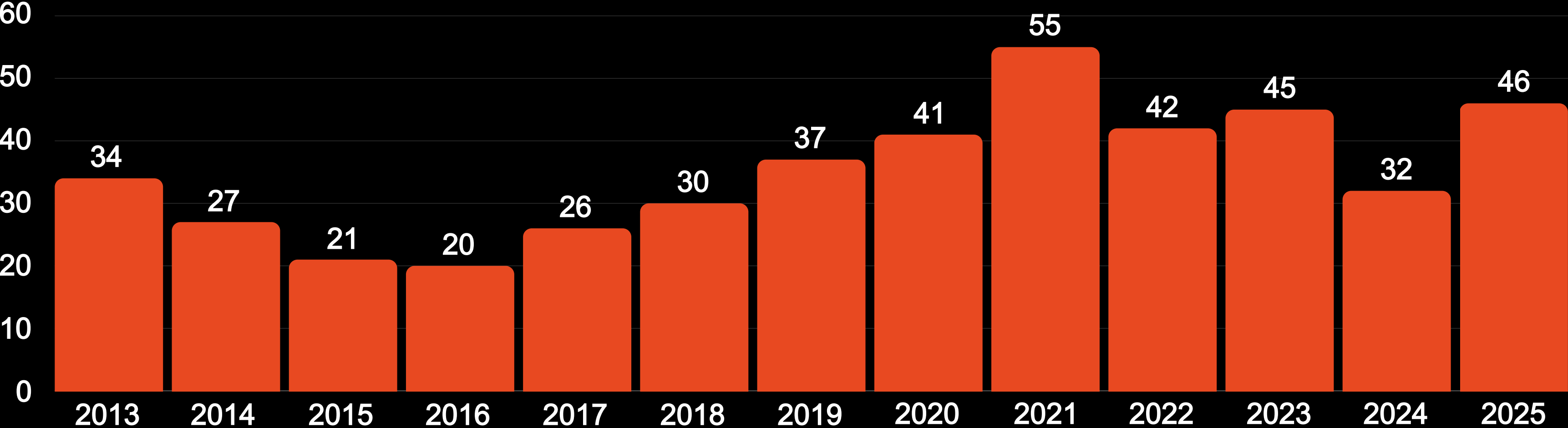

**Murdered by the 3000 Boys
on March 30, 2009.**

- The 3000 Boys operate in the Men's Central Jail and emerged in the 2000s. Deputies operating at correctional facilities often physically abused or tortured those in custody, with objectives such as causing the hospitalization of the victim or the fracture of bones seen as desirable or necessary for initiation.
- The 3000 Boys may be the largest deputy gang within LASD. Members are tattooed with a "III" on their calf—earned by using excessive force against an inmate and then filing a false report thereafter.

THE ABUSE

CONTINUES

Jalani Lovett: Killed on September 22, 2021 while in solitary confinement at Men's Central Jail, on the 3000th floor. Death was ruled an overdose, while his body showed major signs of abuse.

Quenten Thomas: Killed on March 9, 2018 while incarcerated at Twin Towers. Deputies and staff neglected Quenten's medical issues. Quenten died just 7 days after being incarcerated.

Joseph Perez: Attacked and beaten by Sheriff Deputies. He continues to not receive adequate medical treatment while incarcerated.

Maxwell Aguirre: Air Force veteran died September 2023 while at Twin Towers. Deputies failed to perform mandatory Title 15 security checks. Instead of performing these security checks deputies were watching YouTube videos.
