About Us

The Probation Oversight Commission is a civilian oversight body that advises the Probation Department and the Board of Supervisors and monitors the Probation Department's progress on systemic reform. The Probation Oversight Commission has the authority and duty to: Review departmental policies, procedures, and practices;

 Conduct inspections in order to ensure the physical safety and welfare of youth and adults in Probation custody;

•Investigate critical matters brought to the Commission's attention;

•Receive and review grievances;

•Compel data, real evidence, and direct testimony including the power to subpoena necessary information from the Probation Department; and

•Engage the public through robust and transparent reporting and regular meetings.



Our Challenge – Biased, Harmful Perceptions

- Mainstream perceptions: crime among young people is on the rise and punishment is the most effective consequence (Fenton Comm. Harris Poll 2024)
- Adultification bias: a form of implicit bias rooted in racial discrimination that influences how adults perceive children; namely that Black & Latine youth are less innocent than their white peers (Georgetown Law Center on Poverty & Equality; National Council of Juvenile and Family Court Judges)
- "Superpredator" myth: racist theory that depicted boys of color as radically impulsive, brutally remorseless youth with no respect for human life. (Equal Justice Initiative)

Our Challenge – Data-Sharing & Analysis

- Limited compliance with data-sharing agreement
- Probations' own admission that their data systems are antiquated and cumbersome
- When data is shared, it is often:
- □ Incomplete
- □ Late / past-due
- Contains errors and requires revisions
- □ Lacks consistency from one dataset to another

Our Goal – Increase Transparency

Publish reports and fact sheets using Probation data to:

- Share demographics and increase transparency about who's detained
- Promote data-driven decision-making
- Correct the narrative about justice-involved youth
- Advocate for ongoing reform

Justice-system involved youth are likely to struggle with one or more of the following:

- Untreated trauma
- Maltreatment, removal from home
- Poverty, community violence & disinvestment
- Undiagnosed learning disabilities & poor academic performance
- Substance abuse
- Depression and sense of hopelessness
- Impulsivity and peer pressure
- Trafficking

But with the right support, hope and healing are possible

- Adolescence is a period of significant brain and human development
- The juvenile-justice system shouldn't mimic the adult criminal justice system
