On Sept. 9, 2025, the Probation Dept. changed the way in which they report daily population statistics data to the POC. The new format, above, contains aggregated age data which makes it difficult to isolate specific ages and monitor trends.

Additionally, the new report does not provide a breakdown of the youth's case status. Without this critical information, we are unable to monitor the percentage of pre-disposition youth detained in juvenile hall.

Given these changes, we are unable to update the POC dashboard but will continue to share the statistics via a PDF documents to the public has access to the information.
