	Violence impacts all of us. Violence harms people of all ages, genders, sexual orientations, income levels, physical and mental abilities, and religious, racial/ethnic backgrounds in every community and in every area of LA County. This tells us that we are all impacted by violence and each of us have a role to play in the prevention of violence. How violence aligns, or does not align, with social and socioeconomic conditions at the community level; the social determinants of health. It is important to consider how local community conditions (availability of jobs, access to parks and libraries, transportation, etc.) may be related to violence. We analyzed the relationship between trauma center visits for assaults and the Healthy Places Index (a measure of community conditions). We found that while violence and unhealthy community conditions tend to be found in the same geographic areas, this is not always the case, and further research is needed to understand unique local dynamics. Our analysis suggested that the relationship between community conditions and assaults was stronger in some areas (SPA 6, SPA 8) than others (SPA 1, SPA 2). More detailed results of this analysis can be found in Appendix F and on OVP's website. This tells us that place-based approaches are needed to address how violence impacts individual communities and to address unhealthy community conditions that are related to violent outcomes.
	How these data may mislead us Underreporting of violence affects the numbers and rates we calculate. Surveys indicate that many crimes are not reported to law enforcement agencies. Additionally, not all injured victims seek medical treatment for violence-related injuries. Reasons for underreporting may include lack of trust in medical and criminal justice systems, fear of reprisal by perpetrators or lack of services in a given community. If members of some demographic groups report less consistently when they are victims of violence, this will give us an incorrect picture of who is most impacted, with those with greater access or trust seeming to be disproportionately impacted. Reporting may also vary substantially depending on the type of violence. The 2018 National Crime Victimization Survey reported that overall 43% of victims of

violent crimes reported the crime to law enforcement; however, among victims of rape/sexual assault,

only 25% of victims reported the crime22

. This tells us that strategies that build trust and improve

equitable access to services are needed if we are to accurately understand the impact of violence, and to develop further strategies to prevent it.

Systemic biases impact the information collected from our data sources. Systems (health care, schools, law enforcement, etc.)

Mr. Justice Holmes made the point a half century ago.

"When a legal distinction is determined, as no one doubts that it may be, between night and day, childhood and maturity, or any other extremes, a point has to be fixed or a line has to be drawn, or gradually picked out by successive decisions, to mark where the change takes place. Looked at by itself, without regard to the necessity behind it, the line or point seems arbitrary. It might as well or nearly as well be a little more to one side or the other. But when it is seen that a line or point there must be, and that there is no mathematical or logical way of fixing it precisely, the decision of the legislature must be accepted unless we can say that it is very wide of any reasonable mark."

Louisville Gas Co. v. Coleman, 277 U. S. 32, 277 U. S. 41 (dissenting opinion).

When separate but equal was still accepted constitutional dogma, this Court struck down a racially restrictive zoning ordinance. Buchanan v. Warley, 245 U. S. 60 (1917). I am sure the Court would not be hesitant to invalidate that ordinance today. The lower federal courts have considered procedural aspects of zoning, [Footnote 2/2] and acted to insure that land use controls are not used as means of confining minorities and the poor to the ghettos of our central cities. [Footnote 2/3] These are limited but necessary intrusions on the discretion of zoning authorities. By the same token, I think it clear that the First Amendment provides some limitation on zoning laws. It is inconceivable to me that we would allow the exercise of the zoning power to burden First Amendment freedoms, as by ordinances that restrict occupancy to individuals adhering to particular religious, political, or scientific beliefs. Zoning officials properly concern

themselves with the uses of land -- with, for example, the number and kind of dwellings to be constructed in a certain neighborhood or the number of persons who can reside in those dwellings. But zoning authorities cannot validly consider who those persons are, what they believe, or how they choose to live, whether they are Negro or white, Catholic or Jew, Republican or Democrat, married or unmarried.

My disagreement with the Court today is based upon my view that the ordinance in this case unnecessarily burdens appellees' First Amendment freedom of association and their constitutionally guaranteed right to privacy. Our decisions establish that the First and Fourteenth Amendments protect the freedom to choose one's associates. NAACP v. Button, 371 U. S. 415, 371 U. S. 430 (1963). Constitutional protection is extended not only to modes of association that are political in the usual sense, but also to those that pertain to the social and economic benefit of the members. Id. at 371 U. S. 430-431; Brotherhood of Railroad Trainmen v. Virginia Bar, 377 U. S. 1 (1964). See United Transportation Union v. State Bar of Michigan, 401 U. S. 576 (1971); Mine Workers v. Illinois State Bar Assn., 389 U. S. 217 (1967). The selection of one's living companions involves similar choices as to the emotional, social, or economic benefits to be derived from alternative living arrangements.

The freedom of association is often inextricably entwined with the constitutionally guaranteed right of privacy. The right to "establish a home" is an essential part of the liberty guaranteed by the Fourteenth Amendment. Meer v. Nebraska, 262 U. S. 390, 262 U. S. 399 (1923); Griswold v. Connecticut, 381 U. S. 479, 381 U. S. 495 (1965) (Goldberg, J., concurring). And the Constitution secures to an individual a freedom "to satisfy his intellectual and emotional needs in the privacy of his own home." Stanley Page 416 U. S. 16

v. Georgia, 394 U. S. 557, 394 U. S. 565 (1969); see Paris Adult Theatre I v. Slaton, 413 U. S. 49, 413 U. S. 667 (1973). Constitutionally protected privacy is, in Mr. Justice Brandeis' words, "as against the Government, the right to be let alone . . . the right most valued by civilized man." Olmstead v. United States, 277 U. S. 438, 277 U. S. 478 (1928) (dissenting opinion). The choice of household companions -- of

whether a person's "intellectual and emotional needs" are best met by living with family, friends, professional associates, or others -- involves deeply personal considerations as to the kind and quality of intimate relationships within the home. That decision surely falls within the ambit of the right to privacy protected by the Constitution. See Roe v. Wade, 410 U. S. 113, 410 U. S. 153 (1973); Eisenstadt v. Baird, 405 U. S. 438, 405 U. S. 453 (1972); Stanley v. Georgia, supra, at 394 U. S. 564-565; Griswold v. Connecticut, supra, at 381 U. S. 483, 381 U. S. 486; Olmstead v. United States, supra at 277 U. Section 242 of Title 18 makes it a crime for a person acting under color of any law to willfully deprive a person of a right or privilege protected by the Constitution or laws of the United States.

For the purpose of Section 242, acts under "color of law" include acts not only done by federal, state, or local officials within their lawful authority, but also acts done beyond the bounds of that official's lawful authority, if the acts are done while the official is purporting to or pretending to act in the performance of his/her official duties. Persons acting under color of law within the meaning of this statute include police officers, prisons guards and other law enforcement officials, as well as judges, care providers in public health facilities, and others who are acting as public officials. It is not necessary that the crime be motivated by animus toward the race, color, religion, sex, handicap, familial status or national origin of the victim.

The offense is punishable by a range of imprisonment up to a life term, or the death penalty, depending upon the circumstances of the crime, and the resulting injury, if any.

TITLE 18, U.S.C., SECTION 242

Whoever, under color of any law, statute, ordinance, regulation, or custom, willfully subjects any person in any State, Territory, Commonwealth, Possession, or District to the deprivation of any rights, privileges, or immunities secured or protected by the Constitution or laws of the United States, ... shall be fined under this title or imprisoned not more than one year, or both; and if bodily injury results from the acts committed in violation of this section or if such acts include the use, attempted use, or threatened use of a dangerous weapon, explosives, or fire, shall be fined under this title or imprisoned not more than ten years, or both; and if death results from the acts committed in violation of this section or if such acts include kidnapping or an attempt to kidnap, aggravated sexual abuse, or an attempt to commit aggravated sexual abuse, or an attempt to kill, shall be fined under this title, or imprisoned for any term of years or for life, or both, or may be sentenced to death.

18 U.S. Code § 112 - Protection of foreign officials, official guests, and internationally protected persons U.S. Code Notes

(a)Whoever assaults, strikes, wounds, imprisons, or offers violence to a foreign official, official guest, or internationally protected person or makes any other violent attack upon the person or liberty of such person, or, if likely to endanger his person or liberty, makes a violent attack upon his official premises, private accommodation, or means of transport or attempts to commit any of the foregoing shall be fined under this title or imprisoned not more than three years, or both. Whoever in the commission of any such act uses a deadly or dangerous weapon, or inflicts bodily injury, shall be fined under this title or imprisoned not more than ten years, or both.

- (b)Whoever willfully—
- (1)intimidates, coerces, threatens, or harasses a foreign official or an official guest or obstructs a foreign official in the performance of his duties;
- (2)attempts to intimidate, coerce, threaten, or harass a foreign official or an official guest or obstruct a foreign official in the performance of his duties; or
- (3) within the United States and within one hundred feet of any building or premises in whole or in part owned, used, or occupied for official business or for diplomatic, consular, or residential purposes by—
 (A) a foreign government, including such use as a mission to an international organization;
- (B)an international organization;
- (C)a foreign official; or
- (D)an official guest;

congregates with two or more other persons with intent to violate any other provision of this section; shall be fined under this title or imprisoned not more than six months, or both.

(c) For the purpose of this section "foreign government", "foreign official", "internationally protected

person", "international organization", "national of the United States", and "official guest" shall have the same meanings as those provided in section 1116(b) of this title.

(d)Nothing contained in this section shall be construed or applied so as to abridge the exercise of rights guaranteed under the first amendment to the Constitution of the United States.

(e)If the victim of an offense under subsection (a) is an internationally protected person outside the United States, the United States may exercise jurisdiction over the offense if (1) the victim is a representative, officer, employee, or agent of the United States, (2) an offender is a national of the United States, or (3) an offender is afterwards found in the United States. As used in this subsection, the United States includes all areas under the jurisdiction of the United States including any of the places within the provisions of sections 5 and 7 of this title and section 46501(2) of title 49.

(f)In the course of enforcement of subsection (a) and any other sections prohibiting a conspiracy or attempt to violate subsection (a), the Attorney General may request assistance from any Federal, State, or local agency, including the Army, Navy, and Air Force, any statute, rule, or regulation to the contrary, notwithstanding.

But our county's budget shows LA is still addicted to arresting and jailing people rather than caring for them.

In years of good economy and bad, years of rising and falling crime, waxing and waning numbers of people incarcerated, LA County continuously showers law enforcement with ever-increasing funding, leaving budget dust for alternatives to incarceration and community systems of care.

In Los Angeles County, the jail budget has increased 44% since fiscal year 2011. The number of sheriff employees has also increased. The jail population, however, has decreased by 5% during the same period. - https://www.vera.org/publications/what-jails-cost-cities/los-angeles-ca LASD's proposed budget is larger than last year, and the LASD is proposing to add 14 more staff—which increases personnel budget by 10.5M. In contrast, LA County is proposing to spend \$200 million on the Care First and Community Investment budget unit—so 17 times less than on LASD (Civilytics) LA County is proposing to spend \$633 per resident on "law and justice" departments next year. In contrast, LA County is only proposing to spend \$20 per resident on the Care First and Community Investment budget unit. (Civilytics)

Nearly 30,000 people work for the county's "law and justice" departments.
