Agenda Item 4	Sheriff deputies not only get away with killing Black and brown folks, but also get away with retaliating against and harassing the families of those who they've killed. Families are only trying to expose the violence, discrimination, and racism demonstrated by LASD, but are then harassed for exercising their First Amendment rights and seeking truth and accountability. LASD deputies have used a variety of malicious tactics to intimidate these family members: slowly driving by or parking in front of their homes; slowly driving by memorial sites; damaging items at memorial sites; taunting family members with rude comments, gestures, smirks, and laughter; following family members while they are driving; parking outside family members' workplaces; and taking pictures of or recording family members. Deputies have also engaged in more serious and often illegal forms of harassment on a number of occasions, including targeting family members for arrest and detention without probable cause, frequently pulling over family members and searching their vehicles, and harassing family members of minor age. Back in 2019, the Check the Sheriff coalition brought this crisis to the attention of this Commission, OIG, and the Board of Supervisors (Board). As a result, since 2019, both this Commission and the Board have condemned LASD's harassment of families. Importantly, on July 27, 2021, the Board by motion requested LASD develop and adopt a policy to protect memorial sites and vigils for victims of deputy-involved shootings and killings. LASD was supposed to do so within 90 days. Yet, more than two years later, LASD has not adopted any policy which prohibits the harassment of surviving families. As a result, surviving families continue to suffer under the harassment of LASD	Sarah Bowers

Only after community pressure did this Commission and the Board of supervisors condemn LASD's harassment of families. On July 27, 2021, the Board by motion requested LASD develop and adopt a policy to protect memorial sites and vigils for victims of deputy-involved shootings and killings. LASD was supposed to do so within 90 days. But more than two years later, LASD has not adopted any policy which prohibits the harassment of surviving families. So y'all know families are continually harassed. At one of your last meetings Max Huntsman said that it's just a matter of fact that community members will continue to be harassed & killed by LASD. LASD must adopt a policy that prohibits surveillance, intimidation, and unnecessary interactions with surviving family members, either online or in person. LASD deputies must be prohibited from following family members, parking, or idling vehicles outside of their homes or places of work, filming family members, interacting with or observing family members' personal social media accounts or any social media pages created in memorial of their loved ones; and specifically preventing interactions with minors in these families, so that children can feel safe walking to school and in the community. These policies must prevent deputies from disrupting, destroying, surveilling, disturbing, or distracting from vigils and memorials. Our community is not safe from LASD violence & harassment. The sheriff himself said they have policies in place- but deputies aren't following them? So, how to get accountability? How do we enforce these policies?
