	There has been a history of drinking related problems in	
	LASD. Baca tried to instate a ban to carry while drinking in 2008 & 2010 but ALADS shot it down twice. The problems	
	haven't changed with drunk driving, fights and most recently	
	a deputy gang member shooting off another's tattoo. The sheriff must stand up to ALADS & update LASD policies to	
	protect the public (& his own staff) from LASD deputies. It's	
	the least you can do.	
	Does this commission notice how often the Sheriff says in	
	theory that he agrees with a policy but then quickly claims an uncited story that suggests he will use it to excuse why he	
	won't implement that policy when held accountable later?	
	8) 2023 In-custody deaths: 42 deaths in 48 weeks is	
	unacceptable. In-custody deaths have steadily increased from 19 in 2016. We listen to a report annually about in-	
	custody deaths without acknowledging this crises.	
	The majority of these folks were pre-trial & awaiting	
	resolution of their case. That's inhumane.	
	According to LASD's own website on in-custody deaths:	
	 The majority of folks listed as dying at LAGMC were due to sepsis - the medical care that folks receive inside is so bad 	
	that their health issues are not being addressed. These	

deaths were preventable.

- Look at all the deaths that occurred at MCJ on the 2000 & 3000 floors- the floors run by deputy gangs. According to the special council report we know there are other floors run by deputy gangs. How are your investigations of deputy gangs intersecting with jail deaths?
- Why does someone whose manner of death listed as suicide have their means of death listed as multiple blunt force injuries? That doesn't add up.
- What 31 yr old dies of natural causes? 32yr old? 46yr old? Even 50 & 60yr olds don't die of natural causes. Where's the oversight on the autopsies? Deputies are present at the coroner's office during autopsies while families are not permitted. Seems like a huge conflict of interest. Where's the oversight of the coroners office on the categorization of these deaths?
- Finally, stop with the lies about how drugs are making it inside- deputies do not go through the body scanners- the deputies are bringing it in.

2023 in-custody deaths were unfathomable, this year already 3 deaths in the first 2 weeks looks like nothing has changed. This is an emergency- the Board of Supervisors has done nothing. I urge this commission to use your power to urge the BoS to do act NOW.

On the pregnancy conversation. Pregnant people shouldn't be incarcerated, period. They are many other options. It's alarming to hear you talk about pregnant people needing bottled water without acknowledging that otherwise their drinking water comes out of the back of their toilet. No one should have to drink out of that dirty little sink. As Commissioner Johnson acknowledged the conditions in our jails, especially the drinking water, are life threatening. Did the report mention whether these folks were pregnant before they came to these facilities? With well documented reports of abuse especially at CRDF, that would be useful information for this commission to have, wouldn't it?

Please ensure all impacted families are given more than 2 minutes to speak, even if they arrive after the family impact remarks on the agenda. The community supports adjusting the agenda to ensure they are heard.
