This Commission must take bolder action to address the plague of deputy gangs within LASD. The Office of the Inspector General's February 26th 2024 report lays out in clear language that LASD has NEVER undertaken an investigation aimed at identifying every member of LASD gangs. LASD has NEVER made a determination whether or not deputy gangs violate LASD policy. This is unacceptable. Furthermore, LASD does not even have a policy that complies with state law requiring law enforcement departments to have a policy that establishes grounds for termination for those involved in deputy gangs. Sheriff Luna has not proven himself to be different from former sheriff Alex Villanueva as he has approved his department's non-compliance with the OIG's investigation into deputy gangs, nor has he publicly released any plan to eradicate deputy gangs from his department.

LASD gangs are not only illegal they also cost the county tens of millions of dollars in litigation expenses AND target our communities with violence and over policing. LASD continues to hide from the truth that the murder of Andres Guardado was carried out by the LASD gang- the Executioners. I encourage the COC to push the Board of Supervisors to stop financing the legal defense of deputy gangs with County taxpayer dollars. Lastly, and most importantly, the COC MUST consult with and invite family members who have been impacted by LASD deputy gangs. These family members can provide critical testimony about the widespread violence and harassment undertaken by LASD gangs.

Their houses "swatted" for no reason other than LASD murdered their loved one and they were speaking out against it.

As a teacher, I am all for accountability in academia. I believe a teacher should be fired if they have a certain number of complaints against them and fired immediately if they have more serious complaints filed against them. The same should be true for all industries and professions. Sheriff deputies hold so much power, and it is exactly those groups of professionals who should be held to the highest standard of accountability. Certainly officers who have murdered 13 people in Ohio, shouldn't just be transferred to LASD and other forces around the country. Certainly they should have been fired and charged, after the first murder. I have watched LASD bring violence to peaceful protests for so many years without any accountability. it is LASD's position that they are here to protect and serve and prevent crime, but they are in fact, creating "criminality" in their interactions with civilians, without any repercussion. I watched four sheriff deputies assault and take down an unhoused man in Pasadena three years back and beat him to a pulp on the street in front of Ralph's, while shouting "you attacked us," not knowing that I was videotaping the whole thing. I brought my video to the lieutenant and nothing was done. I tracked these officers down for months and filed complaints for months to make sure that this man was free and clear, because he had done nothing wrong, and nothing was done. He was just black and homeless in Pasadena. It's time for oversight. These are our tax dollars. These deputies absolutely work for us and will be held accountable! Come, Hell or high water!!

This Commission must take bolder action to address the plague of deputy gangs within LASD.
