Jail Conditions	Hello, my name is Jayme Kusyk with JusticeLA. I am writing to submit written public comments ahead of Friday, November 18th's Civilian Oversight Commission meeting regarding prison conditions. March 30, 2022 marks the one-year anniversary of the publication of the Men's Central Jail (MCJ) Closure Report. Men's Central Jail is Los Angeles' largest and oldest jail facility, and its unsafe, crowded, crumbling structure stands as a landmark of the dominance of mass incarceration in Los Angeles. The MCJ Closure Report outlines a roadmap for the closure of Men's Central Jail within 18-24 months, yet, the County has not taken the necessary steps to effectively close MCJ and direct funding and resources into our communities. In 2021, 55 people died in LA County jails, in the custody of the Los Angeles Sheriff's Department. The County has the finances and legal power to close Men's Central Jail and ensure that decarceration is safe and supportive for our communities. I have three demands for the Civilian Oversight Commission. FIRST, commit to closing MCJ without a replacement by March 2023. The target population for closing MCJ is now within sight. It is achievable with commitment and care. Last year at the onset of the pandemic, the county decreased the jail population by 30 percent within two months. An outcome previously considered unthinkable was achieved, and it promoted safety and health. This same level of focus and intensity is necessary now. This Commission must set a deadline for closure and public benchmarks for decarceration.	Jayme Kusyk

SECOND, commit to and create an independent pretrial services system in 3-6 months. Pretrial incarceration is a significant driver of the jail population. The Board agreed to implement the ATI Work Group strategy for pretrial services but has not yet delivered. As a result, wealth continues to determine access to release. The county can leverage and scale existing infrastructure within its health system to do release planning assessments, interface with system actors, and make referrals. It can also immediately fund key pillars-like text reminders, transportation assistance, and case management. It is critical that the county adheres to its "care first" vision in accelerating pretrial release through a framework of support and public health, which in turn decreases the reliance on jail and promotes safety.

THIRD, immediately allocate sufficient funding for community-based services that drive releases. Numerous county workgroups have called on the Board and CEO to fund behavioral health treatment beds. System actors have said that many judges would release people if services were available in the community, especially for people in need of housing. Existing service providers have made clear that, with funding, they could easily and rapidly expand offerings. It is possible to scale up community resources quickly, as evidenced by the county bringing more than 200 treatment beds online in just a month, to support releases at the onset of the pandemic. We need this same sense of urgency now, and the main barrier is funding. Without it, people with unmet treatment needs will continue to be trapped in jail and have worse reentry outcomes.

The county should immediately increase funding for the Office of Diversion and Reentry (ODR) to allow it to lift the cap on new placements in the ODR Housing program. It should also dedicate more funding to the Department of Health Services (DHS) for Housing for Health—one of the most used programs by people leaving the jail who are vulnerable to homelessness—and to the Department of Public Health – Substance Abuse Prevention and Control (DPH-SAPC) for treatment beds that can be utilized by people with substance use disorders, in order to minimize the chances of recidivism."

Jail My name is Sarah Bowers and I live in County District 2. I am writing to submit written public conditions comments ahead of Friday, November 18th's Civilian Oversight Commission meeting regarding LA County's jail conditions. MCJ desperately needs to be closed down. As a social worker with friends who are therapists and social workers in the jail, I hear about the horrors that are committed there and people who are endlessly stuck there because our county and city systems do not have the infrastructure to treat them as human beings. Grossly enough, our county's jail and prison system is the largest mental health provider in the country and nation, but no one is getting anything near the amount and quality of mental health treatment that they need. People are stuck in MCJ who are in states of psychosis and may have committed what our society describes as "crime" through no conscious fault of their own, but still they are stuck in a cell. This is just the beginning of MCI's horrors. In 2021, 55 people died in LA County jails, in the custody of the Los Angeles Sheriff's Department. As the Sheriff Civilian Oversight Commission, you also have the responsibility to provide oversight of the LASD's management of LA County jails. Many witnesses, like my colleagues who currently work at the jail, have reported that Sheriff deputies working in the jail refer to people as "bodies" instead of people. Furthermore, MCJ and Twin Towers are the home to the LASD gang the "3000 boys." This gang has murdered our community members with impunity, in large part because they mask in-custody murders as deaths from "natural causes."

Simply hearing reports from the County about jail conditions is not enough. I request that this commission take the crisis in LA County jails seriously and commit to a deeper inquiry into why the jail conditions are so horrific, the role of LASD deputy gangs in jail management, and the department's own unwillingness to support the improvement of jail conditions.
