Los Angeles County Holiday Events at the Music Center: Annual Tree Lighting Ceremony and Annual Holiday Celebration - Parking Waiver

For decades, the County of Los Angeles (County) has hosted the Annual Tree Lighting Ceremony and the Annual Holiday Celebration at The Music Center in Downtown Los Angeles.

The Annual Tree Lighting Ceremony will be held on November 28, 2022, at 5 p.m. in the Jerry Moss Plaza at The Music Center and will provide the community and County employees with a festive welcome to the holiday season. This ceremony will include live holiday performances by local companies and free hot chocolate. The event will be hosted by a newscaster and be featured by local media. This year will be particularly special given that the 2020 and 2021 events were canceled due to COVID-19 safety protocols.

The Annual Holiday Celebration will be held on December 24, 2022, at 3 p.m. in the Dorothy Chandler Pavilion. The event, in its 63rd year, will reach thousands of live audience members and tens of thousands of at-home viewers. The Annual Holiday Celebration performers represent music, dance, and choral companies from across the County and, in preparation for the show, the performers and crew members are required to attend several rehearsals at The Music Center.

As in the past, parking waivers are requested for both events including the mandatory rehearsals.

I THEREFORE MOVE THAT THE BOARD OF SUPERVISORS:

1. Waive up to \$600 in parking fees for 30 vehicles at \$20 per space in Lot 14 (The Music Center Garage), excluding the cost of liability insurance, to accommodate artists, crew, and VIPs performing and participating in the Annual Tree Lighting Ceremony on Monday, November 28, 2022, from 4 p.m. to 6 p.m.; and

2. Waive the following parking fees for the dates listed below in Lot 14 (The Music Center Garage), and Lot 16, if necessary, excluding the cost of liability insurance, for the Annual Holiday Celebration in the Dorothy Chandler Pavilion:
- a. Waive the \$20 per vehicle parking fee for 50 vehicles for a total of \$1,000, on December 1, 2022;
 - b. Waive the \$9 per vehicle parking fee for 800 vehicles for a total of \$7,200, on December 3, 2022;
 - c. Waive the \$20 per vehicle parking fee for 50 vehicles for a total of \$1,000, on December 9, 2022;
 - d. Waive the \$9 per vehicle parking fee for 50 vehicles per day for a total of \$900, on December 17-18, 2022;
 - e. Waive the \$20 per vehicle parking fee for 200 vehicles per day for a total of \$12,000, on December 19-21, 2022;
 - f. Waive the \$20 per vehicle parking fee for 150 vehicles per day for a total of \$6,000, on December 22-23, 2022;
 - g. Waive the \$9 per vehicle parking fee for the entire Lot 14 (The Music Center Garage) and Lot 16, if necessary, for a total of \$11,700, on December 24, 2022;
 - h. Waive the \$20 per vehicle parking fee for 50 vehicles for a total of \$1,000, on December 26, 2022; and
 - i. Waive the \$20 per vehicle parking fee for 10 vehicles for a total of \$200, on December 27, 2022.
