On August 29, 2018, the Regional Planning Commission voted 4-1 to recommend approval of the project to the Board of Supervisors. The Board hearing has been scheduled for December 11, 2018, and the Board letter was submitted to the Executive Office on November 1. Staff to provide an update on particular topics mentioned in the Board letter and answer any additional project-related questions.
2. **Step by Step Los Angeles County; Pedestrian Plans for Unincorporated Communities** (J. Robertson, J. Armbruster, & R. Marshalian)  
Step by Step LA County provides a countywide framework for pedestrian policies, programs and procedures and includes community specific pedestrian plans with proposed infrastructure projects for four unincorporated communities.
