**AWARD 13 JOB ORDER CONTRACTS
FOR MAINTENANCE, REPAIR, REMODELING, AND REFURBISHMENT
OF COUNTY INFRASTRUCTURE AND FACILITIES
ADOPT AND ADVERTISE VARIOUS SPECIFICATIONS
(ALL DISTRICTS – 3 VOTES)**

SUBJECT

This action is to make necessary environmental findings; approve and adopt two Job Order Contract unit price books, each dated November 2022, from Job Order Contract Consultants: Cannon/Parkin, Inc., and The Gordian Group, Inc.; advertise for bids to be received; approve and authorize the Director of Internal Services Department, or designee, to award and execute 13 separate Job Order Contracts to the lowest responsive and responsible bidders; and approve the issuance of Work Orders.

IT IS RECOMMENDED THAT THE BOARD:

1. Find that the adoption of the two Job Order Contract unit price books from Cannon/Parkin, Inc. and The Gordian Group, Inc., each dated November 2022, approval for advertisement for bids, and the proposed award of Job Order Contracts are not a project under the California Environmental Quality Act, and issuance of Work Orders for projects that have been determined to be exempt from the California Environmental Quality Act are within the scope of the previous exemption findings under the California Environmental Quality Act, for the reasons stated in this letter and in the record of the proposed action.
2. Approve and adopt The SimpleBid Book Job Order Contracting Unit Price Catalog prepared by Cannon/Parkin, Inc., dated November 2022.

3. Approve and adopt the Job Order Contract Construction Task Catalog and Specifications prepared by The Gordian Group, Inc., dated November 2022.
4. Instruct the Executive Officer of the Board to advertise for bids to be received and Internal Services Department to publicly open bids on January 5, 2023, using Cannon/Parkin, Inc.'s SimpleBid Job Order Contract System, for three separate Job Order Contracts (JOC187, EJOC56, and HVACJOC24), in accordance with the Notice Inviting Bids.
5. Instruct the Executive Officer of the Board to advertise for bids to be received and Internal Services Department to publicly open bids on January 5, 2023, using The Gordian Group, Inc.'s Job Order Contract System for ten separate Job Order Contracts (JOC185, JOC186, JOC188, JOC189, AJOC2, EJOC55, LVJOC5, PLUMBJOC11, ROOFJOC18, and HVACJOC23), in accordance with the Notice Inviting Bids.
6. For each of the 13 Job Order Contracts, authorize the Director of Internal Services Department, or designee, to make the determination that a bid is nonresponsive and to reject a bid on that basis; to award to the next lowest responsive and responsible bidder; and to waive inconsequential and non-material deficiencies in bids submitted, in accordance with the bid specifications.
7. Approve and authorize the Director of Internal Services Department, or designee, to award and execute five (5) general and eight (8) specialty Job Order Contract agreements: one (1) asbestos abatement, two (2) electrical, one (1) low voltage, one (1) plumbing, one (1) roofing, and two (2) heating, ventilating, and air conditioning, in the form previously approved by County Counsel, and to establish the effective date following receipt of approved Faithful Performance and Payment for Labor and Materials Bonds and evidence of the required insurance by the contractors. Agreements JOC185, JOC186, JOC187, JOC188, JOC189, AJOC2, EJOC55, EJOC56, LVJOC5, PLUMBJOC11, ROOFJOC18, HVACJOC23, and HVACJOC24 are each for a not-to-exceed amount of \$5.25 million. The aggregate not-to-exceed amount of the 13 Job Order Contracts is \$68,250,000.
8. For each of the 13 Job Order Contracts, authorize the Director of Internal Services Department, or designee, to issue Work Orders for projects that are not subject to the State Public Contract Code, including maintenance work, as applicable, in an amount not-to-exceed \$330,000 per Work Order, subject to the limitation that the aggregate amount of all Work Orders issued under a particular Job Order Contract does not exceed the \$5,250,000 contract amount of the Job Order Contract. For all Work Orders in excess of \$150,000 on projects that are not subject to the State Public Contract Code, the Board will be notified, one week in advance, with a Board memo.

PURPOSE/JUSTIFICATION OF RECOMMENDED ACTION

Approval of the recommended actions will make necessary findings under the California Environmental Quality Act (CEQA); adopt two Job Order Contracts (JOCs) Unit Price Books from JOC Consultants: Cannon/Parkin, Inc. and The Gordian Group, Inc., each dated November 2022; advertise for bids to be received and opened for 13 JOCs; authorize the Director of Internal Services Department (ISD), or

designee, to determine that a bid is nonresponsive and to reject a bid on that basis, including the authority to waive inconsequential and nonmaterial deficiencies, award and execute 13 JOC agreements, and issue corresponding JOC Work Orders for projects that are within the scope of previous findings of exemption under CEQA.

JOC is a competitively procured, flexible, cost-effective unit price contracting method used by ISD to accomplish maintenance, repair, refurbishment, remodeling, and alteration of County infrastructure and facilities without extensive plans and specifications. The State Public Contract Code (PCC) provides that JOCs are annual contracts that may be awarded for repair, refurbishment, remodeling, or other repetitive work but not for new construction. The JOC delivery method reduces administrative requirements and lowers direct construction costs while meeting all Federal, State, and County procurement requirements. The recommended JOCs will augment ISD's ability to effectively maintain, repair (including emergency repairs), refurbish, and remodel County infrastructure and facilities.

The proposed 13 JOCs will be utilized by the Delivery Teams of ISD Operations Services to complete Facility Reinvestment Program (FRP) projects and client department funded capital, maintenance, and renovation projects. For purposes of clarification on the approval processes discussed herein, FRP projects are approved by the Board of Supervisors (Board) by "Cohort", in which multiple projects are recommended for approval within a single Board letter to provide a program view. Client department funded projects are recommended for approval as individual Board letters for individual projects as departments tend to fund them one at a time.

ISD will utilize Board-approved, as-needed consultants for design/engineering services to augment JOC Work Orders. JOCs and in-house crafts (subject to the "Force Account" limits set forth in the State PCC) will be utilized to complete maintenance, repair, refurbishment, remodeling, and alteration projects. ISD will obtain the necessary jurisdictional approvals as required, for the proposed projects.

In addition to the FRP projects, all other work for projects costing less than the statutory "Force Account" limit of \$50,000 will be performed by in-house crafts staff, except in circumstances such as timeline conflicts, capacity, project complexity etc., that would require ISD to use a contractor. Of the 325 FRP projects in Cohorts 1, 2, 3, and 4, ISD is delivering 267. Of the 267 ISD projects in FRP, ISD in-house crafts is currently delivering (in whole or in part) 28 projects, or 3 percent of the projects.

IMPLEMENTATION OF STRATEGIC PLAN GOALS

The recommended actions support the County's Strategic Plan: Goal II – Foster Vibrant and Resilient Communities, Strategy II.1, Drive Economic and Workforce Development in the County, Objective II.1.2, Support Small Business and Social Enterprises; and Goal III - Realize Tomorrow's Government Today, Strategy III.3 - Pursue Operational Effectiveness, Fiscal Responsibility, and Accountability, Objective III.3.2, Manage and Maximize County Assets by investing in public infrastructure, continually assessing our efficiency and effectiveness, maximizing and leveraging our resources, and holding ourselves accountable.

FISCAL IMPACT/FINANCING

Maintenance, repair, refurbishment, remodeling, and alteration work will be funded through the appropriate maintenance, capital, refurbishment, infrastructure or special fund(s) project budgets. For capital projects and refurbishments, no work will be assigned to these JOCs without the prior review and funding verification from the Chief Executive Office (CEO) and the approval of the project budget by the Board. For ISD's infrastructure and maintenance projects, no work will be assigned to these JOCs without the appropriate funding authorization.

FACTS AND PROVISIONS/LEGAL REQUIREMENTS

The Board's Civic Art Policy, last amended on August 4, 2020, is exempt from allocation to the proposed contracts as this action does not approve any specific capital improvement or refurbishment project. Individual projects will be evaluated to determine applicability to Board's Civic Art Policy.

For each of the 13 JOCs, the Director of ISD, or designee, is authorized, under the Los Angeles County Code, Section 2.81.050, and in accordance with the authority provided by PCC sections 20128.5 and 20145, to issue Work Orders for projects that are subject to the PCC, including repair, remodeling and refurbishment work, in an amount not-to-exceed \$330,000 per Work Order, subject to the limitation that the aggregate amount of all Work Orders issued under a particular JOC does not exceed the \$5,250,000 contract amount of the JOC.

ISD will seek advance approval from the Board for all repair, remodeling, refurbishment projects that exceed the delegated authority limits set forth in the County Code and/or the County's fiscal manual.

Approval of the recommended actions will authorize the Director of ISD to issue Work Orders for projects that are not subject to the PCC, including maintenance work, as applicable, in an amount not-to-exceed \$5,250,000 per Work Order, subject to the limitation that the aggregate amount of all Work Orders issued under a particular JOC does not exceed the \$5,250,000 contract amount of the JOC.

Pursuant to Board Motion adopted on October 31, 2017, ISD will provide a Board notification, one week in advance, for all Work Orders more than \$150,000 that are not subject to the State PCC, unless prohibited by law, regulation, or funding source. PCC Section 20128.5 allows an individual JOC to have a single year term and a maximum value of \$5,250,000 per JOC. A 1997 amendment to the State PCC allows annualized increases in the maximum contract value, based on the California Consumer Price Index.

ENVIRONMENTAL DOCUMENTATION

The recommended actions, to adopt the two JOC unit price books from Cannon/Parkin Inc., and The Gordian Group, Inc., advertise for bids, and award of JOCs are not a project under California Public Resources Code section 21065 and are excluded from the definition of a project under Section 15378 (b)(4) and (5) of the State CEQA Guidelines, because they involve the creation of government funding mechanisms or other government fiscal activities which do not involve any commitment to any specific project which may result in a potentially significant physical impact on the environment or are organizational or administrative activities of government which will not result in direct or indirect physical changes in the environment.

Issuance of Work Orders for projects not subject to the State PCC are within the scope of the findings of exemption as determined by your Board on May 28, 2019, December 17, 2019, and October 19, 2021, for FRP projects. The scope of projects includes alterations, renovations, repair, and refurbishment of existing facilities. The approved work was determined to be exempt under Sections 15301 (a),(d), and (l), 15302 (b) and (c), and 15303 of the CEQA Guidelines and Classes 1(c), (d), (h), (i), (j), (l) and(m), 2(a), (b) and (e), and 3 of the County's Environmental Document Reporting Procedures and Guidelines, Appendix G because the projects involved maintenance and repair of existing facilities and structures with negligible or no expansion of existing use; and replacement of existing facilities or components at the same site with facilities of substantially the same purpose and capacity. There has been no change to the work previously found to be exempt since the time of approval.

Upon the Board's approval of the recommended actions, ISD will file a Notice of Exemption with the County Clerk pursuant to section 21152 of the California Public Resources Code and will post the notice to its website in accordance with section 21092.2.

For all other Work Orders to be issued under the 13 JOCs, the work is similarly anticipated to meet the requirements for categorical exemption under CEQA since the proposed work will consist of the repair and building system replacement projects at County buildings and facilities with negligible or no expansion of use and where replacement facilities or components will have the same purpose and capacity.

As Work Orders are proposed under the 13 approved JOCs for work not previously found to be exempt under CEQA, ISD will review each proposed activity and decide whether exemptions apply at the time of the issuance of Work Orders. ISD will return to the Board to recommend CEQA findings and approval of issuance of individual Work Orders for any work which is not exempt, prior to issuance of Work Orders for any such work.

CONTRACTING PROCESS

A JOC Consultant Services Request for Proposals (RFP) was released by Public Works on May 9, 2018. The RFP solicited for a bench of consultants who could implement and provide comprehensive JOC Systems and related consulting services, including related price and unit books for JOC work to the County departments that utilize JOC (i.e., Public Works, Internal Services, Parks and Recreation, etc.), as well as the Los Angeles Community Development Authority. On October 30, 2018, the Board awarded consultant services agreements to The Gordian Group, Inc., Cannon/Parkin, Inc., and JAMB Services, Inc., thus creating a bench of consultants that would provide JOC Systems and related consulting and support services to assist various County departments and the Los Angeles Community Development Authority in administering the JOC Program.

Advertising for bids for the 13 separate JOCs will be in accordance with the County's standard Instruction Sheet for Publishing Legal Advertisements (Enclosure A).

The Executive Officer of the Board will advertise the JOC invitation for bids in various publications throughout the County of Los Angeles, including hyper-local and ethnic media. Additionally, ISD will post the Invitation for Bids on the County's "Doing Business with the County" website and Vendor Self Service (VSS) Portal, as well as on ISD's Facebook, LinkedIn, Instagram, and Twitter.

The recommended JOCs will be solicited on an open-competitive basis and in accordance with applicable Federal, State, and County requirements. The County will award contracts to the lowest responsive and responsible bidder pursuant to the State PCC.

Bidders will be required to submit a set of cost adjustment factors that will be applied to the unit prices for work using the Cannon/Parkin, Inc.'s SimpleBid JOC System for three separate JOCs (JOC187, EJOC56, and HVACJOC24) and using The Gordian Group, Inc.'s JOC System for ten separate JOCs (JOC185, JOC186, JOC188, JOC189, AJOC2, EJOC55, LVJOC5, PLUMBJOC11, ROOFJOC18, and HVACJOC23), with each book dated November 2022. Each unit price book from Cannon/Parkin, Inc. and The Gordian Group, Inc. will be made available to bidders and be on file in the Program & Project Management Division of ISD.

Bids will be determined by calculating a composite factor using a predetermined advertised formula. The lowest responsive and responsible bidder for each JOC will be awarded that JOC. The JOC consultant and their corresponding unit price book dated November 2022 and each of the lowest responsive and responsible bidder's adjustment factors will be incorporated in the awarded JOCs. will be in the form previously reviewed and approved as to form by County Counsel and in compliance with the Chief Executive Office and the Board's requirements.

IMPACT ON CURRENT SERVICES (OR PROJECTS)

The use of these JOCs will expedite the completion of maintenance, repair, refurbishment, remodeling, and alteration of County infrastructure and facilities work managed by ISD. Minor impacts to tenant departments may occur while such work is underway. ISD will coordinate with each of the affected departments and the JOC contractors to phase and schedule the work to minimize disruption to facility operations and to maintain public access to the greatest extent possible.

There is no employee impact. JOCs are intended to augment, but not replace the County workforce, and to ensure our ability to respond to emergent requirements.

SUBJECT

The Internal Services Department is requesting delegated authority for the Director of the Internal Services Department to enter into, operate, maintain agreements, at no cost to County, related to the Countywide Address Management System (CAMS) Program, subject to the review and approval of County Counsel and notification to your Board.

IT IS RECOMMENDED THAT THE BOARD:

1. Approve and authorize the Director of the Internal Services Department to execute agreements, at no cost to County, related to the Countywide Address Management System (CAMS) Program, subject to the review and approval of County Counsel and notification to your Board.

PURPOSE/JUSTIFICATION OF RECOMMENDED ACTION

The Countywide Address Management System (CAMS) Program provides a centralized repository of searchable, authoritative addresses within Los Angeles County. Many county websites use CAMS to offer residents the ability to search for County provided good and services, based on their address. ISD facilitates the CAMS program as a data collaboration program in an informal partnership with the Cities of Los Angeles County, who maintain the authority to assign addresses. ISD intends to negotiate agreements with all 88 cities. As part of the collaboration, and as an effort to formalize the operation, and maintenance of the data partnership with our local partners, ISD requests the ability to enter into no-cost agreements in the form of Memorandums of Understanding (MOU) or Memorandums of Agreement (MOA).

The CAMS Program information is used by Departments to facilitate the social needs of the population of the county, including but not limited to, the areas of health, law enforcement, public safety, rehabilitation, welfare, education, and legal services, as well as accessibility support for the physical, mental, and financial needs of persons with disabilities and older persons by providing location-based identification of County provided services. The operation, and maintenance of the CAMS program, as the authoritative source of aggregated address information within the county, is imperative to the County's operations. The requested agreements will establish arrangements enabling enhanced collaboration between the incorporated cities, other organizations such as red cross, agencies such as metro, and departments. The requested agreements will establish CAMS as the County of Los Angeles official aggregator for civic addresses and will directly support public safety's next generation 9-1-1.

IMPLEMENTATION OF STRATEGIC PLANNING GOALS

The recommended action supports the County's Strategic Plan Goals:
Strategy III.2 - Embrace Digital Government for the Benefit of our Internal Customers and Communities.
Strategy III.3 - Pursue Operational Effectiveness, Fiscal Responsibility, and Accountability.
Strategy III.4 - Engage and Share Information with Our Customers, Communities and Partners.

FISCAL IMPACT/FINANCING

The CAMS program is currently funded by ISD's enterprise GIS (eGIS) Program, which charges for membership and services. Members include County Departments, County-Related Agencies, and County Commissions. eGIS Program improves the delivery of geospatial services to the public, facilitates operational improvements to departments and programs, and improves inter-departmental and inter-agency collaboration.

The CAMS Program is structured to require no additional net County costs.

FACTS AND PROVISIONS/LEGAL REQUIREMENTS

Municipalities within Los Angeles County may have adopted or codified through ordinance, the process of establishing civic addresses within their jurisdiction. If no ordinance exists for a city jurisdiction, and City has contracted with the County Building and Safety services through the Department of Public Works (DPW), then DPW, through the plan review process, in accordance with the procedures established by the California Building Code, will assign civic addresses. Parallel process and inconsistent reporting of address assignments to concerned parties, such as the Public Safety entities and/or the County Assessor, and even the United States Postal Service (USPS), degrades the services provided to residences and businesses. Delegating authority for ISD to maintain a coordinated repository, established by board motion, and providing the ability for ISD to enter into MOU agreements with jurisdictions, can centralize the utilization, dissemination, and communication of authoritative addresses within the County.

IMPACT ON CURRENT SERVICES (OR PROJECTS)

The CAMS Program will positively impact the current services performed by County departments for the more than 10 million residents of Los Angeles County. As implemented, CAMS is currently being utilized by most high priority Board and CEO initiatives including: Anti-Racism, Diversity, and Inclusion (ARDI), Digital Divide, and the Homeless Initiative. Additionally, many County websites offer residents the ability to perform location-based searches to find various goods and services offered in their areas. The ability for the Director of the Internal services Department to enter into agreements with interested parties relating to civic address information will improve services to the public by expanding access to essential services.

CONCLUSION

Upon your Board's approval, the Executive Office, Board of Supervisors, is requested to return one adopted stamped Board Letter to the CEO.

SUBJECT

The Los Angeles County (County) Sheriff's Department (Department) is seeking Board approval and execution of Amendment Number Seven (Amendment) to Sole Source Agreement Number 77870 (Agreement) with Mideo Systems, Inc. (Mideo) for continued maintenance and support services (Services) of the Department's Mideo Forensic Imaging System (System). The Amendment will exercise the first one-year option period from November 29, 2022, through November 28, 2023.

IT IS RECOMMENDED THAT THE BOARD:

1. Approve and instruct the Chair of the Board to sign the attached Amendment to the Agreement with Mideo which will exercise the first one-year option period and extend the term of the Agreement from November 29, 2022, through November 28, 2023.
2. Delegate authority to the Sheriff, or his designee, to execute the remaining three one-year option periods, provided it is in the best interest of the County.

PURPOSE/JUSTIFICATION OF RECOMMENDED ACTION

The Agreement will expire on November 28, 2022, and has four one-year option periods remaining. The Amendment is necessary to ensure that the Department's Scientific Services Bureau's (SSB) System continues to operate efficiently and effectively. The System must be regularly maintained and repaired within a reasonable time when problems are detected. SSB operates one of the largest full-service crime laboratories (Crime Lab) in the United States. The Crime Lab provides forensic support to all law enforcement agencies in the County, except for the Los Angeles Police Department.

The System is comprised of Mideo equipment and Mideo case image management software. Mideo is the sole provider of Services for all Mideo equipment in the United States.

The Department has utilized Mideo's forensic imaging equipment and case image software since 1997. The Services are critical to the operational integrity of SSB and its ability to accurately capture, catalog, and monitor changes made to digital forensic evidence. Mideo's case image management software provides image enhancement necessary to optimize images for analysis and interpretation and is periodically updated to involve service upgrades and resolve potential systemic issues.

Preventive maintenance, major repairs, and the servicing of specialized components for the proprietary Mideo imaging equipment, as well as maintenance and support of Mideo's case image management software, must be performed by Mideo. Mideo does not contract with, authorize, or otherwise certify any third party to provide support and maintenance to their proprietary forensic imaging equipment.

Implementation of Strategic Plan Goals

The recommended action is consistent with the principles of the County's Strategic Plan, Strategy III.3, Pursue Operational Effectiveness, Fiscal Responsibility and Accountability. Specifically, by allowing the Department's SSB to operate effectively and efficiently by providing the continued maintenance and support of Mideo's proprietary forensic imaging equipment.

FISCAL IMPACT/FINANCING

The Amendment includes an annual increase of \$12,107 to option year one, from \$159,303.15 to \$171,410.15 and an additional annual increase of \$12,107 for option years two through four, from \$171,410.15 to \$183,517.15, which will be paid in advance at each Agreement Term Year. The Maximum Contract Sum will increase by \$84,749,

from \$2,226,237 to \$2,310,986. The funding required to provide these services will be allocated annually from the Department's operating budget.

FACTS AND PROVISIONS/LEGAL REQUIREMENTS

Mideo is the sole provider of Services for its proprietary equipment in the United States. On May 29, 2007, the Board approved Sole Source Agreement Number 76119 with Mideo to provide maintenance and support for the Department's digital forensic imaging equipment. The Agreement expired on November 28, 2012.

On November 20, 2012, the Board approved the current Sole Source Agreement with Mideo. The Agreement had a three-year term from November 29, 2012, through November 28, 2015, with four additional one-year option periods. The Agreement expired on November 28, 2019.

On June 27, 2019, in accordance with Board Policy 5.100, the Department provided the Board with an advance notification of its intent to enter into an Amendment to extend the Agreement. On October 29, 2019, the Board approved Amendment Number Five to extend the Sole Source Agreement for three years, from November 29, 2019, through November 28, 2022, plus four additional one-year option periods.

On August 14, 2019, the Department released a Request for Information (RFI) Number 689-SH to invite vendors who could provide the County with an operationally proven commercial off-the-shelf enterprise solution for visual evidence documentation, analysis, and storage system; comprised of equipment, case image management software, and integration capabilities with existing database of stored images and the Department's property, evidence, and lab information management system, to submit their responses.

The Department received two responses to the RFI from Mideo and QueTel Corporation. The Department finalized its review of the responses, vendor presentation/demonstration, and concluded that no other vendor was equipped to seamlessly continue the services offered by Mideo. More specifically, the RFI responses confirmed that no other System supports on-image documentation, image overlay, and chain of custody functionality required by the Crime Lab.

The purchase cost, application development costs, hardware, software licensing, and other miscellaneous costs associated with a new untested forensic imaging platform far exceed the annual cost for continued maintenance and support from Mideo. A new vendor would require extensive downtime to become acclimated to the needs of the Department, implement the required customizations, and migrate data from Mideo's CaseWorks software. In addition, the laboratory personnel would require training to navigate a new system, which would create a disruption in Services.

The Agreement requires Mideo to be in compliance with all Board and Chief Executive Office requirements.

In compliance with Board Policy 6.020, Chief Information Office Board Letter Approval, the Office of the Chief Information Officer (OCIO) reviewed the information technology (IT) components (management, design, development, acquisition, expansion, or purchase of IT systems and/or related services) of this request and recommends approval. The OCIO determined this recommended action(s) does not include any new IT items that would necessitate a formal written CIO Analysis.

The Amendment has been reviewed and approved as to form by County Counsel.

IMPACT ON CURRENT SERVICES

Approval will ensure continued Services and uninterrupted operation of the forensic imaging equipment utilized by the Department's SSB.

MAINTENANCE AND SUPPORT SERVICES**

This Amendment Number Seven to Agreement Number 77870 (Agreement) is entered into by and between the County of Los Angeles (County) and Mideo Systems, Inc. (Contractor), effective upon execution by the County Board of Supervisors.

- A. WHEREAS, on November 20, 2012, County and Contractor entered into the Agreement to provide forensic imaging system maintenance and support services for the Los Angeles County Sheriff's Department (Department); and
- B. WHEREAS, the Agreement had an initial term of three years, from November 29, 2012, through November 28, 2015, with four additional one-year option periods; and
- C. WHEREAS, on May 8, 2015, County and Contractor entered into Amendment Number One to the Agreement to (1) to exercise the first one-year option period and extend the Term of the Agreement from November 29, 2015, through November 28, 2016, (2) revise the County-mandated provision regarding Consideration of Hiring GAIN/GROW Participants, (3) add the County-mandated provision regarding Time Off for Voting, (4) revise Exhibit L (Attestation of Willingness to Consider GAIN/GROW Participants), and (5) revise Exhibit Q (IRS Notice 1015); and
- D.  - 6.5 Notwithstanding Paragraph 6.3 above, for any deletion or addition of Equipment to Exhibit C (Equipment List and Price Schedule), including software applications and features, of this Agreement, a Change Order shall be executed by County Project Manager and Contractor Project Manager, provided that the total of such increase does not exceed ten percent (10%) of the Maximum Contract Sum.
2. Section 7 (Term) of the Agreement is deleted in its entirety and replaced as follows to extend the Term of the Agreement from November 29, 2022, through and including November 28, 2023:

7. TERM

- 7.1 The Term of this Agreement shall commence November 29, 2012, and shall terminate on November 28, 2023, unless sooner terminated or extended, in whole or in part, as provided in the Agreement.
- 7.2 The County has the option, at the Sheriff's discretion, to extend the Term of the Agreement for up to three additional one-year periods. Each such extension option shall be in the form of a written Amendment executed by Sheriff and Contractor.
- 7.3 The County maintains databases that track/monitor contractor performance history. Information entered into such databases may be used for a variety of purposes, including determining whether the County will exercise a contract term extension option.
- 7.4 Contractor shall notify the Department when the Agreement is within six months from the expiration of the Term of the Agreement as provided for hereinabove. Upon occurrence of this event, Contractor shall send written notification to the County Project Director at the address provided in Subparagraph 3.1.1 of this Agreement.

65.0 COMPLIANCE WITH FAIR CHANCE EMPLOYMENT HIRING PRACTICES

Contractor, and its subcontractors, must comply with fair chance employment hiring practices set forth in California Government Code Section 12952. Contractor's violation of this Section 65.0 (Compliance with Fair Chance Employment Hiring Practices) of the Agreement may constitute a material breach of the Agreement. In the event of such material breach, County may, in its sole discretion, terminate the Agreement.

5. Exhibit C (Equipment List and Price Schedule) of the Agreement is deleted in its entirety and replaced with the revised Exhibit C (Equipment List and Price Schedule), attached hereto, to add an additional \$12,107 to Option Year 1 (from \$159,303.15 to 171,410.15) and \$24,214 to each year for Option Years 2-4 (from \$159,303.15 to 183,517.15).
6. Except as expressly provided in this Amendment Number Seven, all other provisions, terms, and conditions of the Agreement shall remain the same and in full force and effect.
7. Contractor represents and warrants that the person executing this Amendment Number Seven for Contractor is an authorized agent who has actual authority to bind Contractor to each and every item, condition, and obligation of this Amendment Number Seven and that all requirements of Contractor have been fulfilled to provide such actual authority.

PURPOSE/JUSTIFICATION OF RECOMMENDED ACTION

Consistent with your Board's policy directives on September 10, 2019 and November 19, 2019, related to the establishment of a rent stabilization program, and based on additional directives from your Board motion of September 27, 2022, Strengthening the County's Permanent Protections for Unincorporated Los Angeles County in Response to Lessons Learned during the COVID-19 Crisis¹, departmental review and stakeholder testimony and feedback, the Department of Consumer and Business Affairs (DCBA or Department) recommends adopting amendments and clarifying provisions to the RSTPO and MRSMOPO (collectively, Ordinances). The changes are intended to (1) incorporate additional protections as directed by your Board, (2) clarify the rights and responsibilities of property owners, park owners, tenants and mobilehome owners, and (3) standardize procedures contained in the ordinances. Recommended changes are detailed below.

FISCAL IMPACT/FINANCING

The adoption of these proposed amendments will have no net County cost impact on the General Fund.

FACTS AND PROVISIONS/LEGAL REQUIREMENTS

Recommended Amendments to Chapter 8.52 - Rent Stabilization & Tenant Protections Ordinance and Chapter 8.57 - Mobilehome Rent Stabilization Ordinance

As directed by your Board motion of September 27, 2022, Strengthening the County's Permanent Protections for Unincorporated Los Angeles County in Response to Lessons Learned during the COVID-19 Crisis. The following changes are being recommended to the RSTPO & MRSMOPO:

1. Add language to, for the period of January 1, 2023 through December 31, 2023, impose a temporary cap on the maximum allowable Rent increase for Fully Covered Rental Units at three percent (3%) annually, unless otherwise permitted by Department (LACC Section 8.52.050).
2. Revise, at the directive of your Board, section related to At-Fault reason "Failure to Pay Rent" to read "Failure to Pay Rent Exceeding Monetary Threshold" and ADD language to state that a tenant may only be evicted for nonpayment of Rent if the Tenant's total rental debt owed exceeds a monetary threshold amount equal

to one month of fair market rent (FMR) for the Los Angeles-Long Beach-Glendale, CA U.S Department of Housing and Urban Development (HUD) Metro FMR area that any notice of termination related to nonpayment under this chapter shall state the number of bedrooms, and additional requirements to be outlined in its procedures and guidelines (LACC Section 8.52.090).

In addition, DCBA recommends adopting the attached amendments and clarifying provisions to the RSTPO and MRSMOPO (collectively, Ordinances). The changes are intended to (1) incorporate additional protections as directed by your Board, (2) clarify the rights and responsibilities of property owners, park owners, tenants and mobilehome owners, and (3) standardize procedures contained in the ordinances.

IMPACT ON CURRENT SERVICES (OR PROJECTS)

The adoption of these proposed amendments will have no impact on current services or projects and will better facilitate the County's ability to implement the Ordinances.

DCBA requests that the Executive Officer, upon approval by the Board, return one adopted-stamped copy of this letter to the Director of DCBA.
