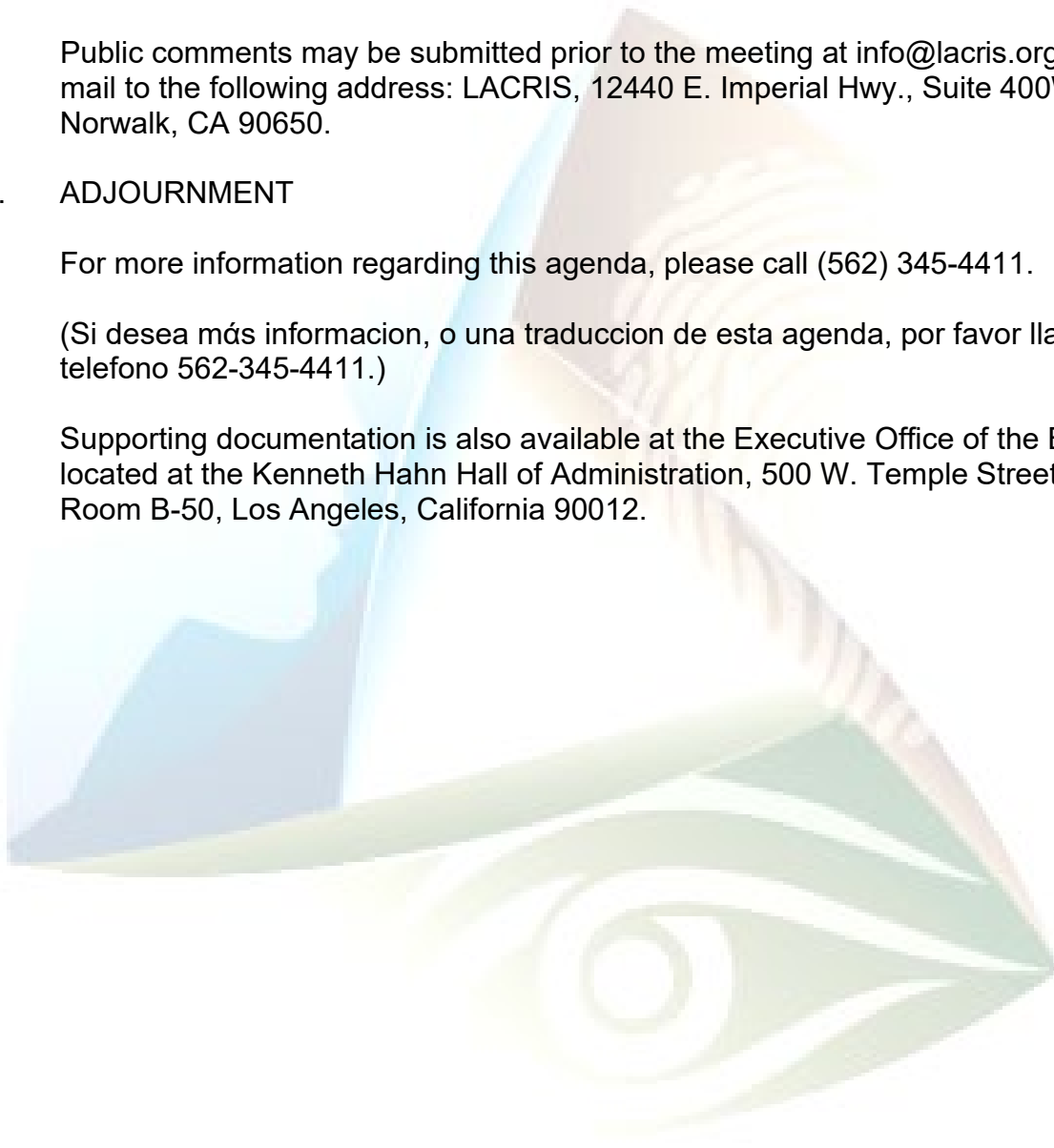

**I. CONVENE**

The July 28, 2022, meeting of the Local Cal-ID RAN Board was called to order by Kassandra Angel at 2:04 p.m.

**III. REPORT ON THE TECHNICAL SUBCOMMITTEE**

Lieutenant Derek Sabatini reported on the tasks assigned to the Technical Subcommittee on May 26, 2022.

1. Report on the Status of the LiveScan Network, Installations, and Enhancements

During this period, there were no installs conducted nor any significant incidents to report.

2. Report on the Status of LAFIS

From May 1, 2022, through June 30, 2022, various LACRIS systems were inoperable and experienced unscheduled downtime for approximately sixty-six (66) hours and fifty (50) minutes.

5. Steering Committee

The last Technical Subcommittee meeting was held on May 11, 2022. There have been no subsequent Tech Sub meetings. The RAN Board was briefed at the May 26, 2022, meeting. The need for Fuming Chambers at various agencies was discussed, and it was agreed that a request would be made to the RAN Board at the next meeting.

6. General Updates

PAC-50 Upgrade: El Segundo Police Department is the only agency left to complete in the PAC50 project. All project agency locations have been upgraded to the 10 mbps connection with Spectrum.

LACRIS Relocation Update: Miguel Covarrubias from the Chief Executive Office's Real Estate Division presented an update on the status of the LACRIS lease. He obtained a signed letter of intent from the building landlord. The low voltage cost will be confirmed with Internal Services Department. The lease will be drafted in the very near future. He anticipates The Board of Supervisor's approval to be complete by late September or early October 2022. Once approval is obtained, the construction process will begin.

A. Authorization to Purchase Foster Freeman Fuming Chambers

Allen Brogden from the Glendale Police Department, Verdugo Crime Lab presented this item. LACRIS is requesting approval to fund the purchase of eighteen (18) Foster Freeman fuming chambers of various sizes, including all hardware, software, support, and maintenance required for five (5) years (Solution). The cost of the fuming chambers is approximately \$490,000 for five (5) years

B. Approval of the Los Angeles County Regional Identification System Facial Recognition Policy

Sergeant John Denney presented this item. LACRIS is seeking RAN Board approval of the LACRIS Facial Recognition Policy which has been in place since May 2, 2019. The provided LACRIS Facial Recognition Policy once approved will memorialize the procedures for LACRIS personnel, law enforcement agencies, and their personnel while using the LACRIS Facial Recognition System.
