REQUEST TO APPROVE AN EXTENSION TO THE CURRENT SOLE SOURCE CONTRACTS FOR THE LESBIAN, GAY, BISEXUAL, TRANSGENDER, AND QUEER+ TAILORED SERVICES TO YOUTH (ALL SUPERVISORIAL DISTRICTS) (3 VOTES)

<u>SUBJECT</u>

The Department of Children and Family Services (DCFS) requests your Board's approval to extend the existing contracts for Lesbian, Gay, Bisexual, Transgender, and Queer+ (LGBTQ+) Tailored Services to Youth.

IT IS RECOMMENDED THAT THE BOARD:

- 1. Delegate authority to the Director of DCFS, or designee, to execute amendments substantially similar to Attachment A, with the Community-Based Organizations (CBO) identified in Attachment B, to provide LGBTQ+ Tailored Services to Youth in eight Service Planning Areas (SPAs). The term of the contracts will be effective March 1, 2024 through February 28, 2025. The Maximum Contract Sum of each contract will be \$250,000 for each SPA serviced, with a total of eight SPAs, for a maximum annual program budget of \$2,000,000, financed by 100 percent net County cost (NCC). The Board and the Chief Executive Officer (CEO) will be notified, in writing, within ten business days after execution of the contracts.
- 2. Delegate authority to the Director of DCFS, or designee, to amend contracts to expand services into an adjacent SPA. The total of all Maximum Annual Contract Sums shall not exceed \$2,000,000. Approval of County Counsel will be obtained prior to the execution of the contract, and the Director, or designee, will notify the Board and the CEO, in writing, within ten business days after execution.

- 3. Delegate authority to the Director of DCFS, or designee, to execute amendments to make changes to the contract terms and conditions; or to increase or decrease the Maximum Annual Contract Sums up to twenty percent if either of these is necessary to meet program needs. The approval of County Counsel will be obtained prior to the execution of such amendments and the Director, or designee, will notify the Board and the CEO, in writing, within ten business days after execution.
- 4. Delegate authority to the Director of DCFS, or designee, to terminate the contracts for convenience or default. The approval of County Counsel will be obtained prior to terminating the contract and the Director, or designee, will notify the Board and the CEO, in writing, within ten business days after such termination.

PURPOSE/JUSTIFICATION OF RECOMMENDED ACTION

The contracted services address the myriad of concerns affecting LGBTQ+ youth by promoting positive health, safety, permanency, and well-being outcomes. These services focus on building affirming behaviors in parent(s), caretaker(s), and legal guardian(s) in order to support healthy family reunification, promote safety, and post-reunification stability.

This multi-faceted, targeted, holistic, and affirming approach has the potential of saving countless lives, reducing self-harming behaviors, and promoting the full experience and essence of LGBTQ+ youth. Without these services being available to these youth, each LGBTQ+ youth will continue to live their life without the proper support they deserve to thrive throughout their adolescent and adult life. Through these services, the Department is able to establish valuable data that will further support program development of services, establishment of new resources, and help develop new approaches to better serve the youth.

In order to ensure that LGBTQ+ youth, young adults and their support systems continue receiving affirming services, an additional one-year extension of the LGBTQ+ Tailored Services to Youth contract is necessary, which will allow for the continued Request for Proposals (RFP) solicitation that was initiated on October 19, 2023. The RFP is currently underway and new scheduled have start contracts are to а March 1, 2025. Both the one-year extension and new solicitation will ensure that LGBTQ+ youth and young adults have the option of participating in services as their full and authentic selves, without the worry, judgement and discrimination of their sexual orientation, gender and gender expression. By doing so, we intend to create opportunities and an expectation that LGBTQ+ youth and young adults in the child welfare system are safe, experience improved well-being and thrive.

IMPLEMENTATION OF STRATEGIC PLAN GOALS

The recommended services support the County's Strategic Plan Goal I., Make Investments That Transform Lives; Strategy I.1, Increase Our Focus on Prevention Initiatives, by redirecting federal funds to provide services to keep children safely with their families and out of foster care, and when foster care is needed allows federal reimbursement for care in family-based settings and certain residential treatment programs for children with emotional and behavioral disturbance requiring special treatment.

FISCAL IMPACT/FINANCING

The Maximum Contract Budget will be \$2,000,000, financed using 100 percent NCC funds, for the term of March 1, 2024, through February 28, 2025.

FACTS AND PROVISIONS/LEGAL REQUIREMENTS

The Board Letter adopted on February 15, 2022, gave delegated authority to the Director of DCFS to execute contracts for LGBTQ+ Tailored Services to Youth, for a one-year term and one additional year extension. Subsequently, contracts with the CBOs identified in Attachment B were executed on March 1, 2022, for a contract term of one year with one optional year extension through February 29, 2024.

On February 14, 2023, DCFS notified the Board of the execution of Amendments Number 1 and 2 to extend the term of the contracts from March 1, 2023 to February 29, 2024.

The Board Letter was reviewed by County Counsel and CEO. County Counsel approved the Amendment (Attachment A), as to form. The Sole Source Checklist (Attachment C) has been approved by CEO.

CONTRACTING PROCESS

On January 2, 2024, DCFS sent a Notice of Intent (Attachment D) to the Board to inform them of its intent to extend the current Sole Source Contracts for LGBTQ+ Tailored Services to Youth.

On October 19, 2023, DCFS released the LGBTQIA2S+ Tailored Services RFP to solicit proposals for tailored services to LGBTQIA2S+ youth. The proposals were due on December 27, 2023 and the new contracts are expected to be executed effective March 1, 2025.

IMPACT ON CURRENT SERVICES (OR PROJECTS)

Approval of the current recommendations will allow the Department to: 1) receive uninterrupted LGBTQ+ Tailored Services to underserved LGBTQ+ youth; 2) improve outcomes for LGBTQ+ children and youth in care by connecting them to affirming services; 3) provide support aimed at achieving well-being and safety; 4) address the negative outcomes; and 5) provide qualified child welfare services to the children of the County of Los Angeles.

WHEREAS, COUNTY and CONTRACTOR are parties to this Contract adopted by the Board on February 15, 2022, and executed by all parties on March 1, 2022;

WHEREAS, Amendment No. One expanded the services to SPA 3 and SPA 5 and allocated additional funding to increase services for LGBTQ+ Youth;

WHEREAS, Amendment No. Two was to extend the contract term effective March 1, 2023 to February 29, 2024, and to update the Statement of Work (SOW), and the contract Terms and Conditions;

WHEREAS, Amendment No. Three is to extend the contract term effective March 1, 2024 to February 28, 2025;

WHEREAS, this Amendment is prepared and executed by COUNTY and CONTRACTOR as set forth in the Contract Part I, UNIQUE TERMS AND CONDITIONS, SECTION 10.0, CHANGES AND AMENDMENTS; and

NOW, THEREFORE, COUNTY and CONTRACTOR mutually agree to the following changes to the Contract:

- 1. CONTRACT, PART I, UNIQUE TERMS AND CONDITIONS, SECTION 2.0 TERM, Subsection 2.1.2 is added to read as follows:
 - 2.1.2 The term of this Contract is extended effective March 1, 2024 to February 28, 2025, unless terminated earlier or extended, in whole or in part as provided in this contract.
- 2. CONTRACT, PART I, UNIQUE TERMS AND CONDITIONS, SECTION 3.0, CONTRACT SUM, Subsection 3.1.2 is added to read as follows:

SOLE SOURCE JUSTIFICATION

It is the policy of the County to solicit the maximum number of bids/proposals for a commodity or service from the largest relevant market and to select vendors on a competitive basis.

There are certain acquisitions which, when in the best interest of the County, can only be obtained from a sole source. Sole source acquisitions <u>must</u> be justified in sufficient detail to explain the basis for suspending the usual competitive procurement process.

DOCUMENTATION FOR SOLE SOURCE JUSTIFICATION MUST INCLUDE RESPONSES TO THE FOLLOWING QUESTIONS WHEN APPLICABLE:

1. What is being requested?

2.

Why is the product needed – how will it be used?

The Department of Children and Family Services (DCFS) requests approval from the Board of Supervisors (Board) to extend four Sole Source Contracts for LGBTQ+ Tailored to Youth Services with the following four agencies: (1) Penny Lane Centers; (2) The Help Group; (3) Los Angeles LGBT Center; (4) One in Long Beach (Doing Business As - The LGBTQ Center Long Beach).

LGBTQ+ foster youth experience the highest levels of rejection by their birth families, along with alarmingly high rates of depression, mental health concerns, substance use and abuse, homelessness, joblessness, sexually transmitted infections, victimization, partner abuse, suicide, and attempted suicide. Prior to the current contracts, the County lacked comprehensive services tailored to the needs of this most vulnerable population of foster youth. With these dismal outcomes in mind, it is imperative that DCFS put in place services aimed at meeting the needs of this population and ensure that current foster youth and young adults in care benefit from affirming services, supports, and placements. The services outlined in the Statement of Work for this project have been shown to improve outcomes for LGBTQ+ youth and young adults.

Pursuing Sole Source Contracts was deemed the most efficient pathway for implementing immediate services to address the needs of LGBTQ+ youth in care. Four agencies were selected based on their responses from the Statement of Interest to the Request for Statement of Interest released on November 12, 2021. The four recommended agencies demonstrated an ability to serve all LGBTQ+ youth and young adults within the Service Planning Area (SPA) selected by each agency.

Each agency provides services to LGBTQ+ children, youth, young adults, caregivers, legal guardians, and families, in the SPAs they have elected pursuant to the requirements of the Statement of Work (SOW) for this contract. The \$2,000,000 cost of this Demonstration Project will be fully funded by one-hundred percent (100%) net County cost (NCC) from the approved \$3.6M set aside to address the service gaps and unmet needs of LGBTQ+ children, youth, and young adults in care. The term of this extended Demonstration Project is for a period of twelve (12) months, beginning March 1, 2024, through February 28, 2025.

3. Is this "brand" of product the only one that meets the user's requirements?

DCFS designed this Demonstration Project consisting of four individual contracts to address the unmet needs of this most vulnerable population of foster youth. The affirming services and supports outlined in the Statement of Work for this Demonstration Project have been shown to be effective in promoting child safety and positive outcomes for current and former LGBTQ+ youth. Affirming services have also been shown to promote child and family well-being, permanency, help parents develop affirming skills that lead them to embrace and affirm their child(ren)'s identity, thereby reducing the likelihood of abuse of LGBTQ+ children and youth.

4. Have other product/vendors been considered?

Yes. When the Request for Statement of Interest (RFSI) was widely distributed on November 12, 2021, multiple vendors expressed interest and responded to the RFSI by way of a Statement of Interest (SOI). Fifteen agencies submitted SOIs by the RFSI deadline. Each agency was individually assessed, but not all agencies met the minimum requirements. Given the immediate needs of this vulnerable youth population, DCFS recommended only those agencies who met the minimum requirements and demonstrated an ability to provide affirming services for LGBTQ+ children, youth, young adults, and families.

5. Will purchase of this product avoid other cost?

Yes. Purchasing these tailored services will allow the County to immediately address the needs of LGBTQ+ children, youth, and young adults. Addressing the needs of LGBTQ+ youth, especially those are in crisis, promotes healthy development in LGBTQ+ youth, along with placement stability and permanency while avoiding avoids costs associated with higher levels of care. Purchasing these services will also help County avoid the cost of human life resulting from self-harm, suicide, and attempted suicide.

6. Is this product proprietary or is it available from various dealers?

Yes, the service is available from various providers. However, not all providers who expressed interest met the minimum requirements or demonstrated an ability to immediately address the needs of all LGBTQ+ children, youth, young adults, and families in their elective SPA.

7. Reasonableness of Price. Does the County obtain a percentage discount or special discount not available to the private sector?

Under this Demonstration Project, the County will not be receiving a discount that is not available to the private sector. The price of \$2,000,000 for twelve (12) months is below that of prior estimates for the same work.

8. What is the dollar value of existing equipment and the Purchase Order No. for the existing equipment?

This question is not applicable to this request as each recommended agency is responsible for providing a physical space, electronic equipment, supplies, etc., at its own cost. County will not be providing or covering the cost of equipment.

In compliance with Board Policy 5.100, Sole Source Contracts, this is to notify the Board that the Department of Children and Family Services (DCFS) intends to amend the Lesbian, Gay, Bisexual, Transgender, and Queer+ (LGBTQ+) Sole Source Contracts for Tailored Services to Youth with four of the current contractors: the Los Angeles LGBT Center (Contract Number 22-04-004), Penny Lane Centers (Contract Number 22-04-005); One In Long Beach (Contract Number 22-04-006); and the Help Group (Contract Number 22-04-007).

The Board letter adopted on February 15, 2022, delegated authority to the Director of DCFS, to enter into Sole Source Contracts with qualified Community-Based Organizations for a one-year term effective March 1, 2022 through February 28, 2023, with an option to extend for an additional twelve months to complete the demonstration project and to complete a solicitation for replacement contracts. The current contracts will expire on February 29, 2024. DCFS intends to amend the four aforementioned contracts to extend the term through February 28, 2025, to complete a Request for Proposals solicitation and execute new contracts effective March 1, 2025.

What is the Work?

- A medical model approach to Substance Use Disorder (SUD) for system-involved youth in LA County
- Partners at DHS, DCFS, DPH-SAPC, OCP, DMH received a state grant to increase access to Medication for Addiction Treatment (MAT) for system-involved youth
 - Strengthen training, screening, outreach, and treatment
 - Incorporate youth voice
 - Institutionalize an inter-agency service approach

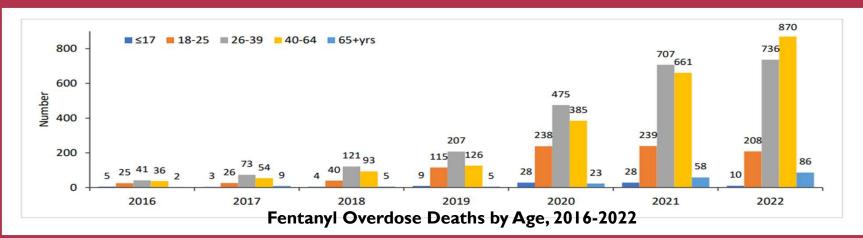
IMPORTANCE OF YOUTH OPIOID RESPONSE

Overdose Crisis

- Fentanyl overdose deaths among youth ages 10-19 in LA County increased by over 50% from 2019 to 2020
 LA County DPH 2022
- Fentanyl Overdose Deaths among youth ages 25 and under in LA County in 2022 was 218 – LA County DPH Fentanyl Mortality Report, 11/23

Substance Use

- There are currently over 13,000 youth ages 12-17 classified with an opioid use disorder in LA County – SAMHSA 2017
- Over 60% of adolescents receiving treatment for opioid addiction in LA County reported initiating use with prescription opioids – UCLA 2021

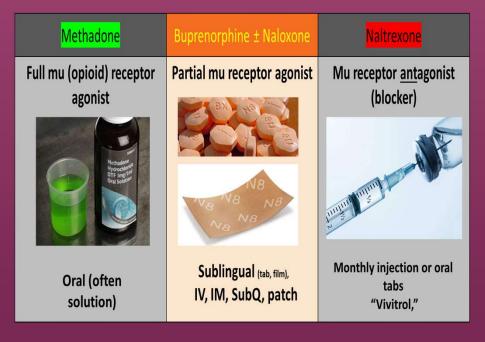

Medications for Opioid Use Disorder



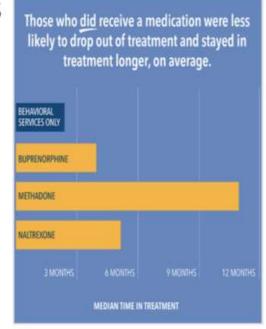
EARLY Interventions: Lack of Timely

BEHAVIORAL TREATMENT

- Combining MAT and behavioral health treatment: counseling, treatment of psychiatric disorders, behavioral modification, and referrals to community-based services results in reduced overdoses and substance use Source: SAMHSA Einstein Expert Panel
- The American Academy of Pediatrics recommends MAT with "developmentally appropriate substance use disorder counseling in community settings." Source: AAP Committee on Substance Use and Prevention, Policy Statement, Sept. 2016.
- Demonstrated to help adolescents reduce or stop drug use and to improve problems in other areas, such as employment, school attendance, family relationships, conduct problems, and depression. NIDA 2019

MENTORING AND PEER SUPPORT

- "Peer-based activities that engage, educate, and support youth to make the changes they want to make to reduce or stop their substance use is effective in combination with MAT" Journal of Adolescent Health, 2016
- Formal and natural mentoring showed improved prevention and reduced substance use among high-risk youth- DOJ, 2020

TRAINING AND HARM REDUCTION

- Created accessible training videos and materials
- Have begun providing training to:
 - 82 probation staff and 60 youth
 - DCFS staff, STRTP staff, and resource families
- Working with LAUSD on youth-led campaign and interventions

CURRENT YOR ACTIVITIES & ACCOMPLISHMENTS

MAT SERVICES AND TRAINING

- 135 new youth getting MAT for opioid use
- 246 new youth getting MAT for stimulant and cocaine use
- 80 new youth receiving case management services
- 115 youth receiving outpatient treatment/counseling services
- Trained 280 clinicians
- Extended Help Line to offer 24-hour coverage
- 1012 people reached through community and prevention education events

HARM REDUCTION CAMPAIGN AND POLICY REVISION

- Initiated campaign that offers training for staff and caregivers; provisions regional offices to distribute Naloxone
- Revised STRTP contracts to require Naloxone training and supplies on site
- Issued new FYI re. Naloxone practices
- Developing a prevention education program with LACOE, to pilot in two short term residential therapeutic programs.

CREATING A MODEL FOR YOUTH ENGAGEMENT



YOUTH SPEAK COLLECTIVE

GOAL

- Empower youth with lived experience to lead SUD prevention campaign
- Leverage youth perspectives to craft campaign messages

STRATEGIES

- Engagement through Participation
- Skill Building Opportunities
- Stipend

GAPS

PREVENTION

- System-involved youth are particularly at risk of SUD
- More prevention efforts are needed that target this population including in school environments
- Combining individual and family-focused therapy is key

PATHWAYS TO TREATMENT

- SUD screening is not consistent
- Not enough primary care providers are advocating for MAT for their youth clients
- Need to strengthen ties between referrals and services

HARM REDUCTION

- Training is not mandatory in all Departments
 - E.g., only 200 of 9,000 DCFS staff have been trained
- Naloxone is not readily accessible to youth
 - E.g., supplies are locked in staff offices

MAT

- Overcoming provider biases
- Not enough experienced MAT providers
- Providers need be comfortable with initiating MAT even if not specialized MAT providers
- Limited knowledge of this option among youth
