





Pathway Home Data Dashboard

Following the completion of a Pathway Home encampment resolution, data will be collected, reconciled, and posted online. Please allow between 72-96 hours following the completion of an encampment resolution for updates to occur. These data are current as of 1/24/24. Data on Individuals Permanently Housed is updated quarterly and are current as of 12/19/23. Pathway Home formally launched on August 9, 2023.

This Pathway Home dashboard excludes data from our encampment resolution partnership with the City of Los Angeles.

- All tenants use **Time-Limited Subsidies** (TLS)
- LAHSA **master leases** entire building with HHIP funding



Eviction Prevention

PREVENTION AND PROMOTION SYSTEMS GOVERNING COMMITTEE

- Initial key focus areas/domains include:
 - (1) Child Welfare and Family Wellbeing
 - (2) Behavioral Health
 - (3) Homelessness and Housing
- Initial focus on scaling up a **countywide comprehensive eviction defense program** leveraging the mainstream and homeless response systems
- Robust **community engagement and outreach plan** to ensure inclusion of multi-sectoral collaboration and lived expertise using an equity lens

The Committee will host listening sessions in February with diverse community stakeholders to gain insights on:

- Potential population-level outcome(s) longer term
- Pressing prevention-focused issue(s) that would benefit from shorter-term targeted, cross-departmental, and cross-sector coordination and investment.

The **Homeless Initiative** is the central coordinating body for Los Angeles County's effort to expand and enhance services for people experiencing homelessness or at risk of losing their home. It administers **Measure H** and other funding to provide **outreach** to people living on the streets; **interim housing**, such as temporary shelters; **permanent housing** such as subsidized apartments; and links to **supportive services**, such as healthcare, mental health care, substance use disorder treatment, job training and employment. It also offers **homeless prevention** services, and works to increase the supply of **affordable housing**. The Homeless Initiative is currently overseeing the County's urgent response to the **homelessness emergency**, which includes the **Pathway Home** encampment resolution program.
