SUBJECT

This action is to adopt the Negotiated Property Tax Exchange Joint Resolutions associated with the annexation of territories into County Sanitation Districts Nos. 14, 21, 22, and the Santa Clarita Valley Sanitation Districts of Los Angeles County.

IT IS RECOMMENDED THAT THE BOARD:

1. Approve and adopt Joint Resolutions between the Board of Supervisors (Board), as the governing body of the County of Los Angeles (County), the Consolidated Fire Protection District, and the County Flood Control District, and on behalf of the LA County Library, County Waterworks No. 36, County Waterworks No. 40, Road District No. 4, Road District No. 5, and Lighting Maintenance District No. 1687; County Sanitation Districts Nos. 14, 21, 22, and the Santa Clarita Valley Sanitation Districts of the County; and other affected taxing entities based on the negotiated exchange of property tax revenue related to proposed Annexation Nos. 14-437 and 14-446 in the City of Lancaster; 21-771 in the City of La Verne; 21-772 in unincorporated Rowland Heights; 22-439 in the

City of Bradbury; 22-444 in the City of Covina; SCV-1113, SCV-1121, SVC-1123, SVC-1125, SVC-1126, SVC-1127 and SVC-1128 in the City of Santa Clarita; and SCV-1122 and SCV-1129 in unincorporated Santa Clarita Valley.

2. Find that the proposed Joint Resolutions are not subject to the provisions of the California Environmental Quality Act (CEQA) because the action does not meet the definition of a project for the reasons stated herein and the reasons reflected in the record.

PURPOSE/JUSTIFICATION OF RECOMMENDED ACTION

The governing bodies of the affected County Sanitation Districts (Districts) and the respective taxing entities have adopted the attached Joint Resolutions (Enclosure) based on the negotiated exchange of property tax revenue related to the proposed annexations to the Districts.

In order for the Local Agency Formation Commission (LAFCO) for the County to proceed with the required hearings on the proposed annexations, the Board, as the governing body of the County, Consolidated Fire Protection District, and the County Flood Control District, and on behalf of the LA County Library, County Waterworks No. 36, County Waterworks No. 40, Road District No. 4, Road District No. 5, and Lighting Maintenance District No. 1687, must also adopt the attached Joint Resolutions.

The proposed annexations involve residential, vacant, and commercial parcels for which there is no other local agency able to provide off-site sewage disposal services. The annexations will allow property owners in the affected territories to obtain off-site sewage disposal service from the Districts by connecting their properties to existing sewer lines. Currently, the only option available to property owners is to construct private septic systems. In each annexation application submitted to LAFCO, all the owners of real properties within the affected territories have requested, in writing, that their properties be annexed to the respective County Sanitation Districts.

FISCAL IMPACT/FINANCING

There is no base transfer of property taxes associated with these annexations. If the annexations are approved, the adopted joint resolutions will transfer a portion of the annual property tax growth attributable to the annexation areas from the County, Consolidated Fire Protection District, County Flood Control District, and the other affected taxing entities to the affected Districts. The impact of the annexations to the County's share of incremental property tax growth for future years due to the proposed annexations is minimal and is reflected in the Enclosure.

FACTS AND PROVISIONS/LEGAL REQUIREMENTS

Pursuant to Part 3, Division 3, Title 5 of the California Government Code, commencing with Section 56000, the Districts adopted resolutions and filed applications with LAFCO to initiate proceedings for the reorganization of territory to the Districts. Section 99 of the Revenue and Taxation Code (R&T Code) requires that prior to the effective date of any jurisdictional change, the governing bodies of all agencies whose service area, or service responsibilities will be altered by such change, must negotiate a reallocation of property tax revenue between the affected agencies, and approve and accept such reallocation by resolution. The Districts and the other independent taxing entities have adopted the negotiated Joint Resolutions for the subject reorganization, as required by section 99 of the R&T Code.

Adoption of the Joint Resolutions by the Board will allow LAFCO to schedule the required public hearings to consider testimony on the proposed reorganization. LAFCO will subsequently take action to approve, approve with changes, or disapprove the proposal for reorganization.

The Joint Resolutions have been approved as to form by County Counsel.

ENVIRONMENTAL DOCUMENTATION

The proposed project is not a project pursuant to the CEQA, because it is an activity that is excluded from the definition of a project by section 15378(b) of the State CEQA Guidelines. This proposed action is the creation of a government funding mechanism, a fiscal activity which does not involve any commitment to any specific project, which may result in a potentially significant physical impact on the environment.

IMPACT ON CURRENT SERVICES (OR PROJECTS)

The proposed action has no impact on current County services or projects.

SUBJECT

Public Works is seeking Board approval to adopt plans and specifications, advertise for construction bids, and award and execute a construction contract for the Malibu Canyon Road North of Mile Marker 2.32 - Guardrail Project in the unincorporated County area north of the City of Malibu.

IT IS RECOMMENDED THAT THE BOARD:

1. Find that the proposed project is exempt from the provisions of the California Environmental Quality Act, for the reasons stated in this Board letter and in the record of the project.

- 2. Approve the project and adopt the plans and specifications that are on file with Public Works Project Management Division III for the Malibu Canyon Road North of Mile Marker 2.32 Guardrail Project at an estimated construction contract cost between \$750,000 and \$1,125,000.
- 3. Instruct the Executive Officer of the Board of Supervisors to advertise for bids in accordance with the Instruction Sheet for Publishing Legal Advertisement that are to be received before 11 a.m. on May 14, 2024, in accordance with the Notice Inviting Bids.
- 4. Find pursuant to State Public Contract Code, Section 3400 (c) (1-4), that it is necessary to specify designated items by specific brand name in order to comply with California Department of Transportation authorized materials list for guardrail and to match other products in use on a particular public improvement either completed or in the course of completion.
- 5. Delegate authority to the Director of Public Works or his designee to determine whether the bid of the apparent responsible contractor with the lowest apparent responsive bid is, in fact, responsive and, if not responsive, to determine which apparent responsible contractor submitted the lowest responsive bid.
- 6. Delegate authority to the Director of Public Works or his designee to award and execute a construction contract for the Malibu Canyon Road North of Mile Marker 2.32 Guardrail Project with the responsible contractor with the lowest responsive bid within or less than the estimated cost range of \$750,000 and \$1,125,000, or that exceeds the estimated cost range by no more than 15 percent, if additional and appropriate funds have been identified.
- 7. Delegate to the Director of Public Works or his designee the following authority in connection with this contract: (a) extend the date and time for the receipt of bids consistent with the requirements of State Public Contract Code, Section 4104.5; (b) allow substitution of subcontractors and relief of bidders upon demonstration of the grounds set forth in State Public Contract Code, Sections 4100 et seq. and 5100 et seq., respectively; (c) approve and execute change orders within the same monetary limits delegated to the Director of Public Works or his designee under Section 2.18.050 of the Los Angeles County Code; (d) accept the project upon its final completion; and (e) release retention money withheld consistent with the requirements of State Public Contract Code, Sections 7107 and 9203.

PURPOSE/JUSTIFICATION OF RECOMMENDED ACTION

Approval of the recommended actions will find that the project is exempt from the California Environmental Quality Act (CEQA) and allow Public Works to install new guardrails to improve roadway safety for the users of the roadway.

In prior years, Public Works has worked on numerous guardrail projects to increase public safety. There is a steep embankment along Malibu Canyon Road, and the installation of guardrail may reduce the occurrence of an errant vehicle running off the road and dissipate energy from collisions in some cases. The proposed project will install about 1,240 feet of guardrail on Malibu Canyon Road between Mile Markers 1.86 and 2.32, which is approximately one mile north of Francisco Ranch Road (see Enclosure A).

The work is anticipated to start in August 2024 and be completed by January 2025.

Implementation of Strategic Plan Goals

These recommendations support the County Strategic Plan: Strategy II.2, Support the Wellness of our Communities, Objective II.2.2, Expand Access to Recreational and Cultural Opportunities, and Objective II.2.4, Promote Active and Healthy Lifestyles; and Strategy III.3, Pursue Operational Effectiveness, Fiscal Responsibility, and Accountability, Objective III.3.2, Manage and Maximize County Assets, by supporting ongoing efforts to encourage the use of alternate modes of transportation and manage and improve public infrastructure assets.

FISCAL IMPACT/FINANCING

There will be no impact to the County General Fund.

The estimated construction contract cost to complete this project is in the range of \$750,000 and \$1,125,000 with a maximum construction contract cost to be 15 percent above this range. The total project cost is estimated to be \$1,850,000. In addition to the construction contract cost, the total project cost includes the interim installation of K-rail, preparation of plans and specifications, construction engineering, inspection, contract administration, change order contingency, environmental compliance, survey, utility clearance, and other County services. The project is located entirely within the unincorporated County areas in the Third Supervisorial District.

The project will be funded using the State of California Road Maintenance and Rehabilitation Account Funds allocated to the County under the Road Repair and Accountability Act of 2017, Senate Bill 1. Funding for this project is included in the Road Fund (B03-Capital Assets – Infrastructure and B03 – Services and Supplies) Fiscal Year 2023-24 Budget.

FACTS AND PROVISIONS/LEGAL REQUIREMENTS

This project will be advertised in accordance with Section 20392 of the State Public Contract Code.

State Public Contract Code Section 3400 allows a product to be designated by specific brand name for several purposes, two of which are to comply with California Department of Transportation authorized materials list for guardrail and to match other products in use on a particular public improvement either completed or in the course of completion, if the awarding authority makes a finding and language is included in the Notice Inviting Bids. The Notice Inviting Bids includes language describing this finding.

A list of specific brand names and qualified purposes in accordance with the State Public Contract Code is provided in Enclosure B.

The contract award will comply with applicable Federal and State requirements and Board policies and mandates. The contract documents will require the contractor to comply with these same requirements, policies, and mandates. The construction contract will be in the form previously reviewed and approved by County Counsel.

As required by Board Policy No. 5.140, information such as defaulted contracts with the County, complaints filed with the Contractors State License Board, labor violations, and debarment actions will be considered before a contract is awarded.

Documents related to award of this contract will be available at Los Angeles County Public Works, Project Management Division III, 900 South Fremont Avenue, 8th Floor, Alhambra, CA 91803.

ENVIRONMENTAL DOCUMENTATION

The proposed project is exempt from CEQA. The project to install new guardrail is within a class of projects that have been determined not to have a significant effect on the environment and which meets the criteria set forth in Section 15301 (c) of the State CEQA Guidelines and Class 1 (x) Subsections 14, 17, and 22 of the County's Environmental

Document Reporting Procedures and Guidelines, Appendix G. In addition, based on the proposed project records, the project will comply with all applicable regulations, and there are no cumulative impacts; unusual circumstances; damage to scenic highways; listing on hazardous waste site lists compiled pursuant to Government Code, Section 65962.5; or indications that it may cause a substantial adverse change in the significance of a historical resource that would make the exemption inapplicable.

CONTRACTING PROCESS

In accordance with the Board's consolidated Local and Targeted Worker Hire Policy, the contract documents will include a best-efforts goal that at least 30 percent of the total California craft worker hours for construction of the project be performed by Local Residents. The "Targeted Worker" component will not be included as part of the project. To increase contractor awareness of Public Works' program to contract work out to the private sector, this project will be listed on both the County's "Doing Business with Los Angeles County" and "Do Business with Public Works" websites for open bids:

The recommended action is consistent with California Public Employee's Pension Reform Act of 2013, which allows a person who retires from the County to serve without reinstatement from retirement or loss or interruption of benefits provided by the retirement system, before a period of 180 days following the date of retirement as long as the Board certifies the position is critically needed and the retired person has the skills

needed to perform work of limited duration. The request for such an appointment may not be placed on a consent calendar.

SUBJECT

Public Works is seeking Board approval to award a services contract to Mesa Energy Systems, Inc., dba EMCOR Services Mesa Energy, for on-call heating, ventilation, air conditioning, and water treatment maintenance services at the Public Works Headquarters complex in the City of Alhambra.

IT IS RECOMMENDED THAT THE BOARD:

- 1. Find that the contract work is categorically exempt from the provisions of the California Environmental Quality Act for the reasons stated in this Board letter and in the record of the project.
- 2. Award the contract to Mesa Energy Systems, Inc., dba EMCOR Services Mesa Energy, for on-call heating, ventilation, air conditioning, and water treatment maintenance services at Public Works Headquarters complex. This contract will be for a period of 1 year with four 1-year renewal options

and a month-to-month extension up to 6 months for a maximum potential contract term of 66 months and a maximum potential contract sum of \$2,486,501.60.

- 3. Delegate authority to the Director of Public Works or his designee to execute the contract; to renew the contract for each additional renewal option and extension period if, in the opinion of the Director of Public Works or his designee, that Mesa Energy Systems, Inc., dba EMCOR Services Mesa Energy, has successfully performed during the previous contract period, and these services are still required; to approve and execute amendments to incorporate necessary changes within the scope of work; to suspend and/or terminate the contract for convenience.
- 4. Delegate authority to the Director of Public Works or his designee to annually increase the contract amount up to an additional 10 percent of the annual contract sum, which is included in the maximum potential contract sum for unforeseen additional work within the scope of the contract, if required, and to adjust the annual contract sum for each option year over the term of the contract to allow for an annual cost-of-living adjustment in accordance with County policy and the terms of the contract.

PURPOSE/JUSTIFICATION OF RECOMMENDED ACTION

Approval of the recommended action will award a services contract to Mesa Energy Systems, Inc., dba EMCOR Services Mesa Energy, to provide on-call and intermittent maintenance services for the heating, ventilation, air-conditioning (HVAC), and water treatment systems at the Public Works Headquarters complex in the City of Alhambra.

Services include providing preventive maintenance; on-call mechanical repairs; regulatory testing and reporting; and testing, adjusting, and balancing of the Public Works Headquarters complex's HVAC systems. The Public Works Headquarters complex consists of a large number of HVAC equipment ranging in complexity and age, which require specialized tools and training to maintain. The recommended contractor has the specialized expertise to provide the necessary maintenance and repair services to maintain the HVAC assets of the Public Works Headquarters complex in an accurately, efficiently, timely, and responsive manner.

The current contract is extended for a period not to exceed 180 days and has an expiration date of April 29, 2024. The award of this contract will continue these services by the recommended contractor.

Implementation of Strategic Plan Goals

These recommendations support the County Strategic Plan: Strategy III.3, Pursue Operational Effectiveness, Fiscal Responsibility, and Accountability, and Objective III.3.2, Manage and Maximize County Assets, by investing into and maintaining existing assets in the pursuit to maximize their use.

FISCAL IMPACT/FINANCING

There will be no impact to the County General Fund.

The annual cost is \$410,992 plus 10 percent of the annual contract sum for additional work within the scope of the contract and cost-of-living adjustments in accordance with the contract. Any unused authorized amounts up to 25 percent from the previous contract terms will be applied to subsequent renewal terms, including the four 1-year renewal options and a month-to-month extension up to 6 months for a maximum potential contract term of 66 months with an estimated maximum potential contract sum of \$2,486,501.60. This amount is based on the annual unit prices quoted by the contractor and our estimated annual utilization of the contractor's services. The County may also authorize an extension of time to the contract's maximum potential term not to exceed 180 days with no additional funding. Adjustments will be made to the annual contract's sum for each option year over the term of the contract to allow for an annual cost-of-living adjustment in accordance with County policy and the terms of the contract.

Funding for the first year of these services is included in the Internal Services Fund (B04 – Services and Supplies) Fiscal Year 2023-24 Budget, which will be reimbursed by the Flood Control District Fund (B07 – Services and Supplies). Funds to finance the contract's renewal years and 10 percent additional funding for contingencies will be requested through the annual budget process. Adjustments will be made to the annual contract's sum for each option year over the term of the contracts to allow for an annual cost-of-living adjustment in accordance with County policy and the terms of the contracts.

FACTS AND PROVISIONS/LEGAL REQUIREMENTS

The recommended contractor, Mesa Energy Systems, Inc., dba EMCOR Services Mesa Energy, is located in Irvine, California. This contract will commence upon the Board's approval and final execution, whichever occurs last, for a period of 1 year. With the Board's delegated authority, Public Works may renew the contract for four 1-year renewal options and a month-to-month extension up to 6 months for a maximum potential total contract term of 66 months. The County may also authorize an

extension of time to the contract's maximum potential term not to exceed 180 days with no additional funding.

County Counsel has reviewed the contract as to form (Enclosure A). The recommended contract with Mesa Energy Systems, Inc., dba EMCOR Services Mesa Energy, was solicited on an open-competitive basis and is in accordance with applicable Federal, State, and County requirements.

A standard services contract has been used that contains terms and conditions in compliance with the Board's ordinances, policies, and programs. Enclosure B reflects the proposers' utilization participation and Community Business Enterprise program information. Data regarding the proposers' minority participation is on file with Public Works. The contractor was selected upon final analysis and consideration without regard to race, creed, gender, or color.

Public Works has evaluated and determined that the Living Wage Program (Los Angeles County Code, Chapter 2.201) does not apply to this recommended contract, which is for services required on an on-call and intermittent basis; hence, this contract is not a Proposition A contract (Los Angeles County Code, Chapter 2.121).

The contract includes a cost-of-living adjustment provision, which is in accordance with Board Policy 5.070, Multi-Year Services Contract Cost-of-Living Adjustments.

ENVIRONMENTAL DOCUMENTATION

These services are categorically exempt from the provisions of the California Environmental Quality Act. These services are within a class of projects that has been determined not to have a significant effect on the environment in that they meet the criteria set forth in Section 15301 of the California Environmental Quality Act.

CONTRACTING PROCESS

On July 6, 2023, a notice of the Request for Proposals was placed on the County's "Doing Business with Los Angeles County" website (Enclosure C), "Do Business with Public Works" website, and X (formerly Twitter). In addition, advertisements were placed in the Los Angeles Daily Journal, La Opinión, Los Angeles Sentinel, The Daily Breeze, The Signal (Santa Clarita), Antelope Valley Press, San Gabriel Tribune, Watts Times, Malibu Times, and Pasadena Star News. Also, Public Works informed 1,442 Local Small Business Enterprises, 158 Social Enterprises, 155 Disabled Veteran Business Enterprises, 904 Community Business Enterprises, 1,385 Community-Based Organizations, 115 independent contractors, various business development centers, and municipalities about this business opportunity.

On August 14, 2023, two proposals were received. Both proposals were evaluated by an evaluation committee consisting of Public Works staff. The evaluation was based on criteria described in the Request for Proposals, which included the price, experience, work plan, references, and equipment utilizing the informed averaging methodology for applicable criteria. Based on this evaluation, it is recommended that this contract be awarded to the highest rated, lowest cost, responsive, and responsible proposer, Mesa Energy Systems, Inc., dba EMCOR Services Mesa Energy, located in Irvine, California. Public Works notified the applicable union on this solicitation.

IMPACT ON CURRENT SERVICES (OR PROJECTS)

The award of this contract will continue the services without disruption to the public and will not result in the displacement of any County employees as these services are presently contracted with the private sector.

<u>SECOND</u>: This AGREEMENT, together with Exhibit A, Scope of Work; Exhibit B, Service Contract General Requirements; Exhibit C, Internal Revenue Service Notice 1015; Exhibit D, Safely Surrendered Baby Law Posters; Exhibit E, Defaulted Property Tax Reduction Program; Exhibit F, Performance Requirements Summary; Exhibit G.1, Job Plans and Routine Tasks; and Exhibit H, Non-Chemical Environmentally Friendly Water Treatment; Exhibit I.1, Equipment to be Serviced; the CONTRACTOR'S Proposal, all attached hereto; the Request for Proposals; and Addenda to the Request for Proposals, all of which are incorporated herein by reference, are agreed by the COUNTY and the CONTRACTOR to constitute the Contract.

<u>THIRD</u>: The COUNTY agrees, in consideration of satisfactory performance of the foregoing services in strict accordance with the Contract specifications to the satisfaction of the Director of Public Works, to pay the CONTRACTOR pursuant to the Schedule of Prices set forth in the Proposal and attached hereto as Form PW-2.1, an amount not to exceed \$410,992 per year, or such greater amount as the Board may approve (Maximum Contract Sum).

<u>FOURTH</u>: This Contract's initial term shall be for a period of one year commencing upon the Board's approval and final execution, whichever occurs last. The COUNTY shall have the sole option to renew this Contract term for up to four additional 1-year periods and six month-to-month extensions, for a maximum total Contract term of 5 years and 6 months. Each such option shall be exercised at the sole discretion of the COUNTY. The COUNTY, acting through the Director, may give a written notice of intent to renew this Contract at least 10 days prior to the end of each term. At the sole discretion of the COUNTY, in lieu of renewing the Contract for the full one year, this Contract may be renewed on a month-to-month basis, upon written notice to the CONTRACTOR at least ten days prior to the end of a term. The Director will provide a written notice of nonrenewal at least 10 days before the last day of any term, in which case this Contract shall expire as of midnight on the last day of that term. Where all option years have been exercised, the Director will not provide a written notice of nonrenewal.

<u>FIFTH</u>: The CONTRACTOR will bill monthly, in arrears, for the work performed during the preceding month. Work performed will be billed at the hourly rates and/or unit prices quoted in Form PW-2.1, Schedule of Prices.

<u>SIXTH</u>: Public Works will make payment to the CONTRACTOR within 30 days of receipt and approval of a properly completed and undisputed invoice. However, should the CONTRACTOR be certified by the COUNTY as a Local Small Business Enterprise, payment will be made in accordance with Board of Supervisors Policy No. 3.035, Small Business Liaison and Prompt Payment Program. Each invoice must be in triplicate (original and two copies) and must itemize the work completed. The invoices must be submitted to:

<u>SEVENTH</u>: In no event will the aggregate total amount of compensation paid to the CONTRACTOR exceed the amount of compensation authorized by the Board. Such aggregate total amount is the Maximum Contract Sum.

<u>EIGHTH</u>: The CONTRACTOR understands and agrees that only the designated Public Works Contract Manager is authorized to request or order work under this Contract. The CONTRACTOR acknowledges that the designated Contract Manager is not authorized to request or order any work that would result in the CONTRACTOR earning an aggregate compensation in excess of this Contract's Maximum Contract Sum.

<u>NINTH</u>: The CONTRACTOR must not perform or accept work requests from the Contract Manager or any other person that will cause the Maximum Contract Sum of this Contract to be exceeded. The CONTRACTOR must monitor the balance of this Contract's Maximum Contract Sum. When the total of the CONTRACTOR'S paid invoices, invoices pending payment, invoices yet to be submitted, and ordered services reaches 75 percent of the Maximum Contract Sum, the CONTRACTOR must immediately notify the Contract Manager in writing. The CONTRACTOR must send written notification to the Contract Manager when this Contract is within 6 months from expiration of the term as provided for hereinabove.

<u>TENTH</u>: If requested by the Contractor, the contract (hourly, daily, monthly, etc.) amount may, at the sole discretion of the County, be increased at the time of contract renewal, if exercised by the County, based on the most recently published percentage change in the U.S. Department of Labor, Bureau of Labor Statistics' Consumer Price Index (CPI) for the Los Angeles-Long Beach-Anaheim area for the 12-month period preceding the renewal date, which will be the effective date for any Cost-of-Living Adjustment (COLA). However, any increase will not exceed the general salary movement granted to County

employees as determined by the Chief Executive Officer as of each July 1 for the prior 12-month period. Furthermore, should fiscal circumstances ultimately prevent the Board from approving any increase in County employee salaries, no COLA will be granted. Upon approval of COLA, a notification will be sent to the Contractor.

<u>ELEVENTH</u>: In the event that terms and conditions, which may be listed in the CONTRACTOR'S Proposal, conflict with the COUNTY'S specifications, requirements, and terms and conditions as reflected in this AGREEMENT including, but not limited to, Exhibits A through I, inclusive, the COUNTY'S provisions will control and be binding.

<u>TWELFTH</u>: The CONTRACTOR agrees in strict accordance with the Contract specifications and conditions to meet the COUNTY'S requirements.

<u>THIRTEENTH</u>: This Contract constitutes the entire agreement between the COUNTY and the CONTRACTOR with respect to the subject matter of this Contract and supersedes all prior and contemporaneous agreements and understandings. This CONTRACT may be signed by the Parties hereto in separate counterparts, including both counterparts that are executed on paper and counterparts that are in the form of electronic signatures. Electronic signatures include facsimile or e-mail electronic signatures. Each executed counterpart will be deemed an original. All counterparts, taken together, constitute the executed Agreement.

The Parties hereby acknowledge and agree that electronic records and electronic signatures, as well as facsimile signatures, used in connection with the execution of this Agreement and electronic signatures, facsimile signatures or signatures transmitted by electronic mail in so-called pdf format will be legal and binding and will have the same full force and effect as if a paper original of this Agreement had been delivered and had been signed using a handwritten signature. Contractor and County (i) agree that an electronic signature, whether digital or encrypted, of a Party to this Agreement is intended to authenticate this writing and to have the same force and effect as a manual signature, (ii) intend to be bound by the signatures (whether original, faxed or electronic) on any document sent or delivered by facsimile or, electronic mail, or other electronic means, (iii) are aware that the other Party will rely on such signatures, and (iv) hereby waive any defenses to the enforcement of the terms of this Agreement based on the foregoing forms of signature. If this Agreement has been executed by electronic signature, all Parties executing this document are expressly consenting under the United States Federal Electronic Signatures in Global and National Commerce Act of 2000 (E-SIGN) and California Uniform Electronic Transactions Act (UETA)(Cal. Civ. Code § 1633.1, et seq.), that a signature by fax, e-mail or other electronic means will constitute an Electronic Signature to an Electronic Record under both E-SIGN and UETA with respect to this specific transaction.

TRANSPORTATION CORE SERVICE AREA ADOPT RESOLUTION NO. 3998 FOR HIGHWAYS-THROUGH-CITIES FUNDING AND APPROVE USE OF ON-CALL CONTRACTS ON TRAFFIC SIGNAL SYNCHRONIZATION PROGRAM AND TRAFFIC SAFETY PROJECTS IN THE CITIES OF HAWTHORNE AND LAWNDALE AND IN THE UNINCORPORATED COMMUNITY OF VIEW PARK/WINDSOR HILLS (SUPERVISORIAL DISTRICT 2) (4 VOTES)

SUBJECT

Public Works is seeking Board approval to adopt Resolution No. 3998 providing Highways-Through-Cities Funds to the Cities of Hawthorne and Lawndale; approve traffic signal synchronization program and traffic safety projects; and authorize the Director of Public Works or his designee to use On-Call Traffic Signal and Safety Construction contracts to deliver the projects in the Cities of Hawthorne and Lawndale and in the unincorporated community of View Park/Windsor Hills.

IT IS RECOMMENDED THAT THE BOARD:

- 1. Find that the proposed projects, Hawthorne Boulevard Traffic Signal Synchronization Program Imperial Highway to Manhattan Beach Boulevard and View Park/Windsor Hills Overhill Drive at 58th Place-Orchid Drive, to be approved through work orders, are exempt from the provisions of the California Environmental Quality Act for the reasons stated in this Board letter and in the record of the projects.
- 2. Adopt Resolution No. 3998 finding that the modification and synchronization of traffic signals in the Cities of Hawthorne and Lawndale is of general County interest and that Los Angeles County aid in the form of Highways-Through-Cities Funds in the amount of \$936,400 shall be provided to the cities to be expended in accordance with all applicable provisions of law relating to funds derived from Proposition C Discretionary Grant Funds and Proposition C Local Return Funds.
- 3. Approve the Hawthorne Boulevard Traffic Signal Synchronization Program -Imperial Highway to Manhattan Beach Boulevard and View Park/Windsor Hills -Overhill Drive at 58th Place-Orchid Drive projects with total project cost estimates of \$1,134,800 and \$2,400,000, respectively.
- 4. Authorize the Director of Public Works, acting as the Road Commissioner, or his designee to use On-Call Traffic Signal and Safety Construction contracts, which have been previously approved by the Board, to deliver the two proposed projects by issuing work orders where the total project cost estimates shall not exceed \$1,134,800 and \$2,400,000 unless additional funds have been identified.

Approval of the recommended actions will find that the proposed projects, Hawthorne Boulevard Traffic Signal Synchronization Program (TSSP) - Imperial Highway to Manhattan Beach Boulevard and View Park/Windsor Hills - Overhill Drive at 58th Place-Orchid Drive, and related actions, are exempt from the California Environmental Quality Act (CEQA); adopt a Resolution that the Hawthorne Boulevard TSSP project is of general County interest and that aid in the form of Highways-Through-Cities (HTC) Funds in the amount of \$936,400 shall be provided to the Cities of Hawthorne and Lawndale; approve the Hawthorne Boulevard TSSP – Imperial Highway to Manhattan Beach Boulevard and View Park/Windsor Hills – Overhill Drive at 58th Place-Orchid Drive projects with total project cost estimates of \$1,134,800 and \$2,400,000, respectively; and authorize the Director of Public Works or his designee to use Board-approved On-Call Traffic Signal

and Safety Construction contracts to construct the projects that will upgrade and synchronize traffic signals throughout several intersections along Hawthorne Boulevard in the Cities of Hawthorne and Lawndale and install traffic signals in the unincorporated community of View Park/Windsor Hills (see Enclosure A).

Public Works is proposing to implement traffic signal synchronization and traffic safety programs to increase mobility, minimize congestion, and improve safety for roadway users. The two proposed projects will be delivered through work orders issued under existing On-Call Traffic Signal and Safety Construction contracts. The use of on-call contracts is a cost-effective, streamlined method for completing traffic signal synchronization and traffic safety projects.

The HTC program is a County program initiated to assist cities in developing a fully coordinated arterial system throughout the County recognizing that many small cities do not have the funds to complete their portion of the County's Highway Plan. Under the HTC program, cities receive assistance for the construction of specific highway projects. The HTC Funds are allocated on a case-by-case basis at the discretion of the Supervisor in whose district the project is located.

Board adoption of Resolution No. 3998 will approve the County's contributions of HTC Funds in the amount of \$936,400 to finance a portion of the Cities of Hawthorne and Lawndale's jurisdictional shares of the project cost (see Enclosure B).

Sections 1680-1683 of the California Streets and Highways Code provide that the Board of Supervisors of any County may, by a resolution adopted by a four-fifths vote of its members, determine that certain types of road improvements are of general County interest and that County aid shall be extended therefor.

Public Works recommends that the Board approve the two proposed projects and authorize Public Works to use On-Call Traffic Signal and Safety Construction contracts to deliver these projects.

If approved, it is anticipated the work for both projects will start in July 2024 and be completed in March 2025.

Implementation of Strategic Plan Goals

These recommendations support the County Strategic Plan: Strategy III.3, Pursue Operational Effectiveness, Fiscal Responsibility, and Accountability, Objective III.3.2, Manage and Maximize County Assets, by supporting ongoing efforts to manage and improve public infrastructure assets.

FISCAL IMPACT/FINANCING

There will be no impact to the County General Fund.

The construction contract costs to complete the Hawthorne Boulevard TSSP - Imperial Highway to Manhattan Beach Boulevard and View Park/Windsor Hills - Overhill Drive at 58th Place-Orchid Drive projects are estimated to be \$569,125 and \$1,320,000, respectively, with total project costs estimated to be \$1,134,800 and \$2,400,000, respectively. In addition to the construction contract cost, the total project cost includes the preparation of plans and specifications, consultant services, utility clearance, inspection, contract administration, change order contingency, environmental compliance, and other County services.

The Hawthorne Boulevard TSSP Project is located in the Cities of Hawthorne and Lawndale. City Service Requests will provide for the County to perform the preliminary engineering and administer the construction of the project with the Cities of Hawthorne and Lawndale to finance a portion of their jurisdictional shares of the project cost, estimated to be \$3,000 and \$195,400, respectively. The project is financed with \$936,400 in grant funds received from the Los Angeles County Metropolitan Transportation Authority 2013 Call for Projects, Proposition C Discretionary Grant Funds, for the South Bay Forum Traffic Signal Corridors Project. The \$936,400 in HTC Funds consists of Proposition C Discretionary Grant Funds. The Cities of Hawthorne and Lawndale's jurisdictional shares of the County HTC contribution from Proposition C Discretionary Grant Funds are \$89,800 and \$846,600, respectively.

The View Park/Windsor Hills – Overhill Drive at 58th Place-Orchid Drive Project is located within the unincorporated County communities of View Park/Windsor Hills. The project is financed with \$2,400,000 in County Road Funds.

Funding for the two proposed projects is included in the Road Fund (B03 - Capital Assets– Infrastructure and Services and Supplies) and Proposition C Local Return Fund (CN9 -Services and Supplies) Fiscal Year 2023-24 Budgets. Funding for future years will be requested through the annual budget process.

FACTS AND PROVISIONS/LEGAL REQUIREMENTS

On June 27, 2023, the Board delegated to the Director of Public Works, acting as the Road Commissioner, or his designee, the authority to separately award and execute six On-Call Traffic Signal and Safety Construction contracts and to approve and execute supplemental work orders within the same monetary limits delegated to the Director of Public Works or his designee under Section 2.18.050 of the Los Angeles County Code, pursuant to the authority granted by Public Contract Code Section 20145, which allows the Los Angeles County Board of Supervisors to authorize the Director of Public Works to deliver construction contracts that do not exceed \$330,000. The contract work of the two proposed projects both exceed \$330,000 and, therefore, require Board approval.

The two proposed projects would be carried out through previously Board-approved On-Call Traffic Signal and Safety Construction contracts. Public Works will use the executed contract pricing and specifications, including the contractual provisions, methods, and material requirements necessary for these projects that are on file with Public Works.

ENVIRONMENTAL DOCUMENTATION

The two separate proposed projects are exempt from CEQA.

The Hawthorne Boulevard TSSP - Imperial Highway to Manhattan Beach Boulevard Project to synchronize and upgrade traffic signal systems is within a class of projects that have been determined not to have a significant effect on the environment and which meets the criteria set forth in Section 15301 (c) of the State CEQA Guidelines and Class 1 (x) Subsections 4, 14, and 22 of the County's Environmental Document Reporting Procedures and Guidelines, Appendix G.

The View Park/Windsor Hills - Overhill Drive at 58th Place-Orchid Drive Project to install a traffic signal system is within a class of projects that have been determined not to have a significant effect on the environment and which meets the criteria set forth in Section 15301 (c) of the State CEQA Guidelines and Class 1 (x) Subsections 4, 5, 7, 14, and 22 of the County's Environmental Document Reporting Procedures and Guidelines, Appendix G.

Based on the records of the two proposed projects, they will comply with all applicable regulations, and there are no cumulative impacts, unusual circumstances, damage to scenic highways, listing on hazardous waste site lists compiled pursuant to Government Code Section 65962.5, or indications that it may cause a substantial adverse change in

the significance of a historical resource that would make the exemptions inapplicable to the projects.

CONTRACTING PROCESS

Public Works would utilize Board-approved On-Call Traffic Signal and Safety Construction contracts for the construction of the two proposed projects.

Both projects will comply with the Countywide Local and Targeted Worker Hiring Policy that went into effect on November 1, 2016.

IMPACT ON CURRENT SERVICES (OR PROJECTS)

The use of Board-approved on-call traffic signal and safety construction contracts for the two proposed projects will expedite the completion of these projects. Minor impacts to adjacent residents, businesses, and motorists may occur while the projects are underway. When the projects are completed, they will have a positive impact by enhancing traffic flow, reducing congestion, and improving safety for the traveling public.







RESOLUTION NO. 3998 OF THE BOARD OF SUPERVISORS OF THE COUNTY OF LOS ANGELES, CALIFORNIA, TO EXTEND COUNTY AID TO THE CITIES OF HAWTHORNE AND LAWNDALE FOR THE PURPOSE OF TRAFFIC SIGNAL SYNCHRONIZATION

WHEREAS, the CITIES OF HAWTHORNE AND LAWNDALE, hereinafter referred to as CITIES and the COUNTY OF LOS ANGELES (COUNTY), hereinafter referred to as COUNTY, desire to modify and synchronize the traffic signals along Hawthorne Boulevard from Imperial Highway to Manhattan Beach Boulevard, which work is hereinafter referred to as the Traffic Signal Synchronization Program (TSSP); and

WHEREAS, portions of TSSP are located and will be utilized within the jurisdictional limits of CITIES and COUNTY; and

WHEREAS, TSSP is of general interest to CITIES and COUNTY; and

WHEREAS, the CITIES' shares of the total cost of TSSP is currently estimated to be One Million One Hundred Thirty-four Thousand Eight Hundred and 00/100 Dollars (\$1,134,800.00); and

WHEREAS, the CITIES' shares of the TSSP cost will be financed with Nine Hundred Thirty-six Thousand Four Hundred and 00/100 Dollars (\$936,400.00) in Los Angeles County Metropolitan Transportation Authority (METRO) 2013 Call for Projects grant funds administered by the COUNTY for the South Bay Forum Traffic Signal Corridors Project and One Hundred Ninety-eight Thousand Four Hundred and 00/100 Dollars (\$198,400.00) in City funds; and

WHEREAS, TSSP is consistent with the scope of work for traffic improvements within CITIES pursuant to Memorandum of Understanding (MOU) Number P00F7310 between COUNTY and METRO; and

WHEREAS, such a proposal is authorized and provided for by the provisions of sections 1680-1683 of the California Streets and Highways Code.

NOW, THEREFORE, it is hereby resolved as follows:

SECTION 1. The TSSP is of general COUNTY interest and County-aid shall be extended therefor.

SECTION 2. Subject to the terms and conditions set forth herein, COUNTY consents, pursuant to the provisions of Streets and Highways Code sections 1680-1683,

to extend aid to CITIES in the amount of Nine Hundred Thirty-six Thousand Four Hundred and 00/100 Dollars (\$936,400.00) for TSSP from the Proposition C Discretionary Grant funds and Proposition C Local Return funds, to be expended in accordance with all applicable provisions of law relating to funds derived from the Proposition C local sales tax.

SECTION 3. The financial obligations of the COUNTY are expressly conditioned upon obtaining reimbursement from METRO pursuant to MOU Number P00F7310 between COUNTY and METRO.

SECTION 4. If any provision of this resolution is held or declared to be invalid, the resolution shall be void and the consent granted hereunder shall lapse.

AWARD CONTRACT FOR LOS ANGELES COUNTY SAN FERNANDO VALLEY AREA PLAN (THIRD AND FIFTH SUPERVISORIAL DISTRICT) (3-VOTES)

SUBJECT

Award contract to Rangwala Associates (Contractor) to prepare the Los Angeles County San Fernando Valley Area Plan.

IT IS RECOMMENDED THAT THE BOARD,

- 1. Find that the contract is exempt from the California Environmental Quality Act (CEQA), pursuant to Section 15378 (b) (4) of the CEQA Guidelines;
- 2. Approve and instruct the Chair to sign the attached four-year contract with the Contractor, effective the day after your Board's approval, with two six-month renewal options, at a maximum contract sum (MCS) of \$500,000; and
- 3. Delegate authority to the Director of Regional Planning (Director) or her designee to approve and execute amendments to incorporate necessary changes to the contract that do not significantly affect the scope of work, exceed the MCS of \$500,000, or change the term of the contract; and to suspend work if, in the opinion of the Director, it is in the best interest of the County to do so.



PURPOSE/JUSTIFICATION OF RECOMMENDED ACTION

In 2015, the County adopted a comprehensive update to its General Plan with the horizon year of 2035. The General Plan serves as the foundation for all community-based plans, such as area plans, community plans, and coastal land use plans. This foundation is called the Planning Areas Framework, which divides Los Angeles County into eleven (11) planning areas. Area plans focus on land use and other policy issues that are specific to the planning area.

One of the planning areas is the San Fernando Valley Planning Area, which includes the unincorporated communities of Kagel Canyon, Lopez Canyon, Sylmar Island, Oat Mountain, Twin Lakes, West Chatsworth, Westhills, and Universal City. The Contractor will assist the County to prepare and develop the area plan guiding the future development of these communities.

Implementation of Strategic Plan Goals

The approval of this contract supports the County's 2016-2021 Strategic Plan Goal II - Foster Vibrant and Resilient Communities, Strategy II.2, Support the Wellness of Our Communities by preparing a plan to encourage effective and orderly land use development in the unincorporated San Fernando Valley area.

FISCAL IMPACT/FINANCING

The MCS of the contract is \$500,000, which is based on the work outlined in the Statement of Work and the price quote from the Contractor. The project is Net County Cost funded through the Department's Fiscal Year 2023-2024 Operating Budget.

FACTS AND PROVISIONS/LEGAL REQUIREMENTS

The contract (Attachment I) will become effective the day after Board approval and will continue for the initial term of four-year. At the end of the initial term, the contract may be extended for two six-month option extension for a total of five years.

The contract contains all the latest applicable Board mandated provisions, including those pertaining to consideration of hiring qualified County employees targeted for layoffs, contractor responsibility and debarment, Child Support program, GAIN/GROW participants, Safely Surrendered Baby Law, and the provisions of Paid Jury Service time for the Contractor's employees.

This contract is a non-Prop A contract because it is highly specialized and cannot be performed by County employees. Consequently, there are no departmental employee relations issues, and the contract will not result in a reduction of County services. The award of this Contract will not result in the displacement of any County employees. Furthermore, the Department of

Regional Planning (DRP) evaluated and determined that the Living Wage Program (County Code Chapter 2.201) does not apply to this Agreement.

The Contractor was selected without regard to race, creed, gender, or color.

DRP will not require the Contractor to perform services that exceed the Board-approved contract sum, scope of work, or contract term.

County Counsel has approved the contract as to form.

ENVIRONMENTAL DOCUMENTATION

The services provided through this contract will not have an effect on the environment and therefore, this contract is exempt from CEQA, pursuant to Section 15378(b)(4) of the CEQA Guidelines.

CONTRACTING PROCESS

Union Notification

Consistent with the provisions of the Memorandums of Understanding between the County and unions, Service Employees International Union Local 721 and California Association of Professional Employees were consulted prior to the release of the Request for Proposals (RFP) and they had no objections with the solicitation.

Solicitation Outreach

The DRP initiated a competitive RFP process to solicit the services from qualified consultants. The RFP was released on November 9, 2023 via the County's WebVen system and posted on DRP website. The RFP was also advertised on the American Planning Association website in order to reach out to additional planning and environmental professionals who might be interested in the project.

Proposal Evaluation

One proposal from the Contractor was received by the January 4, 2024 deadline and it met the minimum requirements. A six-member evaluation committee was formed to evaluate the proposal. The committee was comprised of representatives from DRP and the County of Los Angeles Department of Beaches and Harbors.

Using the County approved Informed Averaging Method, the committee evaluated the proposal according to the evaluation criteria outlined in the RFP and took into consideration team

qualifications, project management, and methodologies. References and the project cost were factored in calculating the final score.

The Contractor is a certified Local Small Business Enterprise (LSBE) and Community Business Enterprise (CBE).

IMPACT ON CURRENT SERVICES (OR PROJECTS)

The award of this contract will not result in the displacement of any County employees. Upon the Board approval of this contract, DRP will commence the project.
