LAND ACKNOWLEDGEMENT

A Land Acknowledgement is a formal statement that recognizes and respects Indigenous Peoples as traditional stewards of this land and the enduring relationship that exists between Indigenous Peoples and their traditional territories.

Developed over many months of collaboration with leaders from local Tribes, on November 1, 2022, the Board of Supervisors unanimously voted to adopt a Land Acknowledgement for the County of Los Angeles.

LAND ACKNOWLEDGEMENT

The County of Los Angeles recognizes that we occupy land originally and still inhabited and cared for by the Tongva, Tataviam, Serrano, Kizh, and Chumash Peoples. We honor and pay respect to their elders and descendants – past, present, and emerging – as they continue their stewardship of these lands and waters. We acknowledge that settler colonization resulted in land seizure, disease, subjugation, slavery, relocation, broken promises, genocide, and multigenerational trauma. This acknowledgement demonstrates our responsibility and commitment to truth, healing and reconciliation and to elevating the stories, culture, and community of the original inhabitants of Los Angeles County. We are grateful to have the opportunity to live and work on these ancestral lands. We are dedicated to growing and sustaining relationships with Native peoples and local tribal governments, including (in no particular order) the

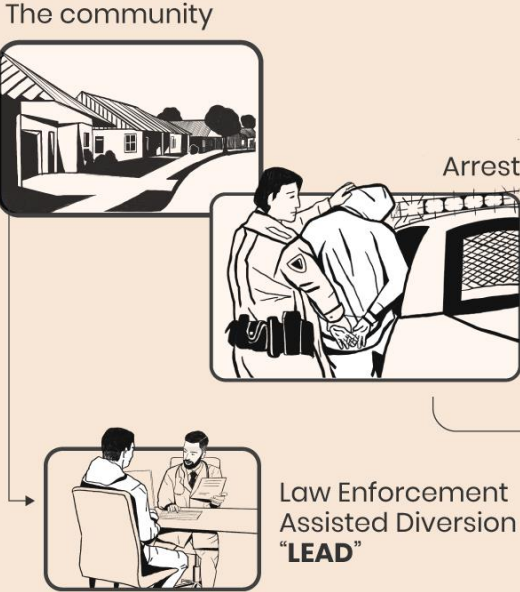

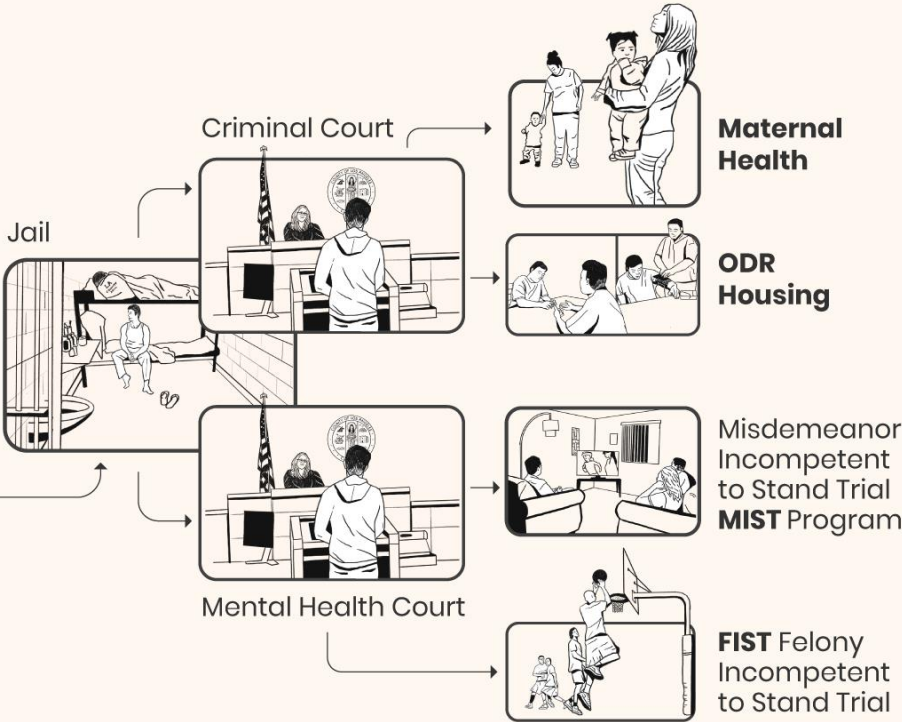

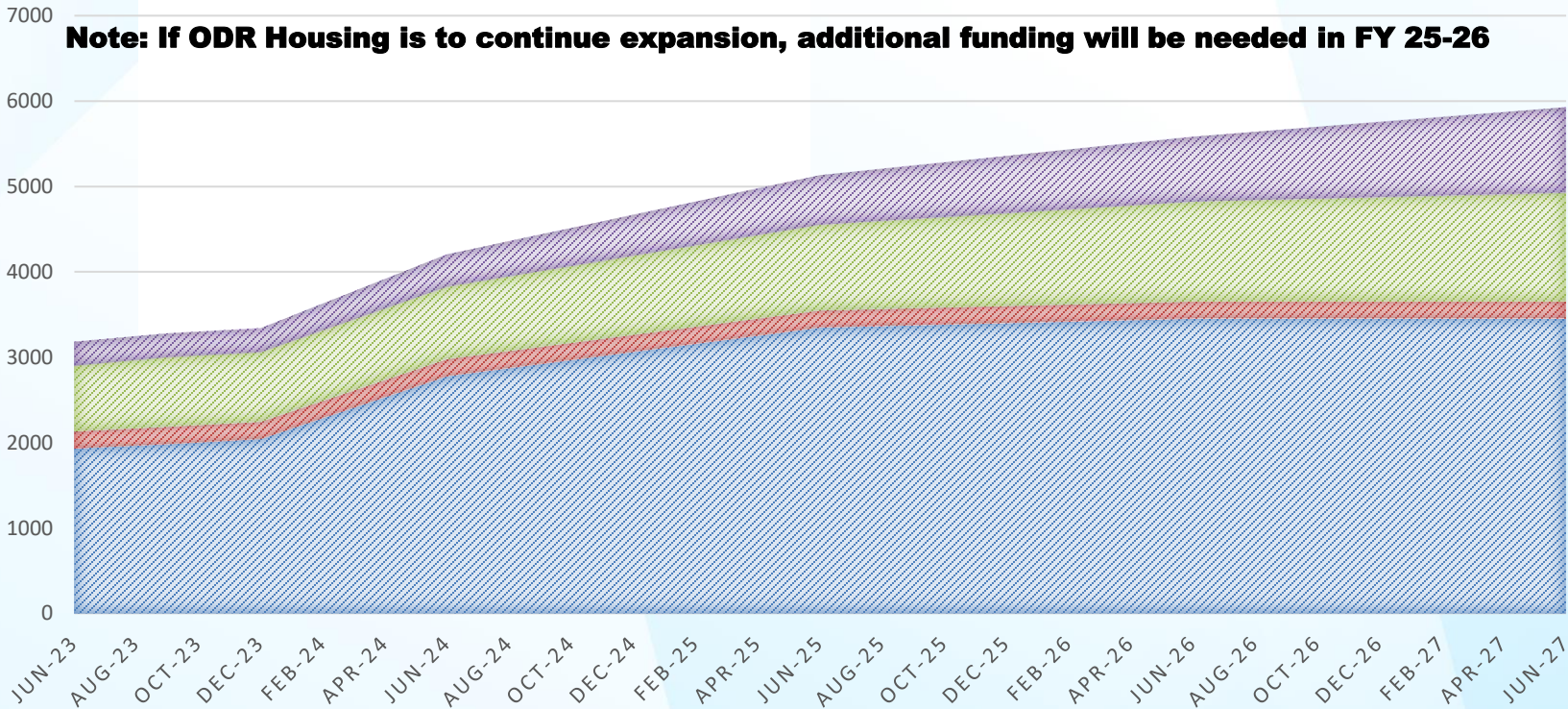

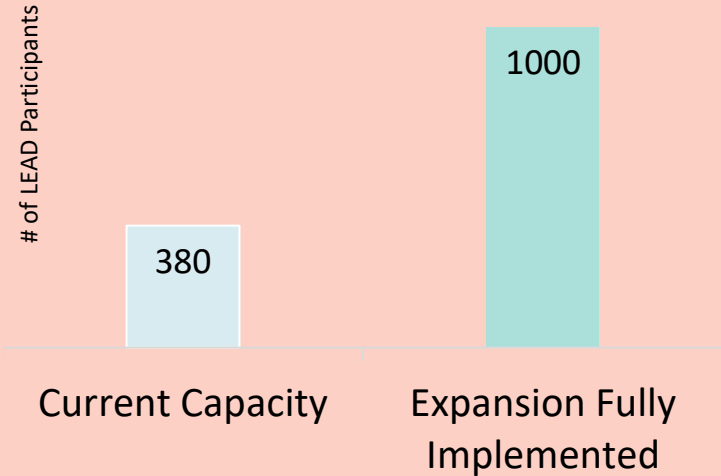

Challenges/
Bottlenecks

- Reverse referral process of P3 clients in ODR Housing slower than referral via portal

- ODR clinical staff shortages for vetting

- Court capacity limitations – delayed expansion
- Issues with transportation to court leading to continuations

- Lack of acute & subacute beds
- Acuity of clients in custody

Solutions

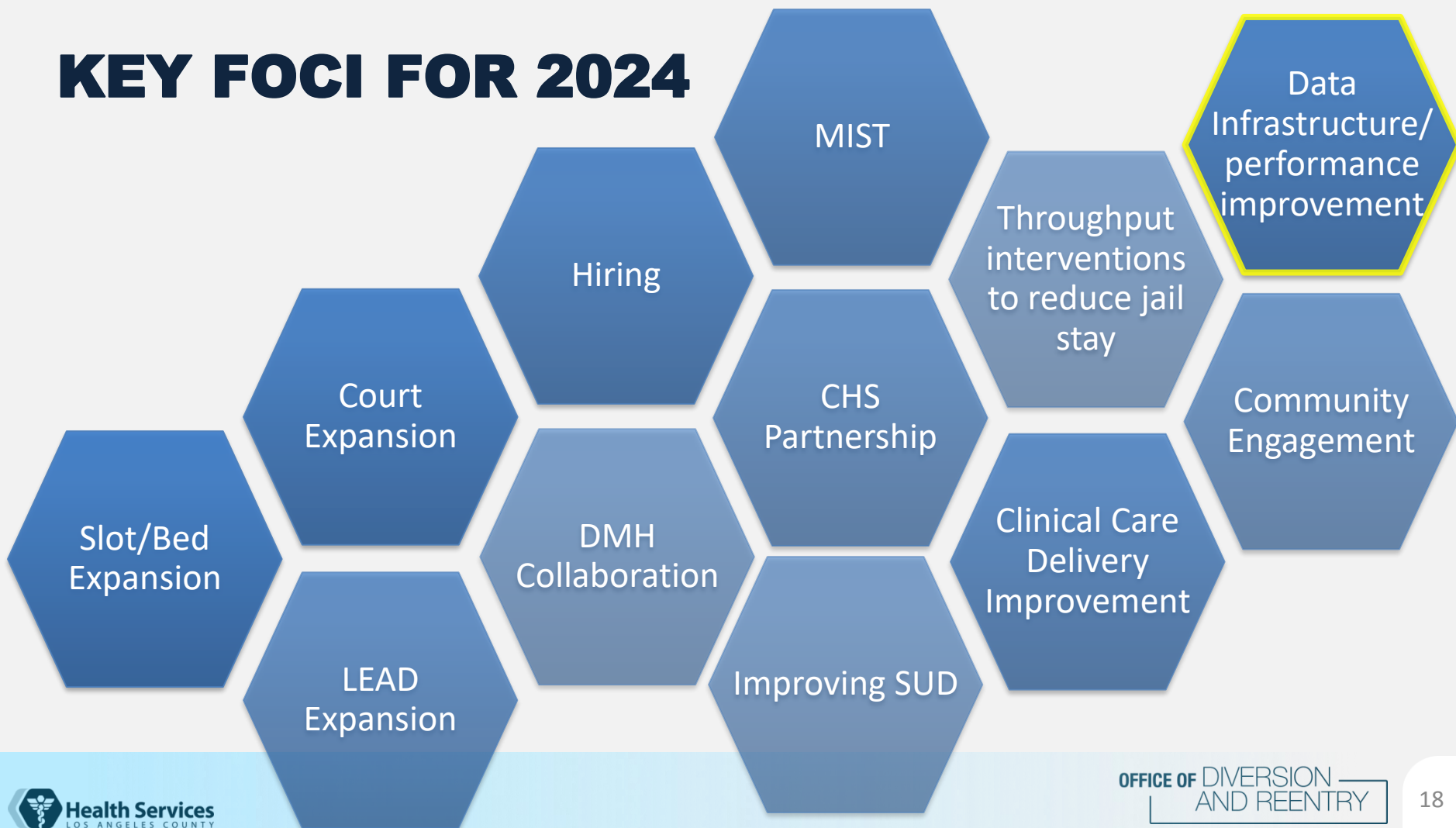
- Working with justice partners to more quickly identify eligible candidates and make referrals to ODR Housing improve referrals/IST notifications

- Rapidly hiring to increase candidate screening capacity
- Deploying clinicians to jails to improve quality & timeliness of evaluations

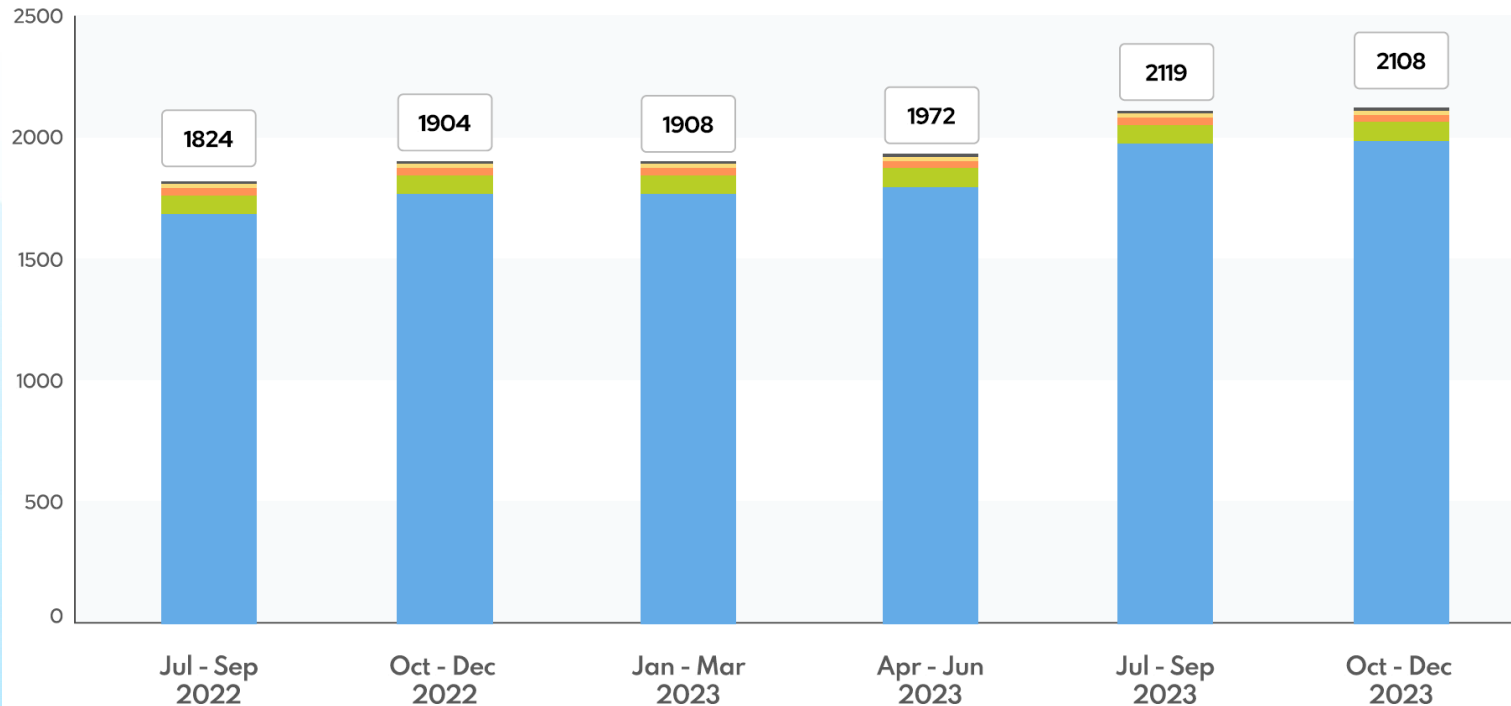
- Partnering with Criminal courts to expand capacity from 6 to 12 days/month countywide and reduce continuations
- Working with LASD to ensure individuals arrive for court dates

- Working with DMH to expand acute & subacute beds
- Coordinating with CHS and increasing ODR capacity for in-custody treatment
- Working with Criminal Courts to develop diversion approach to subacute settings

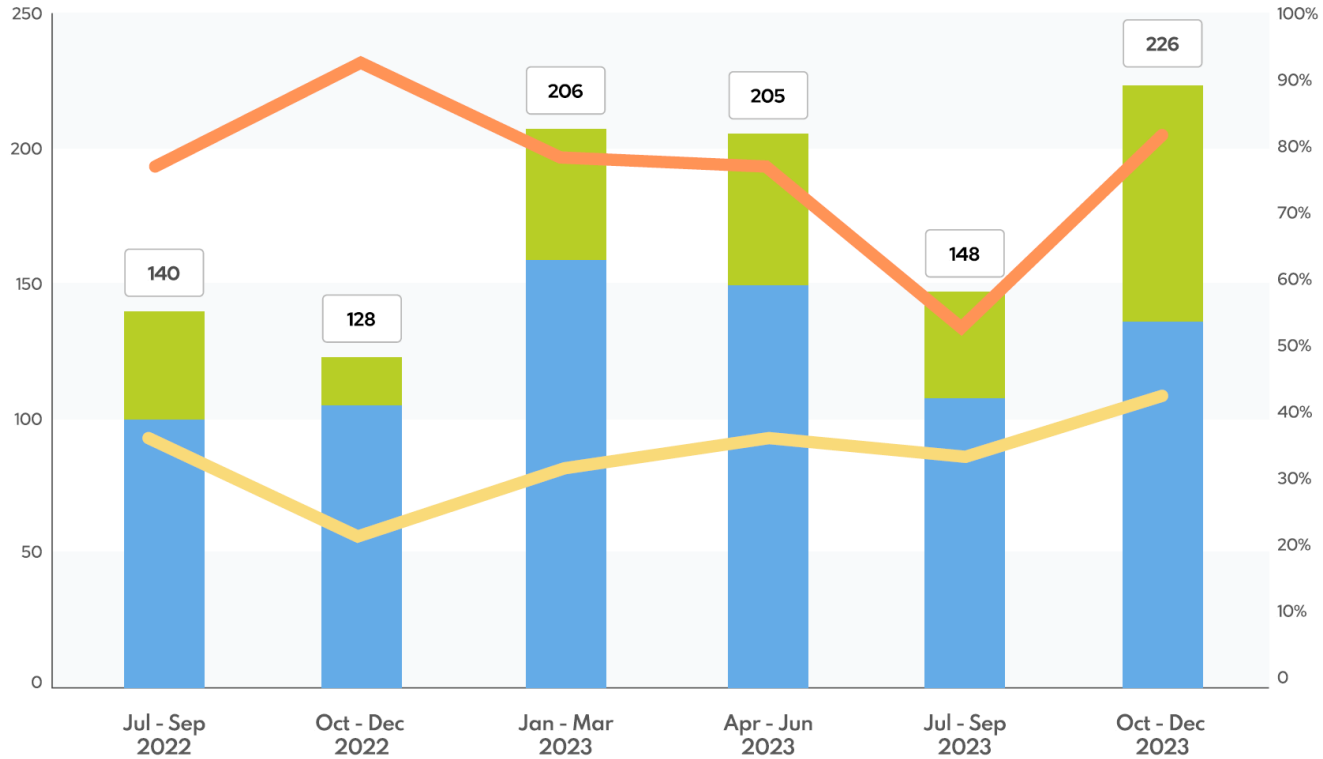


ODR Housing Program Outcomes*

ODR Housing Program Referral Outcomes*



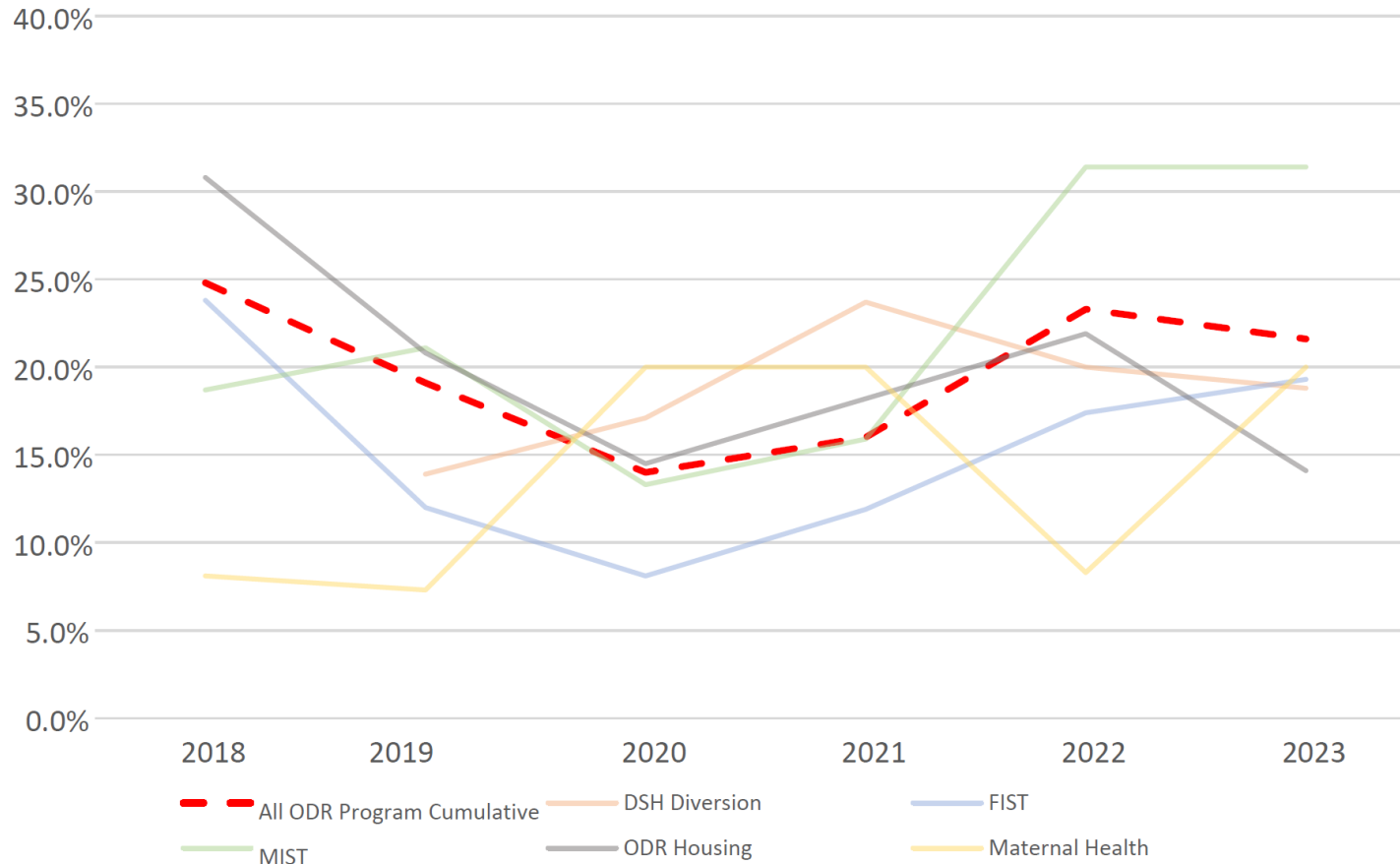

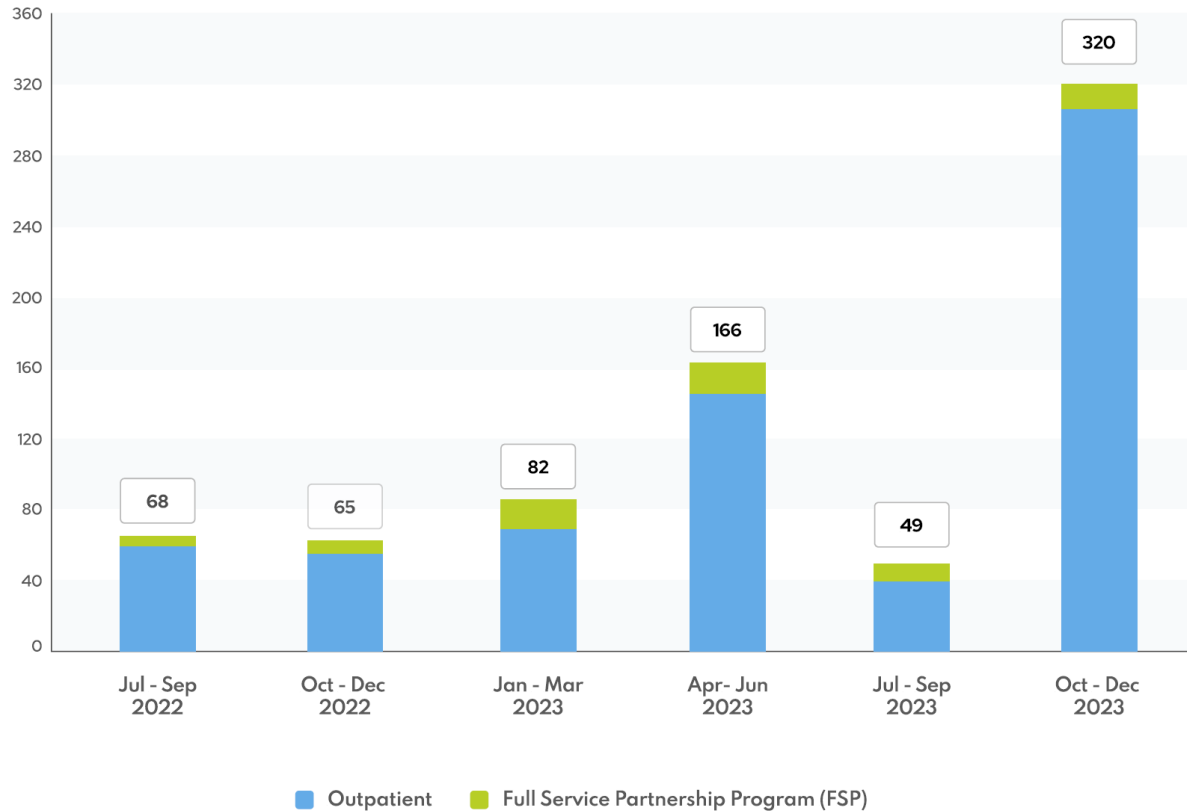
Accepted - Percent

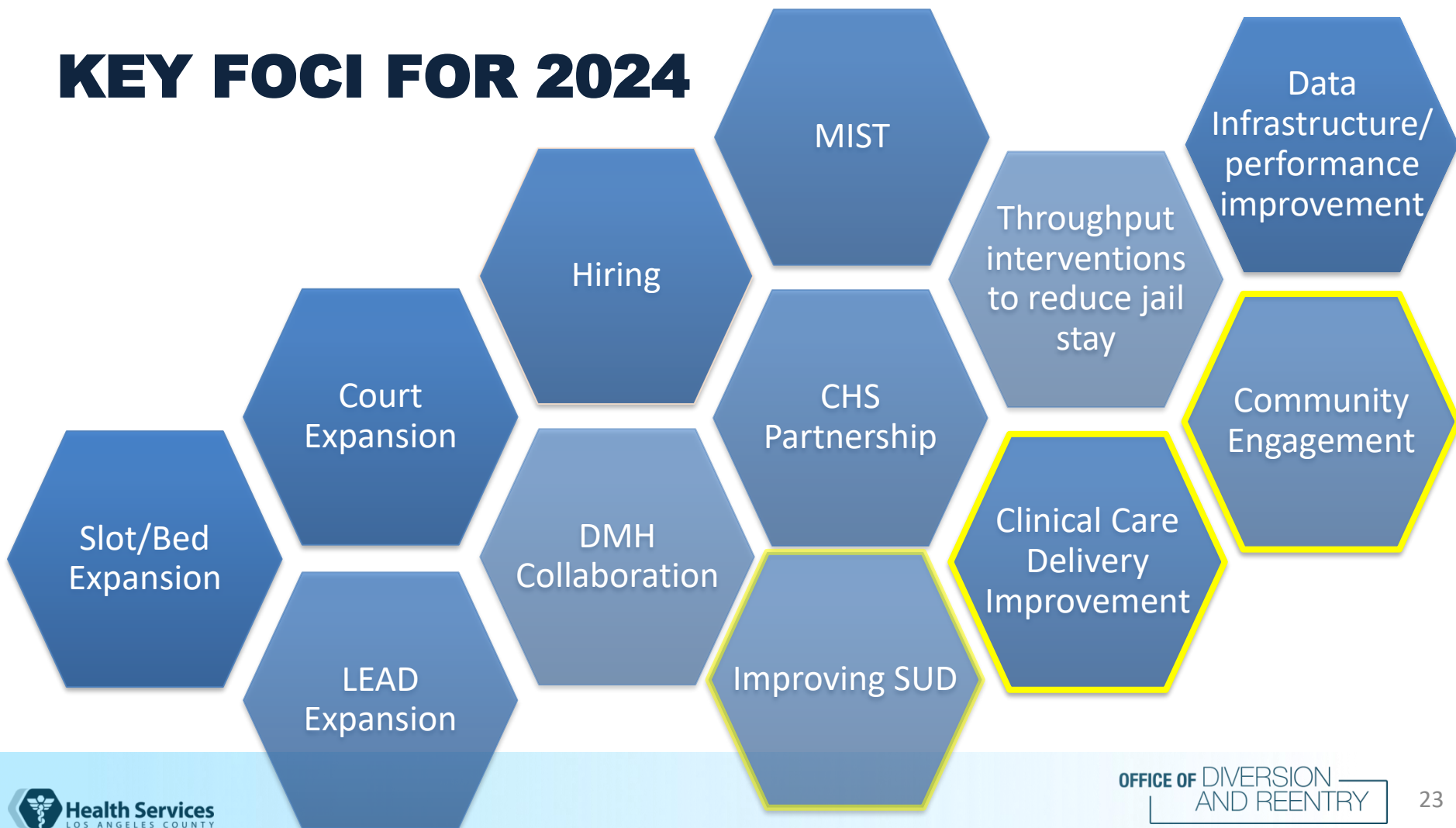
Rearrests within 6 months after ODR Enrollment by ODR Program*
