- Conducted community listening sessions with HRC, DV Council, DV Homeless Coalition, SAC, GBV Policy Group-scheduled for late May 2024
- Provided GBVPD high-level description of community listening sessions feedback
- Established structure/focus areas definitions/GBVPD Cluster meeting frequency.
 - GBVPD will center PRIMARY PREVENTION and meet monthly
- Discussed preliminary recommendations for funding/staffing on-going GBVPD/GBV work
- Identified County departments that provide prevention services. R
 - Recommended these departments/initiatives/commissions assign one staff liaison as a representative for on-going, future, GBVPD meetings in order to reduce duplication and silos.
