



The Face of Homelessness is Changing	
Into an Older One	

- Older adults account for an estimated 25% of LA County's homeless population.
- Nearly half (44%) of older adults became homeless after the age of 50.
- Older adults are fastest growing demographics among those experiencing homelessness and are projected to triple by 2030
- There is a paucity of solutions/models/services responding to the homelessness crisis among older adults.

Homelessness and Disabilities in LA County

In 2023, Los Angeles County has the greatest number of people with disabilities (1,004,632 people).

The prevalence of disability increases with age, from 10.3% among those 18-24 years of age to 41.9% among those 65 and older.

- \succ Homelessness and disability are interrelated issues that affect many people in the United States.
- \succ Homeless individuals are more likely to have a disability than the general population, and disabled individuals are more likely to experience poverty and inadequate housing than non-disabled individuals.
- \succ According to recent reports, about one quarter to one third of homeless people have a severe physical or mental disability.





Housing

- \succ Los Angeles is one of the most expensive housing locations in the United States that makes finding and maintaining an adequate residence challenging.
- \succ California has the highest percentage of cost burdened households in the US, nearly three-fifths spend more than one-third of their income on rent (Padilla-Frausto and Wallace, 2015).
- \succ High housing costs imposed by insufficient housing supply requires trade-offs for many older adults in meeting their personal needs for food sufficiency, medical care, in-home assistance and recreational choices (Joint Center for Housing Studies, 2015).
- \succ The problem is most acute for lower income older adults in Los Angeles, especially minorities, because housing is in short supply, and pressure for housing fosters gentrification and displaces lower income people. Heightening this dilemma, many older adults rely almost wholly on social security for income yet the amount received is not adjusted for cost of living, a big disadvantage for lower income people residing in a very high cost region such as Los Angeles (American Community) Survey, 2013).

The Department of Health Services (DHS) Housing for Health (HFH) Home Safe Enriched Residential Care (ERC) program provides placements in Adult Residential Facilities or Residential Care Facilities for the Elderly for at risk and unhoused individuals with complex health conditions who are unable to manage their health care needs or activities of daily living (ADLs) independently. • Between August 2023 thru April 2024, DHS served a total of 257





Client Challenges and Solutions

Older and dependent adults are often concerned about leaving their community.	AD has extended the length of time a client receipt to be connected to long term housing services.
Older and dependent adults are unique populations that require a longer-term intervention and more one-on-one support to secure housing stability.	AD has worked with LAHSA to extend the numbe fourteen to serve more clients.

State Proposed Budget Reductions

APS Home Safe

. .

- The proposed reduction of funds could jeopardize the Department's ability to provide services to approximately 700 clients who are currently enrolled.
- The proposed redistribution of Home Safe funds is based on CWDA Projected expenditures of over \$31M. However, Aging and Disabilities has projected expenditures of over \$53M.
- The proposed redistribution of \$5.4 million and the deferral of \$14.3 million will impact Los Angeles County's ability to continue services without interruption for clients that are currently enrolled in Home Safe.

Developmental Disability Services

• Delay in rate increases for disability services cuts \$1 billion, nearly half of which are federal dollars that would be lost, since the federal government matches a percentage of state funds used for developmental disability services.

Older Californian's Act Nutrition

• Proposed reduction of \$100 million in senior nutrition. The LA County region currently represents nearly 1/3 of allocated funding. Impact will be significant as the largest number of seniors in the state reside in LA County.

Older Adult Behavioral Health Initiative

 Statewide budget includes \$50 million over three years to fund the Older Adult Behavioral Health Initiative (\$20 million in 2023-24, \$20 million in 2024-25, and \$10 million in 2025-26). The initiative is to focus on addressing behavioral health and/or substance use disorder needs of older adults. The initiative has four main components: Community Capacity Building, Campaign to Reduce Behavioral Health Stigma and Isolation, Continuation of Older Adult Warmline, and State Oversight and Support.



Recommendations and Action Steps

Support legislation/funding that support older and disabled adults, especially initiatives to end homelessness among older and disabled adults.

- >Enhance collaboration with County departments to offer services to specialized or underrepresented populations: Veterans, GR Participants, In-Home Supportive Services Consumers, LGBTQ+, African-Americans and Tribal communities.
 - Ex: Los Angeles County Prevention & Promotion Systems Governing Committee focus on older adults for the Homelessness and Housing domain
- >Establish agreements/MOUs with other agencies to assist with providing housing resources to unhoused older and dependent adults.
 - Ex: Department of Military & Veterans Affairs Veterans Directed Care Program
 - Ex: Department of Consumer & Business Affairs Report On Increasing Banking Access For People Experiencing Homelessness (September 26, 2023)
 - Ex: Development Authority and Public Defender's Office Pilot for Housing for Justice Involved Older Adults
- Support creating a unit within AD to address the unique needs of older and disabled adults at risk or that are homeless.
