SUBJECT: Public Safety Realignment Implementation – August 2024 Update

#### Introduction

The Public Safety Realignment Team (PSRT) was established by the Board of Supervisors to coordinate the County's implementation of Public Safety Realignment (AB 109) and advise the Board on AB 109-related matters. Chaired by the Chief Probation Officer and comprised of multiple agencies and stakeholders, PSRT provides regular updates to your Board on focus areas and key activities of the committee.

This update addresses the PSRT's development of AB 109 funding recommendations for submission to the Chief Executive Office (CEO) and consideration during this year's supplemental budget cycle.

#### **Background**

The County allocates AB 109 funding during the supplemental budget phase. County departments may submit AB 109 funding requests to the CEO through the normal supplemental budget request process.

Per your Board's direction, PSRT may also provide funding recommendations to the CEO that align with County priorities. While PSRT does not manage the AB 109 budget or approve funding, its recommendations offer valuable input and guidance that help inform the CEO's funding recommendations to the Board.

PSRT approved a total of 15 funding recommendations for submission to the CEO at its June 20<sup>th</sup> and July 11<sup>th</sup> meetings,. These recommendations were the result of a thorough process with implementing departments and agencies to identify funding concepts, formulate and draft full funding recommendations, and vote on recommendations for submission. Key considerations during the PSRT recommendation development process included:

- AB 109 funding eligibility criteria;
- public safety responsibilities and mandates transferred to the County through AB 109;

- County justice priorities and the Care First approach; and
- goals and objectives developed by PSRT and approved by your Board.

Ultimately, recommendations approved by the PSRT complement the corresponding formal budget requests submitted to the CEO by lead implementing departments/agencies.

#### **Summary of Recommendations**

A summary of the 15 funding recommendations is attached. Submitted in conjunction with four different departments, the recommendations address:

- the establishment of a Justice-Involved Veterans Division by the Department of Military and Veterans Affairs;
- funding for specified victim services programs within the District Attorney's Bureau of Victim Services;
- four programs implemented by the Justice, Care, and Opportunities Department, including the Justice Connect Support Center, SECTOR, Rapid Diversion Program, and Reentry Intensive Case Management Services;
- the MacArthur Park Overdose Response Team led by the Department of Health Services – Office of Diversion and Reentry; and
- eight initiatives by the Department of Health Services to enhance in-custody health services provided by the Integrated Correctional Health Services Division.

As with all budget matters, the AB 109 budget process remains the responsibility of the CEO, and the office is currently evaluating these recommendations as part of the supplemental changes budget process. The CEO's recommendations will be provided to your Board at the supplemental budget presentation scheduled for October 8, 2024.
