I. Welcome & Introductions

Chair Williamson called the meeting to order at 1:08pm.

Chair Williamson introduced and welcomed new Board Member Abby J. Leibman, appointed by Supervisor Lindsey Horvath of Supervisorial District 3.

II. Approval of Minutes for the March 7, 2024, Regular Board Meeting

No public comment was given.

Moved by Board Member Tabatabi, seconded by Board Member Schulz, the motion carried with one abstention by Board Member Leibman.

III. General Public Comment

No public comment was given.

IV. Encampment Resolution Fund Program Update

Onnie Williams III of the CEO-HI provided a presentation on the state's Encampment Resolution Fund Round 3 award of which the County will receive almost \$52M to leverage with existing local funding to expand the Pathway Home program.

Discussion and clarifying questions ensued from Board Members Kerr, Leibman and Schulz regarding metrics and data around those returning to unsheltered homelessness, engaging with stakeholders surrounding encampments and partnering with them to secure interim housing for encampment resolution efforts.

No public comment was given.

Chair Williamson called for a recess at 1:40pm.

Chair Williamson recalled the meeting to order at 1:52pm.

V. Mortality Rate and Causes of Death Among People Experiencing Homelessness in Los Angeles County

Dr. William Nicholas, Director of the Center for Health Impact Evaluation, Department of Public Health provided a presentation on the mortality rate and causes of death among people experiencing homelessness in Los Angeles County for the year 2022. Dr. Nicholas' presentation also included recommendations on how to reduce the mortality rate.

Discussion ensued by Board Members Kerr, Schulz, Leibman, Tabatabi and Chair Williamson regarding harm reduction strategies and best practices, death rates related to substance use, encampments and environmental factors and their potential contribution to higher mortality rates, strategies on how to better communicate the narrative around equity and disparities in the demographics around mental health and substance use, and overall improvements in how this data is disseminated to faith-based partners and other stakeholders.

Public comment was given by Reba Stevens of the SPA 6 Coalition related to harm reduction and equity.

VI. Housing Acquisition Update

Elizabeth Ben-Ishai of CEO-HI provided a presentation on the County's efforts related to unit acquisition. Sophia Rice and Perlita Carrillo of Brilliant Corners expanded on unit acquisition to include strategies related to the Flexible Housing Subsidy Pool model.

Finally, Thomas Wong of the Los Angeles Homeless Services Authority (LAHSA) provided a presentation on LAHSA's centralized unit acquisition strategy and its benefits.

Discussion ensued from Board Members Tabatabi, Kerr, Schulz, and Chair Williamson regarding housing matching and those outside of the homeless services system competing for housing availability, investing in a broader population of subsidy holders outside of permanent supportive housing, LAHSA's ability to track all costs associated with unit acquisition in order to be fiscally responsible, and coordination with the Department of Mental Health.

Public comment was provided by community member Aliya Y around equity of housing placements.

Public comment was provided by community member Yuri regarding rent subsidy programs and restrictions around affordable housing.

VII. Adjournment

Chair Williamson adjourned the meeting at 3:47pm.

Greater Los Angeles Homeless Count –

LOS ANGELES HOMELESS SERVICES AUTHORITY

September 5, 2024

LAHSA performs the largest annual PIT Count in the United States as required by HUD for Continuums of Care (CoC) nationwide.

LAHSA's data is then reviewed and validated by HUD.


- The process is designed in partnership with data experts at USC with guidance from HUD to create an accurate census of unhoused people living in the Los Angeles CoC.
- The count is an imprecise estimate. It includes both specific numbers like shelter bed counts, along with estimates, observations, and statistical sampling.







This year, LA region's point-in-time estimate declined slightly – down 0.27% in LA County and down 2.2% in the City of LA.





Note: The 2023 Homeless Count was conducted on January 23 – 25, 2024.

Our unified response to unsheltered homelessness is contributing to meaningful change.


Percentage Change of People Experiencing Homelessness in County of LA

Across the County*, unsheltered homelessness dropped by 5.1%, while the number of people in shelter rose by 12.7%.





There are 29,823 people experiencing chronic homelessness in 2024.

42% of the total number of people experiencing homelessness are experiencing chronic homelessness according to the 2024 Los Angeles Continuum of Care Homeless Count.



43%* of people experiencing homelessness also reported being a victim of domestic violence.



LAHSA's Key Performance Indicators show people are moving through our rehousing system faster.

From 2022-2023, year over year, LA County increased street to interim housing placements through outreach by almost 50%.

Additionally, in the same timeframe, the number of people moving from interim housing to permanent housing increased by 25%.



The data continues to show that historic exclusionary racist policies still result in a disproportionate amount of black people experiencing homelessness.




54% of newly homeless unsheltered persons reported that economic hardship as a reason for falling into homelessness.*

What's different about this moment?

- Los Angeles has a coordinated path forward.
- LA area stakeholders, including providers, are coordinating.
- City and County of LA remain in a state of emergency.
- The State of California has financially supported encampment resolution efforts and enacted AB 977.
- The Biden/Harris Administration is supporting through ALL-Inside and HUD's focus on encampment resolution.

This level of alignment to address unsheltered homelessness is unprecedented.



- Sessions with People with Lived Experience (adults and youth)
- Homeless Service Providers

- Educational Stakeholders (new)
- BIPOC Advisory Groups (new)
- Faith-Based Partners (new)

Funding Recommendations FY 2025-26: Listening Sessions

- Solicit community and stakeholder engagement to strengthen strategies for addressing and preventing homelessness.
- In addition to informing our funding recommendations, CEO-HI will consider feedback received during these sessions throughout the fiscal year as we make ongoing systemwide improvements.
- These listening sessions will include an overview of last year's funding recommendations process as well as how Measure H and other funding streams are spent.
- These conversations will help ensure our strategies are responsive to our County communities' unique needs and priorities.

Blue Ribbon Commission on Homelessness Background

On July 27, 2021, the Los Angeles County Board of Supervisors approved a motion to establish the Blue Ribbon Commission on Homelessness (BRCH).

The BRCH was tasked to:

- Research/analyze various homelessness governance reports.
- Provide feedback regarding the most relevant and effective models, with the intention of implementing reform to help solve the homelessness crisis in LA County.
- Provide recommendations for a new governance model that is appropriate for LA County incorporating the diverse needs of the region, 88 cities, and the Unincorporated Communities.

CEO.

Blue Ribbon Commission on Homelessness Commissioners

BRCH composed of 12 Commissioners:

- 5 members appointed by the Board, with one member appointed by each Supervisor;
- 1 member nominated by the Mayor of Los Angeles*;
- 3 members nominated by the Los Angeles City Council President*;
- 1 member nominated by the Contract Cities Association; and
- 2 members nominated by the Councils of Government

^{*}City of Los Angeles did not appoint Commissioners to the BRCH.



Blue Ribbon Commission on Homelessness Report

The BRCH adopted and issued the BRCH Homelessness Governance Report on March 30, 2022.

Executive Level Action Team Overview Board Motion (May 2022)

On May 3, 2022, the Los Angeles County Board of Supervisors approved a motion that took the following actions:

- Adopt the seven BRCH recommendations.
- Instruct the Chief Executive Officer to maximize continuity of analysis and implementation of BRCH recommendations including Recommendation #7.

Recommendation #7: Encourage philanthropy to convene a small, no more than 10 person group of executive-level leaders representing Los Angeles County, its 88 cities, the State and other relevant stakeholders.



Executive Level Action Team Overview CEO Implementation

In the May 12, 2023 BRCH report back to the Board, the CEO recommended proceeding with the development of the executive committee and leadership table.

The proposed structure included:

- An **Executive Committee** made up of elected officials from cities and Los Angeles County who would develop one plan, align funding, and provide oversight.
- A **Leadership Table** made up of a diverse group of stakeholders to advance the strategies and help unite the region around the one plan and one effort.



Executive Level Action Team Overview Board Motion (Aug 2023) – Executive Committee

On August 8, 2023, the Los Angeles County Board of Supervisors approved a motion directing the Chief Executive Office to:

- Establish an **Executive Committee** of elected officials to develop one plan to address homelessness, establish a common set of performance indicators, align resources, and provide oversight.
- Partner with philanthropy to establish the Leadership Table to act as an advisory body supporting the work of the Executive Committee with the goal of uniting the region around one unified effort, guiding public education on the issue of homelessness, and aligning private funding in support of a regional plan.

Executive Committee for Regional Homeless Alignment - Role

- Brings city and county policymakers into a single collaborative body to make big decisions together about our regional response.
- Develop one plan and drive one effort regionally.
- Make collective decisions based on best available data and implement those ideas within each member's respective jurisdiction or area of influence.
- Work with the Leadership Table to identify the most effective strategies, scale solutions, align private and public funding, and communicate the vision.
- Provide candid and actional feedback throughout all decision-making processes.



- Help unite the region around one plan and one effort. The
 Table will include private funders, regional governments,
 advocacy groups, people with lived expertise, faith leaders, and
 the business community.
- Help calibrate strategies based on the data.
- With one trusted voice, lead on public education and hold the system accountable to the north star.
- Limit interference and overcome any obstacles within its sphere of influence that might disrupt implementation.
- Help align private sector funding in support of the regional plan.

Affordable Housing, Homelessness Solutions, and Prevention Now Transaction and Use Tax Ordinance



- June 18, 2024 the ordinance was ratified to qualify for the November 2024 ballot.
- June 25, 2024 LA County Board of Supervisors adopted the ordinance without alteration.
- November 4, 2024 Measure A on ballot for voter consideration.



Affordable Housing, Homelessness Solutions, and Prevention Now Transaction and Use Tax Ordinance

"...this Ordinance has **five goals**:

- 1. Increase the number of people moving from encampment into permanent housing to reduce unsheltered homelessness;
- 2. Reduce the number of people with mental illness and/or substance use disorders who experience homelessness;
- 3. Increase the number of people permanently leaving homelessness;
- 4. Prevent people from falling into homelessness; and
- 5. Increase the number of affordable housing units in Los Angeles County."



Affordable Housing, Homelessness Solutions, and Prevention Now Transaction and Use Tax Ordinance

The Executive Committee **shall evaluate progress toward goals..., with an emphasis on goals 1, 2, and 3**; and the Housing Agency shall evaluate progress towards the goals..., with an emphasis on goals 4 and 5.

... based on input and recommendations from the Leadership Table; relevant County staff; and stakeholders, including service providers contracted to provide services like those to be funded by the tax imposed by the Ordinance, affordable housing developers, and renter protection organizations.

No later than **April 1, 2025** the Executive Committee and Housing Agency shall each **formulate baseline and target metrics**...



Affordable Housing, Homelessness Solutions, and Prevention Now Transaction and Use Tax Ordinance

No later than October 1, 2031, the Executive Committee and the Housing Agency shall formulate new baseline and target metrics informed by the annual evaluation agenda and prior program performance. The Executive Committee shall evaluate progress towards these new metrics at least every five years thereafter and make recommendations to the Board of Supervisors and the Housing Agency.



Affordable Housing, Homelessness Solutions, and Prevention Now Transaction and Use Tax Ordinance

For each goal for which the target metric has not been achieved as of December 31, 2030, the Executive Committee **shall make recommendations** to the Board of Supervisors and the Housing Agency **to redirect funds to or away from specific programs.**

If any of the target metrics have not been achieved, the Executive Committee shall recommend reallocations among County programs and among Housing Agency programs, respectively, of between 2.5% and 5% of the total allocation to each of the County or the Housing Agency.



Affordable Housing, Homelessness Solutions, and Prevention Now Transaction and Use Tax Ordinance

The Executive Committee, with input from the Leadership Table, shall *develop best practices for standardization of care*, including but not limited to connections to behavioral and mental health, medical care, and other services. These best practices should *include guidance and key performance indicators* for contractors and Funding Recipients.
