### PREVENTION

In 2023, our rehousing system permanently ended homelessness for more than 27,400 people. **If we sustained this emergency response, and prevented any more inflows into homelessness, then we could end homelessness in <u>less than three years</u>.** 

The goal of the Homeless Initiative's prevention efforts is to **reduce inflow into the homeless response system**.

The most effective way to reduce inflow is by **focusing on households** who are experiencing housing instability and are at greatest risk of becoming homeless.

## PREVENTION Landscape

(1) **A recently coordinated prevention strategy**: Efforts to build solutions and infrastructure to address homelessness have historically focused on those who have already fallen into homelessness.

(2) **Not funded at scale:** Prevention efforts aimed at reducing inflow into the homeless services system have insufficient funding.

(3) **Does not address main driver:** The lack of available, affordable housing is the primary cause of inflow into homelessness.

### **PREVENTION Countywide Efforts**

### Prevention and Promotion Systems Governing Committee (PPSGC)

- Established July 2023
- 9-member body: Directors of County Departments and/or County Initiatives, and a non-County entity (all Board-appointed)
- Purpose is to improve collaboration and coordination of the infrastructure, services, and supports that prevent negative outcomes *and* help residents thrive.


### Prevention and Promotion Coordination Implementation Team (PPCIT)


- Made up of program and agency leads
- Provide inventories of prevention services and programs, and their funding sources/restrictions
- Purpose is to convene and facilitate coordination across County department

How the Prevention and Promotion Systems Governing Committee and the Prevention and Promotion Coordination Implementation Team Work Together

### **Governing Committee**







PPCIT...

- Convenes Funding Stream Analysis workgroup
- Secures consultants/technical assistance as needed
- Coordinates with other workgroups (e.g., legal analysis)
- Presents recommendations/work products to the Governing Committee

## **PREVENTION High-Risk Factors**

### Income & Housing

- 50% AMI or lower.
- Prior experiences of homelessness.
- Living without a lease.

### Household Composition

- Head of household younger than 25 (particularly those with system involvement)
- Head of household older than 65
- Pregnancy or children under the age of one
- Major life events, such as death of parent who is a leaseholder

### **Other Factors**


- Justice impacted, including arrest
- Chronic health conditions
- Disabling conditions



Predictive Modeling Categorically High Risk Populations

### **PREVENTION** Three-Pronged Approach



**Centralized Access** to create a multi-jurisdictional streamlined access point with screening tools to triage those in need of prevention resources.

**Enhanced Programming** by funding efforts to support those at highest risk of becoming homeless.

Centralized Access and Enhanced Programming <u>Key features</u>

**Client-Centered** Multi-Jurisdictional

High-risk factors for enhanced programming include:


✓ Disabling conditions

Access Oriented

- Head of housing older than 65
- ✓ 50% AMI or lower

- ✓ Living without a lease
- ✓ Head of household younger than 25

### **PREVENTION Three-Pronged Approach**



**Predictive modeling** to identify individuals and families who are most at risk of losing their housing within the next 12 months.

> Key features Proactive Data-driven Client-centered


Predictive Modeling

### Over 400 features produce the High-Risk List\*, including:

- ✓ DHS Emergency Room Visits
- ✓ DMH Crisis Stabilization Holds
- ✓ Application for public benefits through DPSS
- ✓ Arrests/interactions with Probation
- Lists are sent to HPU for outreach, care and coordination

Managed by LA County Department of Health Services, Homeless Prevention Unit

### **KEEPING PEOPLE HOUSED:** Three-Pronged Approach



**Population focused** dedicated programs for those who are categorically at high risk of homelessness and who may have unique needs.

### Key features

Proactive

Data-driven Client-centered

Categorically High-Risk Populations

- Older Adults (especially those using County safety net services)





## **Eviction Defense Efforts Timeline**

### September 2019

The Board directed DCBA to research, develop, and launch an expanded eviction defense program by first quarter of CY 2020

### June/September 2020

DCBA launched the EEPP in June and in September launched the comprehensive, branded eviction defense program known as Stay Housed L.A.

The Board adopted a local COVID-19 Emergency resolution and directed DCBA to launch an emergency eviction prevention program

**March 2020** 

The Board directed DCBA to report back with an implementation plan to make Stay Housed L.A. a permanent program as part of a universal access to legal representation strategy to be implemented Countywide by 2030

September 2022



### July 2023

The Board directs County Counsel and DCBA, in response to an April 2023 DCBA report back, to return within 10 months with a draft Right to Counsel Ordinance for adoption

> The Board unanimously approves a Right to Counsel Ordinance for the Unincorporated areas of LA County to become effective January of 2025



A countywide program that operates as a first line of defense against mass evictions and potential homelessness

First-of-its-kind partnership between the County of L.A., the City of L.A., the City of Long Beach, tenant-led community organizations, and legal service providers





## **Eviction Defense Funding Allocations Since Inception**


Stay Housed L.A. County Funding Allocations (since July 2020 - July 2026)


Reached **1,564,287** tenants in Los Angeles County with workshops, clinics and tenant navigation services. Provided limited legal services and assessments to **22,204** tenant households. Provided **\$3,802,784** in financial assistance disbursed (as of July 31, 2024).

## **To-Date**



Provided full-scope legal representation to **3,420** tenant households.

## Stay Housed LA Outcomes\*



\*Outcomes from closed full scope cases for the County's program (September 2020 through July 2024)

 Tenant Stayed in Home: Tenants remained in their homes

• **Soft Landing:** Tenants negotiated a soft landing to prevent homelessness including extra time to move-out, moving expenses and a sealed eviction record

• Other: Tenants had some other outcome including prevention of harassment, enforced habitability rights, preservation of housing benefits, obtained advice regarding housing matters, etc.

• Unknown: No record of outcome due to incomplete data from early pandemic efforts

• Lost in Court: Tenant lost case in court

- SoCal)

• Cassandra started falling behind on her rent after becoming disabled

 Cassandra worked with Stay Housed LA Partner- Community Legal Aid SoCal (CLA

• CLA SoCal identified an error on landlords' Notice to Pay Rent or Quit which overstated the amount that Cassandra owed

• Los Angeles Superior Court dismissed case based on misinformation and Cassandra was able to stay in her home

- Yesenya is a 65-year-old women diagnosed with a disability.
- She rents a mobile home where she relies on help from her daughter to pay the rent.
- In May 2023, Yesenya was hospitalized with Covid-19. At the same time, her daughter feel ill and could no longer help with rent.
- Yesenya worked with Stay Housed LA Partner, Legal Aid Foundation of Los Angeles (LAFLA).
- LAFLA helped Yesenya apply for low-income housing, provided moving assistance to cover her security deposit/first month's rent and sealed her eviction record.
