

NEUROCOGNITIVE DISORDERS TEAM

2023 CPDA Defender Program of the Year 2024 Gold Eagle Award Recipient

Dedicated to defending clients with cognitive impairments such as dementia, traumatic brain injuries, and developmental disabilities. This innovative team, consisting of trained attorneys, social workers, and mental health professionals, provides holistic legal representation that addresses both the legal and medical needs of vulnerable clients. By working closely with medical experts and advocating for alternatives to incarceration, the NDT ensures fair treatment within the justice system for individuals whose conditions impact their decision-making and behavior.











The RRT, an unfunded pilot program made up of volunteers, is composed of approximately 30 attorneys across Los Angeles County and includes fluent speakers in six languages.

Since its inception in May 2023, the RRT has deployed 18 times and assisted nearly 300 persons across all five Supervisorial Districts.

Using teamwork, diligence, and professionalism, the RRT has contacted arrested individuals to provide critical information necessary for navigating the criminal legal system.

RAPID RESPONSE TEAM (RRT)



Collaborations – Community Outreach Court (COC)

Our primary objective is to assist persons experiencing homelessness in resolving various legal matters, thereby eliminating barriers to accessing social services and securing housing. COC has aided over 100 unhoused individuals with record clearance, ticket relief, warrant resolutions, and housing assistance.

By offering services such as clearing eligible bench warrants, expunging convictions, resolving misdemeanor cases and citations, addressing outstanding fines and fees, and facilitating connections to reentry and job opportunities, COC aims to streamline the criminal court process and ultimately support the transition of individuals experiencing homelessness into stable housing situations.





Collaborations – Rapid Diversion Program

RDP is a cooperative diversion program run by the Justice Care and Opportunities Department (JCOD) in collaboration with the Public Defender and Alternate Public Defender, City Attorney, District Attorney, LASD, DMH, Exodus, Project 180, and LA Superior Court.

Over 6000 clients have been screened with over 2,200 cases diverted. RDP has celebrated over 700 graduations resulting in no criminal record for those clients, with 93% of graduates having no further contact with the criminal legal system.

DPDs Nick Stewart-Oaten and Caroline Goodson and APD Kelly Buck named LA County Bar Association's Defense Attorneys of the Year for 2024.







Collaborations – Partners For Justice

(PFJ)

This project increases LACPDO and LACAPD's capacity to provide holistic representation and assist clients with the underlying needs or challenges driving their involvement in the legal system. Collectively, we have 27 client advocates (18 LACPDO, 9 LACAPD) providing holistic, wrap-around support to stabilize clients, promote wellness, and reduce days of incarceration across the County. Through this project, we have referred nearly 800 clients to work with advocates.

What do Public Defender Psychiatric Social Workers (PSWs) Do?

Collaborate	Collaborate with Public Defenders to identify the psychosocial needs of the individuals represented by each office
Meet	Meet with clients, in or out of custody, to conduct psychosocial assessments, develop and review treatment and disposition plans
Interview	Interview family members and others requested for purposes of assisting with disposition recommendations/reports and memos
Request and Review	Request and review records in order to develop clinical recommendations

Provide	Provide all necessary services; including wellness checks on clients in custody, client and family support, advocacy, consultation, linkage to services and referrals

Attend	Attend court to speak informally and formally on behalf of the client
Collaborate	Collaborate with the primary mental health/substance use provider, Probation, PD Attorney, DA and judges

Collaborations - Client Engagement and Navigation Services (CENS)



The DPH - Substance Abuse Prevention and Control program is embedded in 11 LACPDO offices and courthouses throughout LA County. CENS provides assessment and linkage to substance use programs available to clients.

From July 2023 to April 2024, there were 2,676 unique clients screened at in those courthouses.



Collaborations - DMH Court Linkage Program The DMH - CLP is embedded in 22 LACPDO offices and courthouses throughout LA County.

This program incorporates the "no wrong door" philosophy by offering the courtroom as an entry point for services. The objectives of the program are to increase coordination and collaboration between the criminal justice and mental health systems, improve access to mental health services and supports, and enhance continuity of care.






Collaborations – Office of Diversion and Reentry (ODR)

PD/APD/IDCO teams advocate for clients to receive ODR services including mental health treatment and permanent supportive housing for unhoused individuals with Serious Mental Illness (SMI)

Total ODR Clients as of 4/10/24: 1,475 90% are LACPDO clients





IDCO: From Concept to Launch

Development, Enhancements, Implementation and Growth



Key Milestones

BOS elected to transition LA County's Assigned Panel Program from LACBA to PD in December 2022, with a launch of July 1, 2023. In response, we developed and implemented an ethically walled-off operation model to assure a seamless transition within 6 months, including:

- Preparation and submission of budget proposal for IDCO
- Creation of IDCO email domains, Workplace Portal, and communications infrastructure
- Development of customized case management system
- Development of public-facing website
- Location and build-out of office space at Metropolitan Courthouse
- Onboarding and training of IDCO team members
- Stakeholder and community outreach



IMMEDIATE PROGRAM ENHANCEMENTS:

- Attorney training
 - over 200 training programs offered to panel attorneys
- 20% hourly fee increase for all grade level cases
- Provision of legal research subscription services such as ceb onlaw and lexis/nexus
- Elimination of all panel membership fees
- Implementation of case management system
- Attorney panel recruitment and retention
