Approved Countywide Definition of GBV*

Gender-Based Violence is defined as violent acts or a pattern of acts of assault, threats, humiliation and intimidation or other abuses that are used to harm, punish, or frighten due to a person's identified or perceived gender or sexual identity. GBV includes, but is not limited to, domestic violence, intimate partner violence, gendered cyber abuses, sexual harassment, sexual assault and exploitation, trafficking, homophobic and transphobic abuses.

Gender Based Violence Focus Areas

- Prevention: Implement a multi-disciplinary, GBV primary prevention strategy.
- Coordination: Assemble a coalition of County departments, academia, community stakeholders, philanthropy, and individuals with lived experiences to identify and dismantle systems that have led to or perpetuate gender-based violence and oppression.
- Resources and Programming: Support funding for programs and services that have proven results in harm reduction and/or use best-practices in the provision of prevention services and programs.
- Data Collection: Work with stakeholders to establish metrics and methods for continual data collection and sharing for evaluation, pattern identification, trend forecasting, and funding requests.
- Legislative Advocacy: Collaborate with stakeholders and partners to identify proposed legislation and gap areas that would improve systems and reduce barriers to disclosing violence.



Progress Updates: Focus Areas



Gender Based Violence Focus Areas Updates

- Prevention: OVP is currently surveying county departments to understand the landscape of county prevention and intervention programs, services and funding related to gender-based violence. Next steps will include working with community partners to understand their work around gender-based violence and continuing our research to learn from other jurisdictions.
- Coordination: OVP is utilizing our networks and county and community governance structure to coordinate with existing partners and to understand where there are gaps in representation. We continue to coordinate with Public Health's Office of Women's Health and Domestic Violence Council on issues of domestic violence, sexual violence and trafficking and to conduct outreach to enlist new partners including academia, philanthropy, and individuals with lived experience to involve in the work to increase access to services and dismantle systems that have led to or perpetuate genderbased violence.



Gender Based Violence Focus Areas Updates

- Resources and Programming: OVP is working with the Center for Strategic Partnerships to identify a Third-Party Administrator(TPA) to invest \$2M for prevention programs and services in 4 categories: teen dating violence, engaging men and boys, engaging LGBTQ+ youth leaders, and innovative financial empowerment strategies for girls.
- Data Collection: OVP has created an open data portal to publicly share and increase access to data on violence broken down by demographic groups including by gender. We are creating additional dashboards with a focus on intimate partner violence and sexual assaults. We will continue to work with county and community partners to establish metrics for tracking outcomes related to gender based violence.
- Legislative Advocacy: OVP will work with stakeholders, partners and Government Affairs to identify legislation and policy areas that would improve systems and reduce barriers to disclosing violence.





Emergency Department Visits for Sexual Assault by Year, LA County Residents, 2018-2022



Intimate Partner Homicides & Other Homicides by Year




Between 2017 and 2022 210 homicide victims were killed by a current or former intimate partner.

This is 5% of the 4,139 total homicides reported during that time.



Sex of Homicide Victims by Relationship Between Victim and Suspect, 2017 - 2022




* Includes homicides where victim and suspect were strangers and incidents where the suspect was not identified so the relationship between victim and suspect was unknown.

Other Highlights from HRC Hate Crime Report:

72% of all hate crimes were violent.

91% of crimes motivated by gender were violent.

85% of crimes motivated by sexual orientation were violent.



GBV Comprehensive Gap Analysis

- The CEO Report highlighted feedback from stakeholders and partners that indicated that a gap exists in understanding the landscape of communitybased primary prevention services including funding amounts and funding streams.
- It was recommended that OVP conduct a comprehensive gap analysis of county departments and community providers.

Opportunities

- Countywide training on resources, Trauma Informed Care, GBV signs and resources for County staff
- Expand education to younger audiences about GBV and healthy relationships; leverage social media
- Improve data sharing; more place-based data collection
- Better coordination and response across County systems
- Working with perpetrators
- Leveraging doctors and ER practitioners to identify signs of trafficking and GBV



County Department Landscape Analysis

- Survey was sent to County Departments on 11/07/24.
- The survey will capture information on the landscape of GBV services provided by county departments including primary prevention and intervention services and resources; what data is collected and how is it shared; budgets and funding streams; and gaps, needs, and opportunities for enhancing service provision by geography.
- Survey results will be summarized and shared via written report by 12/15/24.



Update: Staffing and Budget



GBV Staffing and Budget Updates

- **Hiring:** Interviews being scheduled for Public Health Nurse Coordinator.
- Grant Funding: Working with Center for Strategic Partnerships to identify a Third-Party Administrator (TPA) and drafting Scopes of Work to fund local CBOs in each Supervisorial District to implement prevention strategies in four areas:
 - Healthy Relationship Education and Training
 - Engaging Men and Boys
 - Innovative Programs to Engage LGBTQ+ Youth
 - Economic Empowerment Strategies for Girls

Update: Los Angeles County Sexual Assault Council




Establishing the Sexual Assault Council (SAC)

The purpose of LAC SAC is to assemble multiple sectors and individuals with lived experience that have a connection to sexual violence to coordinate across systems, facilitate communication, and create alignment between public safety agencies, healthcare providers, legal systems, survivors, county, and community partners that will allow for better service collaboration and integration, and therefore, better support survivors and more adequately meet the needs of the community.



Sexual Assault Council Community Session

- On October 28, 2024, OVP held a Community Session to share information about the Sexual Assault Council, how to apply to be on the Council and offer an opportunity to provide input on priorities.
- 70 participants from multiple sectors including CBOs, community members, law enforcement, SART Center staff, Rape Crisis Centers, and DV organizations.





SAC Community Session Recommendations

- **Training:** Need for "best-practices" and "evidence-based" training.
- Advocacy: Need for more rape crisis center advocates, and therapists.
- Data: Need for more SART Center and service provider data and not relying solely on emergency room and law enforcement data. Need for more standardized data collection practices.
- **Collaboration:** Need for better collaboration and coordination with mental health, homelessness services, domestic violence, school districts, emergency rooms, and healthcare providers among others.



SAC Community Session Recommendations

- **Campaigns** –posting at bus stops, bathrooms, and community centers.
- Definitions Establish common definitions for sexual assault.
- Faith-based Partnerships include faith-based agencies at the table.
- Follow-up Services There is a gap in following up beyond the immediate aftermath of a sexual assault.



SAC Community Session Recommendations

Crossover with GBV planning:

- Education and Training (by-stander, evidence-based)
- Data Collection and Sharing

Recommendations on where to focus efforts:

- Black Women and Girls
- Underserved communities
- Indigenous communities
- LGBTQ+
- Prevention strategies starting in grade school
- Engage parents
