Homeless Initiative

Motion on September 24, 2024: Establishing a Regional Emergency Response Center.

- **Primary goal:** serving the needs of unsheltered people experiencing homelessness, leveraging and fully utilizing all resources, and finding the most appropriate intervention for each person, and working toward a unified regional solution.
 - Key components/directives
 - Centralize decision makers from regional stakeholders at one location to address encampment resolutions, public works operations, shelter occupancy, outreach priorities, and cross jurisdictional coordination.
 - Critical departments on site fulltime include DMH, DPH, DHS, LAHSA, LASD.
 - Supporting departments to assign liaison for linkages.
 - Offer the City of LA and other jurisdictions to join ECRC.
 - Real time updates on outreach efforts, resource availability, program enrollments.

Workgroups

- Design Team with all entities referenced in the Board motion (50+ members)-met weekly
- Five workgroups met weekly

ECRC Objectives



Establishing a site with staff from the LA County Homeless Initiative (CEO-HI), Departments of Mental Health, Health Services, Public Health, the Los Angeles Homeless Services Authority (LAHSA), LASD, MVA and others to provide the following for elected officials, jurisdictions, and governmental agencies.

- · Centralizing coordination for outreach efforts and encampment resolutions
- Producing real-time updates on encampments or unsheltered individuals
- · Linkages to interim housing and other mainstream services for unsheltered individuals
- Supporting the LA County Office of Emergency Management in the coordination of life-saving responses during emergencies or inclement weather for people experiencing unsheltered homelessness.

ECRC Scope

Strategic Focus: Central coordinating entity to oversee and direct daily operations for unsheltered individuals across LA County.

- In-Person Coordination Center: Co location space that includes a call center and focuses on outreach coordination, supporting outreach teams and providing real time updates from the field.
- Information Hub: Collect and share information about all activities the County supports relative to unsheltered homelessness (e.g., encampment resolutions, cleanups, life-safety missions, County services, etc.).
- Reliable and Real Time Communications: Capable of responding to elected local officials and jurisdictions with accurate and timely information on outreach activities.
- Outreach Mapping & Prioritized Deployment: Maintain a map of all LA County and the respective team assignments to each geographic hub; and help maximize impact by aligning and deploying those assets based on strategic priorities and geographic assignments in partnership with service providers.
- Encampment Locations: Maintain an accurate understanding of encampment locations through mapping, coordination and unsheltered tracking systems.
- Bed Inventory & Access Coordination: Maintain bed availability information and host Air Traffic Control Triage to make placements quickly and efficiently.
- Service Linkages/Program Enrollments: Link individuals to County services and make warm hand offs to programs.
- Crisis Management: Streamline decision-making and coordination during severe weather and other crises affecting unsheltered individuals in coordination with any unified command systems and structures established by CEO-OEM, if applicable.

Develop a comprehensive information hub around encampment locations to prioritize outreach deployment and coordination. Create a contact center for local elected officials, jurisdictions and key system leaders.	Implement an interim housing air traffic control to access beds quickly. Implement linkages to program enrollments and service linkages/connections	Secure metrics from each working group and determine methodologies to collect the applicable data for reporting purposes. Develop ECRC technology and tools to operate and track outcomes.	Develop the messaging and materials that enable clear communication to internal and external ECRC stakeholders.	Identify how the ECRC will work with the County's existing emergency management systems and infrastructure to streamline decision-making and coordination during severe weather and other crises impacting unsheltered.

ECRC Next Steps

- Soft launch on December 9th when County departments (DHS, DMH, DPH), LAHSA, LASD, and LA City CAO reported to ECRC site.
 - Working on operational processes and beginning to process cases.
- **Finalize Call Center Flow**
- Working to secure a call center technology contractor using Microsoft Dynamics.
 - On site team will help inform the process
- Five new ECRC call center staff are in hiring process, including a director
- DPSS to assign a staff to join fulltime.

- Working with ISD to address debris removal on former encampment site to mitigate repopulation (City of Downey)
- Triaged support for a Board office on homeless activity in the City of Whittier

Red Flag Warning/Franklin Fire Malibu

- Leveraged Working Group Roles/Responsibilities Matrix
- Participated in Unified Communication Group Calls
- Alerted MDT to be on call
- Streamlined situational awareness communications between LASD, DHS, and CEO-HI
- Ensured interim housing was on standby for any potential placements

Measure A Goals & BOS Deadlines






- By April 1, 2025 the BOS must approve baselines and metrics as recommended by ECRHA
- By April 1, 2025 the regional plan must be approved by BOS

The five Measure A goals are:

- 1. Increase the number of people moving from encampments into permanent housing to reduce unsheltered homelessness;
- 2. Reduce the number of people with mental illness and/or substance use disorders who experience homelessness;
- 3. Increase the number of people permanently leaving homelessness;
- 4. Prevent people from falling into homelessness; and
- 5. Increase the number of affordable housing units in Los Angeles County.
