- Program 24: Reasonable Accommodations Ordinance Update and Removal of Zoning Barriers to Fair Housing
- Program 29: Housing Types Definitions Program



## **Types of Proposed Changes**

#### **1. State Mandates**

• Changes that incorporate requirements in state law

### 2. County Code Technical Update

- Changes not directly mandated by state law but are meant to maintain consistency between state and local regulations
- Changes aim to maintain consistency across housing ordinances for ease of implementation
- Technical "clean-up" for clarity and other corrections

#### **3. Additional County Local Changes**

- Local changes to carry out the County's housing policies in four areas:
  - 1. Create new affordable housing
  - 2. Preserve existing housing stock
  - 3. Expand housing choices
  - 4. Promote fair housing
