SUBJECT:	Public Safety Realignment Implementation – July 2025 Update

The Public Safety Realignment Team (PSRT) was established by the Board of Supervisors to coordinate the implementation of public safety realignment (AB 109) and advise the Board on AB 109-related matters. Chaired by the Chief Probation Officer, PSRT provides regular updates to your Board on its focus areas and key activities.

This report summarizes PSRT's recent efforts related to the development of AB 109 funding recommendations for submission to the Chief Executive Office (CEO) for consideration during Fiscal Year 2024-25 and Fiscal Year 2025-26 budget cycles.

Background

Estimates of available AB 109 funding are updated each year following the release of the May Revision to the Governor's Budget. As such, the County typically budgets AB 109 funding during its Supplemental Changes budget phase.

Departments submit AB 109 funding requests to the CEO through the normal budget process. In addition, per your Board's direction, PSRT submits funding recommendations that align with County priorities. While PSRT does not manage the AB 109 budget or approve funding, its recommendations offer valuable input and guidance that help inform the CEO's funding recommendations to the Board.

Key considerations during the PSRT recommendation development process include:

- AB 109 funding eligibility criteria;
- public safety responsibilities and mandates transferred to the County through AB 109;
- County justice priorities and the Care First approach; and
- goals and objectives developed by PSRT and approved by your Board.

Ultimately, recommendations by the PSRT complement corresponding formal budget requests submitted to the CEO by lead implementing departments/agencies.

Recent AB 109 Funding Recommendations

In the Fiscal Year 2024-25 Supplemental Changes budget, \$23.4 million in one-time AB 109 funding was set aside for PSRT to develop programming recommendations. In response, the committee submitted 20 funding recommendations to the CEO in two phases.

Phase I: PSRT first considered recommendations that had been approved by PSRT in previous budget cycles and were deemed appropriate for re-submission – either because they were not previously funded or because they would provide bridge funding enabling a program's continued operation. In Phase I, PSRT approved four funding recommendations totaling \$12 million for submission to the CEO.

Following CEO review and evaluation, all four recommendations were incorporated in the CEO's proposed Mid-Year Budget Adjustments 1. They were approved by your Board on February 18, 2025, and included the following:

<u>Phase II</u>: In Phase II, PSRT approved 16 new funding recommendations during its February and March meetings for submission to the CEO. The recommendations totaled \$30.5 million – exceeding the remaining funding available – and were submitted for review and evaluation by the CEO for the Fiscal Year 2025-26 Final Changes budget process.

Five of the submitted recommendations were ultimately incorporated into the CEO's proposed Final Changes budget. They were approved by your Board on June 23, 2025, and included the following:

Fiscal Year 2025-26 Supplemental Budget Phase

As AB 109 funding is typically allocated during the supplemental budget phase, PSRT is currently developing recommendations for the use of new FY 2025-26 funding for CEO review. The CEO estimates that \$4.596 million in one-time AB 109 funding is available for FY 2025-26 supplemental changes.

PSRT's recommendations will be provided to the CEO in mid-July. It is anticipated that the submissions will be based on the committee's most recent recommendations that were not funded during the final changes budget process.
