Briefly provide a description of the incident/event:	Summary Corrective Action Plan 2023-144
	Details in this document summarize the incident. The information provided is a culmination of various sources to provide an abstract of the incident.
	Multiple investigative reports indicate on October 6, 2019, at approximately 2010 hours, deputies assigned to the Pico Rivera Station were dispatched a call for service for a family disturbance. While deputies were responding, the call was updated indicating the Decedent was armed with a machete knife. Several units responded with lights and siren. Upon their arrival, they immediately contacted several family members outside the residence.
	Family members informed deputies the Decedent was no longer armed with the machete, and he never threatened to harm anyone with it. The family hid the machete from the Decedent underneath the living room couch. Family members also informed the deputies the Decedent was suffering from a medical issue and was possibly under the influence of drugs. After speaking with the Decedent's family, they attempted to contact the Decedent but he refused to exit the residence. Via a cellular phone, the Decedent's family members and deputies tried to convince him to exit, but he refused to cooperate with the deputies.
	The Department's Mental Evaluation Team (MET) arrived to conduct an evaluation of the Decedent, but he remained inside the residence. Although a clinician was able to speak with the Decedent over the phone, they were unable to properly evaluate him. After spending approximately two hours at the scene trying to gain his cooperation, deputies determined that the Decedent had not committed a crime and he was not a danger to himself or others.
	Seargent One decided, based on the totality of the circumstances and their investigation, it was best to leave the location. Prior to sheriff personnel leaving the location, they suggested to the Decedent's family they should leave for the night.

Document version: 4.0 (January 2013)

The Decedent's family stated they were not afraid of the Decedent; however, they did plan to leave the location.

Approximately thirty minutes later, the Pico Sheriff's Station received another call for service at the location. The caller stated that the Decedent rearmed himself with the machete and was stating he wanted to be shot by deputies. When deputies arrived, they gathered quickly to establish a tactical plan on how to proceed.

As they planned, several family members ran out of the residence and out onto the street and appeared to be frightened.

Deputies heard someone screaming from the direction of the residence and they ran toward the entrance of the residence's driveway. Personnel noticed the Decedent held onto a large kitchen knife and made slashing motions with it toward a woman standing in front of him.

When deputies ordered the Decedent to drop the knife, he turned toward the deputies and began to run toward them. When the Decedent came within several feet of the deputies, a deputy involved shooting occurred. The Decedent was struck several times by the deputies' gunfire. Also, the gunfire inadvertently grazed a male family member of the Decedent.

Department personnel attempted to begin life saving measures, but they were hindered by family members who laid on top of the Decedent. Once family members were removed, personnel began to provide medical aid to the Decedent until they were relieved by the fire department paramedics. The Los Angeles County Fire Department paramedics contacted the hospital where the attending physician pronounced the Decedent deceased.

The incident was investigated by the Sheriff's Department Homicide Bureau to determine if any criminal misconduct occurred.

The Los Angeles County District Attorney's Office, Justice System Integrity Division, completed its review of the shooting and determined there was insufficient evidence to disprove Sergeant One and Deputies One and Two, did not act lawfully in self-defense at time they fired their weapons.

1. Briefly describe the **root cause(s)** of the claim/lawsuit:

A **Department** root cause in this incident was deputies' use of deadly force.

A **Department** root cause in this incident was the sergeant and deputies did not have equipment (Body-Worn Camera) to video record their contact with the plaintiff, in order to prove or disprove the plaintiff's allegations.

A **non-Department** root cause in this incident was the Decedent's failure to comply with the lawful orders given by the Los Angeles County Sheriff's personnel.

2. Briefly describe recommended corrective actions: (Include each corrective action, due date, responsible party, and any disciplinary actions if appropriate)

### **Criminal Investigation:**

The incident was investigated by the Sheriff's Department Homicide Bureau to determine if any criminal misconduct occurred.

On August 24, 2022, the JSID determined there was insufficient evidence to disprove Sergeant One and Deputies One and Two, did not act lawfully in self-defense at the time they fired their weapons.

### Administrative Investigation:

This incident was investigated by representatives of the Sheriff's Department's Internal Affairs Bureau to determine if any administrative misconduct occurred before, during, or after this incident. The results of the investigation were presented to the Executive Force Review Committee (EFRC) for adjudication. On June 15, 2023, the EFRC determined the use of deadly force and tactics were within Department policy (Los Angeles County Sheriff's Department Manual of Policy and Procedures 3-10/200.00 Use of Firearms and Deadly Force). The Panel had no corrective action recommendations. South Patrol Division Acting Chief concurred with the Panel's findings and recommendations.

Although the tactics and Use-of-Force used in this incident were found to be within Department policy, Sergeant One and Deputies One and Two received additional training pertaining to the circumstances surrounding this incident.

# **Body-Worn Cameras (BWC)**

As of May 30, 2021, all personnel assigned to Pico Rivera Station were issued a Body-Worn Camera in an effort to ensure all public contact is transparent. The use of BWC's ensures reliable recording of enforcement and investigative contacts with the public. The Department established policy and procedures for the purpose, use, and deployment of the Department issued BWC

### **Tactical Debriefing**

In the days following the incident, personnel were briefed on the events known at the time and based on information provided by Homicide Bureau investigators. Special focus was placed on officer safety, tactical preparedness, and lessons learned to assist employees if they ever find themselves in a similar situation. Briefings occurred on all shifts and were given by the field sergeants and watch commanders.

#### Station Training

Field Operations Support Services (FOSS) sent a department wide email on October 19, 2022, and September 29, 2023, regarding Newsletter 16-003 – Calls for Service Involving Alleged Mentally Ill Persons. This topic was thoroughly discussed during Pico Rivera Station pre-shift briefings and continues to be a recurrent briefing topic. Deputy sheriffs assigned to Pico Rivera Station will continuously be scheduled to attend critical incident training with the Department's Tactics and Survival (TAS) Unit. Classes will be scheduled utilizing the Department Situation Simulation Trailer and the Multiple Interactive Learning Objective platform. Pico Rivera Station field training officers have already attended this training as a group.
