The information provided is a culmination of various sources to provide an abstract of the incident.</b></p> <p>Multiple investigative reports indicate, on July 5, 2022, at approximately 5:00 p.m., two on-duty Los Angeles County Sheriff's Department Deputy Sheriffs, assigned to Pico Rivera Sheriff Station, responded to a "McDonalds" parking lot regarding a physical altercation between the Decedent and his boyfriend (Victim). The Deputies detained the Decedent pending their investigation. Upon the conclusion of their investigation, they placed the Decedent under arrest in violation of California Penal Code Section 273.5(a) - Corporal Injury to a Cohabitant.</p> <p>Deputy One placed the Decedent in the backseat of his patrol vehicle. As the Decedent sat down in the backseat of the patrol vehicle, he kicked over a plastic baggie which was located on the rear floorboard on the driver's side. The Decedent stated to Deputy One, "that's not mine." Deputy One retrieved the baggie and placed it on the front passenger seat of the patrol vehicle. Deputy One later evaluated the plastic baggie; there was nothing inside the baggie and Deputy One determined it was trash.</p> <p>Deputy Two did not pursue further investigation into the Decedent's claim of drugs in the back seat of the patrol vehicle because Deputy One had already informed and physically showed him he had removed a plastic baggie from the back seat of the vehicle.</p> <p>The Decedent was transported to a local hospital for a medical clearance, in preparation of the booking process. The Decedent was cleared for booking. The Decedent indicated his head hurt, but head trauma was not noted in the medical documents. The Decedent was transported and booked by Deputy One at the Pico Rivera Station jail at 7:01 p.m. and placed alone in Cell #6 due to his classification.</p> |

|  | <p>Custody Assistant One was responsible for the Decedent's supervision in the station jail and to manually log inmate safety checks after the Decedent was booked and housed.</p> <p>On July 6, 2022, Custody Assistant One performed a safety check at 4:27 a.m. At 5:01 a.m., while distributing breakfast to inmates, Custody Assistant One discovered the Decedent was lying on his right side (facing the wall) on a lower bunk in the cell unresponsive, and appeared to not be breathing. Custody Assistant One entered the cell and tapped the Decedent on the shoulder to wake him; he observed blood on the Decedent's mattress and blanket which prompted him to activate the jail's panic alarm for assistance.</p> <p>Deputies One and Five responded to the station jail. The Decedent was placed on his back, and foam was observed coming from his mouth. Deputies started Cardiopulmonary Resuscitation (CPR) and Custody Assistant One retrieved the Automated External Defibrillator (AED) device; the AED instructed the cadence for the CPR. Deputies One and Five performed CPR until medical personnel arrived and took over. Medical personnel pronounced the Decedent deceased at 5:35 a.m.</p> <p>Nearby inmates at the station jail were interviewed, but no one reported seeing or hearing anything.</p> <p>LASD Homicide Bureau Detectives responded and investigated the death of the Decedent.</p> <p>The coroner's report later indicated the autopsy report did not list any evidence of acute trauma and concluded the manner of death was accidental and identified the cause of death as drug use.</p> |

1. Briefly describe the **root cause(s)** of the claim/lawsuit:

A **Department** root cause in this incident was Custody Assistant One's overdue safety checks, in violation of Department policy.

A **Department** root cause in this incident was the lack of jail cameras in the cell corridors, which may have allowed personnel to notice the Decedent in distress and administer prompt life-saving measures.

A **Department** root cause in this incident was the failure to deploy Narcan during the emergency response for the Decedent.

A **non-Department** root cause was the Decedent's ingestion of illegal narcotics, leading to an accidental overdose of fentanyl and methamphetamine.

An Administrative Investigation was conducted regarding the poor quality of the inmate safety checks. Appropriate administrative action was taken.

All station personnel have been re-briefed on Emergency Medical Procedures. NARCAN has been issued to each station jailer with a holster in addition to the NARCAN located near the "Livescan Machine" inside the jail.

Jail Cameras - Upgrade

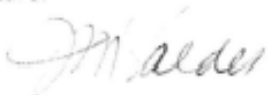

##### a. Sharon L. Anderson v. County of Los Angeles, et al. Los Angeles Superior Court Case No. 21STCV34038

This lawsuit concerns allegations of sexual assault and battery by a Department of Mental Health employee.

##### Action Taken:

The Claims Board recommended to the Board of Supervisors settlement of Item 4(a) in the amount of \$1,500,000.

**b. Matthew Reppa v. County of Los Angeles, et al.  
Los Angeles Superior Court Case No. 23AVCV00552**

This lawsuit arises from injuries Plaintiff allegedly sustained in a traffic collision involving a Department of Public Works' employee driving a snowplow.

Action Taken:

The Claims Board approved settlement of Item 4(b) in the amount of \$50,000.

**c. Non-Litigated Claims of Steven B. Lam and Hisae K. Utsunomiya**

These inverse condemnation claims seek compensation from the Department of Public Works for property damage allegedly caused by a sewage spill from a sewer mainline blockage.

The Claims Board recommended to the Board of Supervisors settlement of Item 4(c) in the amount of \$161,089.

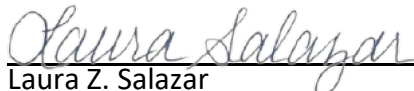
